## LIBERTARIAN COUNTY SUPERVISOR TOM TRYON FACES RECALL

It had to happen eventually, once Libertarians started winning elections. Petitions are being circulated in Calaveras County to have our Libertarian County Supervisor, Tom Tryon, recalled for making statements critical of the County's "War on Drugs."

At the May 26th meeting of the Calaveras County Board of Supervisors, Tom called Sheriff Claude Ballard's war on drugs "useless", "a failure", and "a violation of people's right of self-ownership". He also told the sheriff: "We should legalize all victimless crimes."

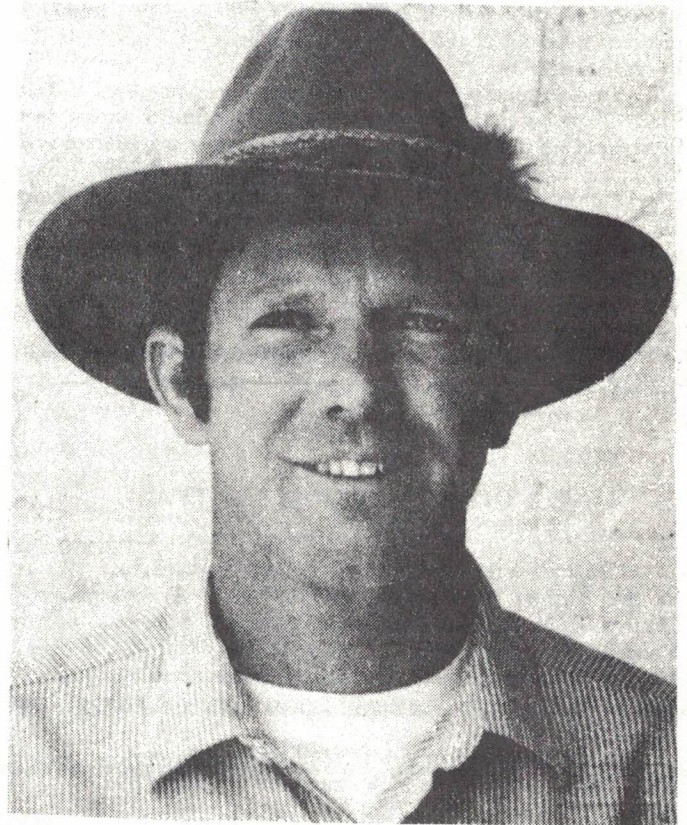
The sheriff, visibly shaken by this unprecedented criticism from an elected official of the County, was able to compose himself and continue his testimony in favor of having \$172,000 of taxpayer's money spent on undercover drug buys. By a vote of four to one, with Tom dissenting, the sheriff got his \$172,000 grant.

Following the meeting, five Calaveras County citizens filed a notice of intention to circulate recall petitions. They have until July 18th to collect 784 signatures to put the recall on the November ballot.

Tom has been getting lots of news coverage for his courageous stand (at least one front page news article per week) and has been generating discussions in schools and churches throught Calaveras County. He has sent out a letter to all Calaveras County voters (at his own expense) explaining his position and asking them not to sign the recall petition.

The leader of the recall, one Douglas Murray of Altaville, says he voted for Tryon and now he's kicking himself for not learning more about Libertarianism before casting his vote. This led the local paper to publish a political cartoon with the comment: "Here they want to close all the County's branch libraries, and we got voters running around that don't know what Libertarianism means." Well, they're learning now.

Tom Tryon won election to the Calaveras County Board of Supervisors last November by one vote.



## Tryon Files Answer To Recall Petition

**SAN ANDREAS** - District Four Supervisor Tom Tryon has filed his answer to a proposed recall petition.

Tryon's exchange with Sheriff Claud Ballard at the May 27 Board of Supervisors meeting regarding the "war on drugs" led to a recall effort launched last week by Doug Murray of Altaville. He presented Tryon with a Notice of Intention to Circulate Recall Petition during a supervisors' study session on June 4.

After Tryon filed his

answer with the County Clerk on June 7, the recall group then has ten days to file copies of their petition for verification. If it is approved, they then have 60 days to gather the required 784 valid signatures.

According to the Elections Code, 25 percent of the registered voters in the district must sign the petition in order to qualify the recall for the ballot. If qualified, the recall would go on the ballot in November. There are 3,135 registered voters in District

Four.

In addition to Murray, the Notice of Intention was signed by Raymond Powell of Altaville; Max Campbell, Doris Stover and Gary Lucht, all of Murphys.

Tryon's answer to the alleged grounds for recall is:

"The indisputable evidence is not contrary, but in support of my publicly stated beliefs. Namely, drugs should be legalized to the extent alcohol is legalized and controlled, thus removing

organized crime, pushers from campuses, high prices, corruption in government and exorbitant profits. I state these beliefs because I do have a comprehension of the terrible human cost of drug abuse, and I recognize that our current government policies have been pursued since the Harrison Narcotics Act of 1914, and the human tragedy only grows. Who today believes that the solution to the drug problem is to spend more money to build more jails to arrest more people?

We all agree the abuse of drugs is bad. The proper question is what policies should be implemented to minimize not only the use of drugs, but also the harmful effects when drugs are used. Today we are escalating the war on drugs to fight the natural consequences of the war itself. The term "war on drugs" is a misnomer; it is not a war on drugs, but rather a war on people. We shall not solve what is basically a health and personal mores dilemma through the police department."



## NEW NATIONAL LP CHAIR ORDERS SWEEPING CHANGES

Randy Ver Hagen, elected in April to fill the unexpired term of Paul Grant as national LP Chair, has ordered a number of changes to attempt to correct National's financial problems, (i. e. a debt in excess of \$70,000.)

Perry Willis has been hired to replace Honey Lanham as National Director, at a \$1,000 per month cut in Salary. The services of employees Paula Bosse and David Kelly are being terminated July 1st and August 1st, respectively. Outgoing phone calls from National Headquarters have been suspended. Following the LP National Convention, LP News will be suspended until the LP pays off its debt to editor Mike Holmes. Several options for reducing National Headquarters rent will be explored.

Fundraising efforts will be increased. However, even without additional fundraising, Ver Hagen expects the spending cuts he has ordered to be sufficient to eradicate the deficit by year-end.

In a letter to all National Committee members and all State Chairs, Ver Hagen states: "...blind optimism in the face of crisis does not constitute a positive and/or productive attitude....no decision I have made was arrived at lightly. I have sought considerable counsel. I have measured responses from all quarters and determined that no other course was more appropriate....My program would entail the taking of some very strong medicine. We are going to stop the bleeding. Then we are going to heal the patient. And then we will teach our healed body to run."

Ver Hagen plans to run for re-election as National Chair at the LP Convention in Phoenix, AZ, August 14-18.

## SELF GOVERNMENT ADVOCATES

Former LPC Executive Director Marshall Fritz is developing a new nationwide organization, "Self Government Advocates," to help Libertarians become better salesmen and recruiters.

Marshall recently completed a 24-day road trip getting Advocate "teams" started in New York, Pennsylvania, Connecticut, Vermont, North Carolina, Virginia, Michigan, Illinois and Utah.

During the two-year start-up phase (1985 - 86), teams are experimenting to develop a successful format which will form the basis for a "chapter handbook" to train future Libertarian leaders.

The Advocates use proven leadership training techniques developed by organizations such as Dale Carnegie and Toastmasters, combined with sales incentive techniques employed by such groups as Amway and Herbalife.
