Bergland On The Issues

-INTERVIEW-

LP Presidential Candidate, David Bergland gave the following exclusive interview to The Washington Libertarian on September 21. Due to space constraints, the interview will be carried in two installments.

TWL. What do you see in domestic terms as the proper role of government?

BERGLAND. Our view of the proper role of government is that it should be limited to assisting all of us in defending our rights against those who might violate them. That means that the only criminal laws that should be on the books are those which penalize such activities as murder, rape, robbery, kidnapping, theft, embezzelment, arson, trespass and fraud because those kinds of activities are situations where one person is violating the rights of another person. I also think that it is appropriate for courts to exist for final dispute resolution where amicable solutions can't be reached between the parties.

TWL. OK. I think that we are all in agreement that things such as social security, Aid to Dependent Children and so on are not proper functions of government. The question arises then, how do we get from here to there? How do we get ourselves out of the Social Security quaquire, how do we get out of ADC, and so on?

BERGLAND. The approach has to be one, first, for us Libertarians, of showing people that there is a better way of doing things rather than coercion, that voluntary, peaceful ways are in fact more effective. So, with regard to Social Security, it's necessary to demonstrate the great negative results that have occured from a massive government welfare program that was supposed to help people. We are going to absolutely destroy the economy of the United States as the Social Security taxes go up to pay for those benefits, as the number of people in the working sector of the economy grows less and less, and as more and more people grow older. These are the demographics of course. I think some of the estimates are that we are going to have to increase the Social Security tax to about 50% of income after we have passed the end of the century if we were to try to just maintain the system as it is. This of course pits the elderly against the young. I'm not so young, but I believe that there isn't going to be anything for the young at the end.

The way out of it, as far as I'm concerned, is number one, we have to get the Federal Government out of it, get it out of the charity and welfare business. And with Social Security, the approach I would like to see examined, which I think would work, is look at what the people who are now receiving benefits, or who are soon to receive benefits, would be entitled to by examining what they have put into it and what they should get out of it—just off the books as they presently stand—and then go into the private market and purchase for them private annuity contracts—which are certainly better than the government system—to give them the same level

of benifts.

The way to get the money to do that would be to take all of the government property, and we have to remember that the Federal Government owns about one third of the land mass, plus other non-real property that's very, very valuable. That property should be liquidated in a fashion that will maximize the return so that those annuities can be pruchased, and therby flip the system from a governmental bureaucratic system—that will go on for ever and ever if we don't stop it—into a private sector program. With regard to other, younger people, it [Social Security] is just over.

TWL. OK, In talking about sale of Federal property, are you talking about selling all Federal property?

BERGLAND. Only with respect to the Social Security system, I'm saying liquidate the property in a fashion that would maximize the proceeds of the sales. But, ultimately, the Federal Government shouldn't own property at all. The policy which I think is most appropriate for disposition of property the Federal government owns

is to do so on homesteading principles. Those people who are willing to go in and work that property should have the right to obtain it. Now, there are whole lots of people, not only in the Social Security system, but other people who have been ripped off by the government, and they should have claims against the government property for what has been done to them. But I was limiting my comments to simply a way to deal with the Social Security system.

TWL. I was thinking about criticisms that would arise from environmental groups and people who would say,

"Are you going to sell the Grand Canyon?" and that sort of thing.

BERGLAND. My response to that is that the Federal Government is really a lousy manager of property. Private organisations such as the Audobon Society, Nature Conservancy, and Ducks Unlimited have demonstrated that they do a much better job of taking care of and managing wilderness and those kinds of environmental assets than the Federal or State governments do. In fact, companies like Weyerhaeuser and Georgia Pacific do a better job of managing environmental assets because they have a long term interest in maintaining this property in good shape on into the forseeable future and even beyond that—much more so than the Federal Government does, because, as people who are involved in the environmentalist movement know, the big companies, developers and et cetera, really have more ability to influence bureacratic decision making than do the environmental groups, because of just simply, "who has the bucks."

TWL. Turning to another aspect of what we are talking about here, you mentioned a little earlier that you felt that a judiciary as a court of last resort sort of thing was a proper function of government. How should

a judiciary be financed?

BERCLAND. It should be financed by the people who are using it. It certainly shouldn't be financed by taxes. Again, our Libertarian position is that we should have only voluntary and peaceful relationships between all people including between people who make up government and the rest of us. So, the people who finance a "dispute resolution service," (and I purposely do not use the term "court," because there may turn out to be a variety of institutions which don't have that much resemblance to our modern day court) should be those litigants who ultimately wind up using the "dispute resolution service." Our fundamental Libertarian approach to the administration of justice (and here I'm not making any distinction between civil and criminal justice, but referring to the administration of justice across the board) is that those people who cause other people injury should pay. So, if a plaintiff has to go after a defendant in a breach of contract case or an automobile accident case, or any kind of case, the prevailing party should be put back into the condition he was in before the injury, or as close to it as can be done, at the expense of the wrong doer. The approach I would then recommend would be that the prevailing party would recover all of the costs of the litigation as well as his original damages. That would be how the system would work. As a matter of fact, that is the way it does work now in non-governmental arbitration, mediation, and conciliation. Litigants agree before hand that they will share the expense.
