HERNDON, VA—Herndon computer consultant Garry Myers, a 20-year resident of Northern Virginia, qualified for the November general election ballot in Virginia's 33rd Senatorial District.

Myers, 48, will run under the banner of the Libertarian Party after the required number of petition signatures were gathered for his placement on the ballot. Mr. Myers will emphasize tax relief, educational reform and preserving citizens' 2nd Amendment rights during the campaign, his first bid for public office.

Shelley Tamres, chairman of the Loudoun County Libertarian Party affiliate, said: "Libertarians are pleased that Garry has courageously stepped forward to run for this office. Voters in the 33rd Senatorial District deserve a real choice when going to the polls this November."

TIM BELTON DELEGATE, 65th DISTRICT

Harry Browne came to Richmond as a part of his fundraising tour; and John Girardeau and I (both LP candidates for the House of Delegates) were in attendance. As for my campaign it is coming along well, and I have a fundraising letter scheduled to go out in early July.



Belton discussed the issues with Harry Browne on Browne's recent swing through the mid-Atlantic states in search of the LP Presidential nomination.

I am stressing several issues but my top priorities are: the repeal of Virginia's State Income and Fuel Taxes; ending the prohibition against marijuana in Virginia; repealing the so called "Crimes Against the Public Morality," which include laws against gambling, sex out of wedlock, and any style of sex other than missionary between married couples, etc. I also plan to introduce a new Two for One Amendment that should curtail the number of bills submitted each year by assembly members. The Amendment would require a legislator to repeal two old laws before any new law can be passed. The response from the public has been mixed, but an overwhelming majority of the young people I've spoken with (mainly the 18-30 year olds) seem to be very supportive of our party's ideas.

Robert McBride has declared that he will seek the office of Chairman of the County Board of Supervisors. Robert intends to use the campaign to further popularize libertarian ideas and to build the party. He says that there is a widespread belief among county residents that their money is not being spent wisely, and he intends to offer the voters an alternative to an established government run by long-term incumbents. Robert believes that if the Libertarian Party is going to promote itself as a real alternative to the incumbent parties, then it has an obligation to offer voters candidates they can support. Once an active member of the Democratic Party, and former page in the U. S. Senate, Robert became a Libertarian after being forced to sell his Karman Ghia convertible to pay his federal taxes in 1986. Humaniterrorism is *no good*

In Washington DC on Saturday, June 26, we had a very spirited "Humaniterrorism is Not A Victory" parade, including libertarians. (Sponsors included Atlantic Anarchist Circle, D.C. Green Party, International Action Center, War Resisters League, DC War Tax Resisters, Washington Action Group, Washington Peace Center.)

We rallied at Dupont Circle where we heard several speakers including self-identified "quasi-libertarian" Sam Smith, editor of the Progressive Review, who has spoken for two DC area libertarian groups in the last two months. We marched past ABC News, which heard lots of heated chants against its biased news reporting of the bombing of Yugoslavia.

Protesters then marched to the Washington Post where I encouraged protesters to join me in destroying invoices for subscriptions to the newspaper. I flailed the Post for its editorial support for the brutal, immoral and illegal bombing. I illustrated this with front-page photographs like those of a smiling Albanian man next to a burning Serbian home. I also sang my new folk song: "Not A Victory." (I did all this as a self-identified libertarian and War Tax Resister since 1976; of course, I refuse to pay for all government violence.)

Hopefully, opposition to US intervention abroad is just getting going. We must oppose the new Clinton Doctrine-"bomb anyone, anytime, using any excuse you

can come up with." We must demand massive military cuts (75%+), bringing home all the troops, getting out of military alliances--esp. NATO, end to all aid to repressive regimes, immediate de-alerting of nuclear weapons (esp. before inevitable false nuclear attack alerts that will happen because of Y2K bug), and abolition of nuclear weapons. And we must not be afraid to press for non-violent conflict resolution of all conflicts just because a few members of any coalition support some side in a violent conflict!! "Humaniterrorism" is *no good*, whether practiced by oppressive governments, NATO, or violent revolutionaries or secessionists.

Also, we should *not* get bogged down in elaborate demands about what to do with the hundreds of billions of dollars saved. There are thousands of paid lobbyists for labor, human needs, taxpayers and other interest groups to do that job. Our job is to stop intervention, massively cut the military budget, and end war.

The Modern Mentality: Know Guns = Know Crime / No Guns = No Crime?

TAX DAY ACTIVITIES

The Libertarian Party of Prince William County passed out tax awareness literature at the Woodbridge and Manassas post offices on April 15th. Bill Lawry reports that his team worked in Woodbridge and handed out thousands of 'million dollar bills'. "We got lots of laughs, interacted with a few USPO employees and wrapped it up at 12:20 AM". The team consisted of Bill Lawry, Bill Yeniscavich, Robert McBride, and Jim Turney with a few others here and there for good measure. Eni Susi worked the same PO for part of the evening on the 14th with good results. Utilizing the Hodson strategy, they leafleted only the outbound patrons and made sure that

they didn't block the post office doorway. Bill Lawry's yellow 'Tax Day' T-shirt - the front showing a taxpayer being screwed into the ground by the giant IRS screwdriver and the back emblazoned with "Abolish the Infernal Revenue Service" got a lot of affirmation. Limited copies are available: T-shirts with a yellow background and light gray hooded sweatshirts. Our comments of "Here's your instant refund", "You've qualified, here's your refund", "...for all you've given...", and "Some funny money to ease the pain" - all got laughs. Robert McBride authored the new comments and brought his dog. The dog added to our credibility. At least 95% of the patrons and 100% of the USPO personnel we interacted with took the bills and enjoyed a moment with us. We had legal documentation too - Faxed in response to Bill's last minute request at 5:30 PM by late-working and well organized Libertarian Party staffer Dan Smith and highlighted by Bill - ready for the

inevitable LP-USPO confrontation; the confrontation which thankfully never came at Woodbridge.

Philip Hodson reports that things didn't go so smoothly at the Manassas post office. While passing out the "LP Million Dollar Bills" the postmaster told him, in an "insolent authoritarian demeanor", to take a hike. He said if Philip weren't gone when he got back to his office that he would call the police. When the police came, Philip left under protest. In his own words, "I was deprived of my right to free speech on public property".

NINTH CONGRESSIONAL DISTRICT and JEFFERSON AREA LIBERTARIANS

May 1999: On May 7, eight J.A.L. members served as ID checkers and wine vendors at "Fridays After Five" in downtown Charlottesville. This effort earned \$200 for the J.A.L. treasury. On May 22, the J.A.L. held its seventh "Adopt a Highway" cleanup of a section of Rt. 20 in Albemarle County. Nancy Howell, Jim Lark, and Gary Westmoreland participated. The J.A.L. has one more cleanup to complete to satisfy its obligation to the "Adopt a Highway" program.

The Advocates for Self-Government named three J.A.L. members (Greg Cunningham, Jim Lark, and Gary Westmoreland) "Lights of Liberty" for 1998. The award was given to Mr. Cunningham for his outreach through his many op-eds and letters to the editors of several newspapers. Dr. Lark and Mr. Westmoreland were honored for their many contributions, particularly with respect to information tables and "Operation Politically Homeless" efforts. (Four Virginians received the award: Mr. Cunningham, Dr. Lark, Mr. Westmoreland, and Jacob Hornberger, president of the Future of Freedom Foundation.)

June 1999: J.A.L. members continue to monitor developments concerning the attempt by some members of the Albemarle County Board of Supervisors to limit the property rights of landowners with respect to "big box" development. The term "big box" is used to describe large general merchandise stores such as Wal-Mart and Target. There is a concerted effort by many in Albemarle County to "fight sprawl" by limiting property rights in order to retard development of such stores in the county. The J.A.L. will oppose such efforts. At this time, it is not clear when the Board of Supervisors will formally consider the issue.

July 1999: The J.A.L. are planning to set up an information table at the annual Independence Day celebration in Scottsville on July 3. On July 30, J.A.L. members will once again raise money for the organization by serving as ID checkers and wine vendors at "Fridays After Five." Throughout the month,

J.A.L. members will contact and encourage LPVA members in central Virginia to become active in LPVA affairs, either through the J.A.L. or by starting their own groups.

The **Virginia Highlands** Libertarians, based in **Abingdon**, will hold meetings at the **Washington**

County Library on the second Wednesday of each month from 6:00 p.m. - 7:00 p.m., according to VHL contact Mike Porter. The first such meeting was held on June 9. Mr. Porter can be reached at (540) 628-2656 and mikescds@naxs.com.

University of Virginia:

This summer the efforts by The Liberty Coalition and its constituent groups are geared toward preparation for the 1999-2000 school year. Students for Individual Liberty (S.I.L.) will enter its thirteenth consecutive year of activity; according to Libertarian activist Don Ernsberger, S.I.L. is the longest-running Libertarian campus group in history. While S.I.L. realized several successes during the 1998-1999 year, the organization operated at a relatively low level due to the work commitments of principal activists Byron Smith and Eric Stetson and the unexpected departure of former S.I.L. president Bill Martin.
