### BALLOT STATUS

Actually, the above is a bit of wishful and hopeful anticipation. The fact is, 1,000 signatures are required for ballot status, and the LPK has collected 1,143. They have until the end of this month to collect any additional buffer that they think is necessary. But, I'm told that Kentucky has no centralized voter registration list, which makes it difficult to check the petitions against the voter registration lists. Other political parties have a period of time——I think a week——to challenge the signatures, but a fee of \$12,500 is required to do so.

Jo Chernow, Tim Lewis, and your editor spent the weekend in Villa Hills, Kentucky, the houseguests of Bobbi and Marty Jahn (KY. State Chair and National Execom member respectively). Saturday, March 6, was a day of fairly intensive signature gathering. At first I was a bit apprehensive——third party is kook party——right? Wrong! The response was quite satisfying to behold. For example, I ran into only 5 people who still think Mr. Nixon got a bum deal. About one out of 4 or 5 signed, which is remarkable when one considers that any given person is probably just as likely to be from Ohio or Indiana as from Kentucky. The end of the day saw about 600 signatures. And it was fun!

#### HOSPERS WRITES NEW BOOK

Dr. John Hospers, renowned Libertarian spokeman, is in the final stages of writing a new book tentatively titled An <u>Intelligent Layman's Guide to Libertarianism</u>.

The book, intended for publication in early 1976, is in four parts: Problem, Principles, Program and Strategy. Dr. Hospers says the work is being done at the invitation of libertarian publisher Robert Kephart, who will print the paperback edition under the auspices of Libertarian Review Press.

The L.P.'s 1972 candidate for President says the 200-300 page guide will deal extensively with the conflict over proper judicial systems, discussing various alternatives for police, court and prison functions. Also unique to the <u>Guide</u> is a consideration of Libertarian tactics: "How to get from here to there"; the problems and conflicts libertarians must confront in the transition to a free society.

# BALLOT STATUS

We know that the Pennsylvania Ballot Status decision has gone back and forth so many times that it has taken on certain characteristics of a yo-yo, but we hope you'll believe us when we tell you that the decision for/against a petition drive at any given time has usually merely reflected the interplay of plaintiffs, defendants, and the courts. Certain recent considerations may once again weigh the odds in favor a MacBride-Bergland petition drive in Pennsylvania. The courts have given the Labor Party and the Consumer Party until Aug. to collect the signatures necessary for ballot status. Since the decision was handed down in a class action suit, the decision should be applicable to other members of said class (e.g., the Libertarian Party), but the State Attorney General's Office is loath to see it that way. If this matter can be cleared up in reasonably short time, it may be feasible to consider another stab at ballot status. Pennsylvania is just too big a State to write off if there is any possibility that a petition drive might be sucessful. (See p.2, "From the Chair)

### LIBERTAS 76!

Libertas 76, tentatively to be held in the Pittsburgh suburb of Greentree, will get under way on the evening of Friday, May 7 and getting down to business the following morning. The agenda will look something like this:

- Nominations for New State Officers. The name of any person you may wish to place in nomination (for a specific state office) should be submitted to Dan Thompson. (See addresses elsewhere in this issue.)
- All suggestions for changes in the state constitution, by-laws, or convention rules will be considered by the constitution, by-laws, or rules committees respectively.
- 3) All suggestions relating to the platform committee (i.e., suggested changes in the State Platform,) will be considered by said committee, chaired by Olga Chauncey.
- 4) Send any other suggestions you may have concernany aspect of the Convention to Fred Hoffstadt.

If the business session can be consummated in the adroit manner of Libertas 75, it will, of course, leave more time for other activities (e.g., festivities).

Also on the agenda: Fran Youngstein & Don Ernsberger on campaigning & public relations; Ralph Raico, keynote speaker; two movies (i.e., S.I.L.'s "We Won't Be Fooled Again" & Campus Studies Institute's "The Incredible Bread Machine").

### FROM THE CHAIR

NEW JERSEY CONVENTION

The New Jersey Libertarian Party held its 1976 convention ("Love and Liberty") in Matawan, NJ on February 14, and all involved deserve a round of applause for a superb production. Speakers included Guy Riggs, Murray Rothbard, and Howard Katz. Special Added Attraction Reger MacBride spent the day in media activity, placing a red, white, and blue wreath on the grave of Philip Freneau, poet of the American Revolution and secretary to Thomas Jefferson, and receiving the endorsement of Mayor Victor Armellino of Matawan. (Where are all the Libertarian mayors in Pennsylvania?) In his dinner address to the group, Roger estimated that he has reached 20 million people so far in the campaign, with media coverage and public reaction being very favorable. The Convention ended with "Let's Make a Deal for Liberty," a fund-raising auction featuring Libertarian books, campaign buttons, and other memorabilia. The NJLP is running an almost full slate of candidates for Senatorial and Congressional seats this year.

#### AND BACK IN PA....

The petition drive for ballot status for the MacBride-Bergland ticket has been off and on so many times my head is still spinning, but it looks like we may still have a chance at it. This is where the situation stands at this time (subject to change at the whim of most any bureaucrat): A Federal Court has issued an order to the Eastern District of Pennsylvania, holding that the filing deadline for nomination papers (March 10) is too far in front of the election to be Constitutional, and allowing the US Labor Party (which brought the suit) to file petitions statewide until August 21. Since a class action suit was brought, and we are in the same class (legally, not philosophically), we also should have until August 21. But the Pa. Justice Department doesn't see it that way, and there will have to be some intervening legal maneuvers before the whole thing is settled. If it's settled in our favor, we will have until August 21 to collect our 30,000+ signatures, which gives us a tremendous advantage over the original filing date.

In other activity, a potential Congressional candidate has surfaced in the eastern part of the state, and although no definite decision has been made, we hope to have some Pennsylvania Political Activity even if we do not make the Presidential ballot. Since we have until August to file signatures in eastern Pa. (Berks, Bucks, Chester, Deleware, Lancaster, Leheigh, Montgomery, Northhampton, Philadelphia, and Schuylkill Counties) it's not too late for you to throw your hat into the ring.
