# Language, Freedom, and Responsibility

homas Szasz coined the term semanticide to designate the murder of language. He realized that the people who can define the limits of the conversation and the meaning of the words used would control the conversation and the people in it. I find this to be true as a psychotherapist and a student of political history. The purpose of this article is to show through example how words have been misused both for the purpose of gaining power and the abdication of responsibility i.e. loosing power. They have been used to destroy the reasoning power of individuals' minds and thus their ability to live in accord with reality, which requires the constant and correct use of the mind.

This misuse and abuse of language for the purpose of either abrogating one's responsibility or to fraudulently pursue people to a point of view that is not based on facts, is not new in human history.

One example is the U.S. government's undeclared but wellknown war on drug users, the free market, and sovereign foreign states called The War on Drugs. (An over 80 year facade that is neither a war or against drugs.) Congress never made a declaration of war and the police are not breaking in doors looking for Prozac, Ritalin, and aspirin. This misuse of words

has not just occurred on the political level. It can be found in one's everyday life.

The misuse of words can also be found in the propaganda of social organizations. A prime example is the Partnership for a Drug Free America. Personally, I do not have a problem with any organization trying to persuade teenagers not to be involved in any unexamined habitual behavior that can have Take back your liberty by taking back the language.

negative effects on their physical health or capacity to reason.

However, that is not the case with this organization. Alcohol and tobacco companies are primary contributors to PDFA. So, it is really not for a drug free America. They are against certain drugs but not against all drugs.

Another good example, whose consequences are the destruction of the volitional mind, is a situation I find quite often in my therapy practice. It goes something like this. Therapist: "Why did you do that?" Client: "I just went with the flow." What the client actually meant by the use of the word flow,

once I held her accountable, was that she gave up making any decisions for herself and simply did what her partner wanted. She abandoned volition, self-direction, and self-interest. By

using the word flow, she no longer had to think for herself and direct her own life. This allows her not to use her own mind to think clearly about life choices. These people convince themselves that the words they use are true representation of the world they live in and therefore the situation requires no more contemplation. They both deny reality and one's obligation to oneself.

Whether it's the State, ones partner or oneself using words incorrectly the end results are the same. It results in the loss of freedom. It lessens the power of the individual to use their mind to understand the world around them and make intelligent decisions about how to lead their life. The way to solve this problem and regain our freedom is to use words correctly and to continually call others to do the same ..

The same day, "The Perspective" section carried a Guest Editorial by Senator Richard Rainey that called for a return of the 'Educational Revenue Augmentation Funds' the State took from the counties seven years ago. Rainey said, "it's time to do the right thing and end the property tax shift so cities, counties and special districts can adequately finance our police, firefighters, libraries, public works, parks and public health services."

In a published 'Letter to the Times Editor' Walter Lautenberger brought this to light: "But what causes library expenditures, citizens or circulation? Obviously it is circulation. You could have lots of people in a county, but if they did not take out any items there would be virtually no library expense. The proper measure of effectiveness is minimizing total cost per item circulated. A May 1998 report from the Legislative Analyst's Office addressed this point and provided data. The report said 'While most county costs are in the range of \$2.75 to \$3.25 per document (circulated)...' Contra Costa was at \$3.20." With our sytem in the top 10% of the range, improving efficiency seems more appropriate.

As previously reported, new LP member, Tom Smith did take the podium at the Moraga City Council meeting last month. The council voted <u>unanimously to continue to oppose the tax increase.</u> One person can make a difference! While this battle is far from over, we are making waves


