### BRIEF CAMPAIGN REPORT

At the time this is being written the campaign is virtually at the end of its petition drive. Pressure of deadlines prevent a more up to the minute report and by the time you receive this report it will be moot, but the information is worth knowing about.

NY election law makes it difficult for an independent party to qualify for the ballot. Space does not permit us to recite all the roadblocks. The minimum required is 7500 signatures of registered voters who did not participate in a primary. Because of the difficulty in sustaining such a burden a standard rule of thumb is to gather more than double the num ber of signatures needed. We have collected at least 17,000 already and should have no less than 18,000 by filing date. If we are not challenged, then we should qualify for the ballot by Labor Day. If we are challenged, then we can be stuck in a drawn out court battle that could last to at least mid September and longer. It could also cost a couple of thousand dollars to handle the appeals. Since this is the last enclosure in the LP newsletter til the election, we can only tell you our guesses as to the future. We expect to be challenged. Political pros have told us to expect challen ges from conservative elements because we represent a challenge to their vote totals. We should also expect challenges from liberals because we represent a threat to their vote totals. We should also expect challenges from the Jewish candidates because Fran's Jewish

name represents a threat to the vote totals of Jewish candidates. This is what the pros have told us. This doesn't mean we will be challenged. But we are expected to be a threat to somebody and they don't know who.

The most heartbreaking thing that can happen is that
we won't have enough money to fight
our case through the courts.

# FRAN TOURS WESTERN STATES

Taking advantage of a business trip Fran was able to do some campaigning in Northern and Southern California and in Denver and Colorado Springs.
