We will be moving to AWS Simple Email Services for email services by the end of December. This will give us increased capacity and lower cost (0.10 per 1000 emails).

I spent time training Patty McMahon in Jefferson County on how to use the CRM to call volunteers.

We pay \$90 per month to the LNC for 3 hours of priority support per month for the CRM. We pay \$20 per month to Sparkpost for CRM email services to cover statewide emails. This cost is recorded as an In-Kind donation by the Database Manager. We have a \$200 credit with MailChimp for email services in lieu of maintaining our account for \$10 per month.
