## **NEW BUSINESS WITH PREVIOUS NOTICE**

As per Secretary Harlos' request, any potential motions would be taken up after the planned Executive Session.

### **ALABAMA BALLOT ACCESS**

Treasurer Redpath led a discussion on this issue with input from Libertarian Party of Alabama Chair Samuel Bohler.

### **NEW HAMPSHIRE BALLOT ACCESS**

Treasurer Redpath led a discussion on this issue and fielded questions and answer.

### **NEW MEXICO BALLOT ACCESS**

Secretary Harlos and Mr. Nanna expressed a desire to speak with Mr. Andy Jacobs on this issue in Executive Session.

### **KENTUCKY BALLOT ACCESS**

Treasurer Redpath led a discussion on this issue and noted that the Oliver/ter Maat Campaign would like to take over the drive from a logistical standpoint and would take on any overages past the \$27,500.00 previously encumbered by the LNC. Mr. Haman read aloud a message from the Libertarian Party of Kentucky Chair. Oliver/ter Maat Campaign Manager Mr. Dasbach also address issued.
