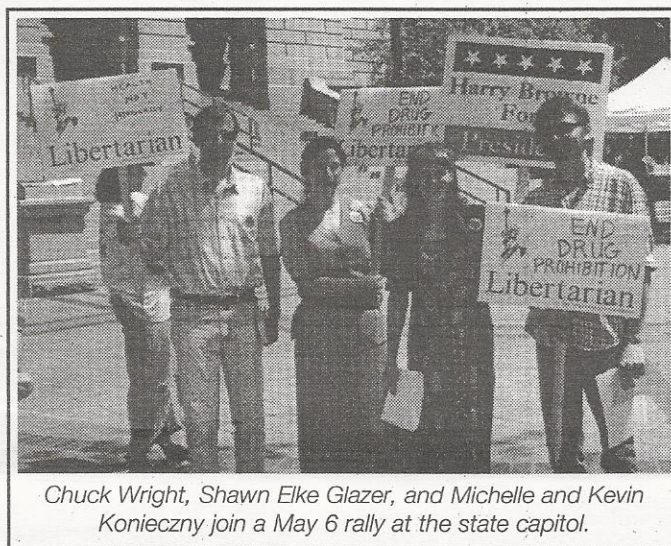

## Libertarians Rally to End Drug Prohibition

It must come to an end. That's what Libertarian Michelle Konieczny said of drug prohibition to a crowd of around 120 on Saturday, May 6 at the "Millennium Marijuana March." Other Libertarians held signs and handed out literature at the event, held on the steps of the State Capitol. Konieczny and Dr. Shawn Elke Glazer gave rousing speeches, encouraging participants to get active in the Libertarian Party's efforts to end the drug war and restore civil liberties damaged by that war.

Glazer and Chuck Wright, both running for the Colorado legislature as Libertarians, provided quotes for a May 7 article by Dan Luzadder in the *Rocky Mountain News*, Colorado's largest newspaper. Wright said the drug war often results in heavier prison sentences for non-violent drug offenders than for rapists and murderers. Dr. Glazer said, "I'm not allowed to even talk about the potential benefits of marijuana to my medical patients — like nausea control for cancer patients — because of the hysteria about the drug."

Konieczny drew cheers and applause when she reminded the crowd that Libertarian Presidential candidates have promised to pardon non-violent drug offenders if elected.

Almost 10 people registered Libertarian at the event, while scores more took LP flyers and voter registration forms. Party members also handed out hundreds of flyers at the Cinco de Mayo celebration taking place in the park near the Capitol. "End the drug war — vote Libertarian," they said. The reaction was overwhelmingly positive.

Jack Woehr of the Colorado Hemp Initiative invited LP members to speak at the event. Christie Donner of the Rocky Mountain Peace and Justice Center also spoke, as did Laura Kriho, considered a hero in Libertarian circles for her efforts to defend jury rights.

Representative Penfield Tate, a Democrat, suggested the legislature should "study" the drug war and sentencing policies. But Libertarians see the harms of drug prohibition as obvious and severe and call for its immediate repeal.

## Libertarians Join Armed Informed Moms

On Mother's Day, May 14, Libertarians joined hundreds of civil arms advocates gathered at City Park in Denver for the Armed Informed Mothers March.

Shawn Glazer, candidate for House District 24, got major press coverage with her doll carrying a miniature firearm and Constitution. Joe Johnson and Elizabeth Bennett carried a huge Libertarian banner.

The event was sponsored by Second Amendment Sisters and Rocky Mountain Gun Owners. At the same time, the so-called "Million Mom March" held a rally at Civic Park Near the Capitol. There, Libertarians and other groups counter-demonstrated.

What if you can't run, don't live near enough to help out with a campaign, and haven't the money to send for support, but you still want to help? What can you do? I have been working on the Sakson for US Congress campaign and here are a few things we need and I suspect other campaigns need as well.

**Slogans** – The Maggert campaign used the slogan 'Live and Let Live' which played very well. The Sakson

campaign will use the slogan 'Enough is Enough.' We need catchy slogans that are only a few words long. The best are ones that express our position like the Maggert slogan or one that can be used as a tag line like the Sakson slogan. ("We have over two million people in jail with almost 40% of them serving time for nonviolent drug offenses. Enough is enough.") Send your ideas to me, Norm Olsen, and Tom Goonan.

**Media contacts** – Do you know someone on the radio or a newspaper columnist who seems to lean our way? Send his name and his office address to us. We also need to constantly update our media list. Take a few minutes and send us the names, addresses, and phone numbers of the papers, radio stations, and TV stations in your city, county, or general area.

**Speaking engagements** – Many groups look for speakers. We have people willing and ready to speak. Send us the names and contact information on organizations like Rotary clubs, Optimist clubs, and other organizations in your area. Please don't forget young people's organizations.

**Special talents** – A campaign has many needs, from fundraising to graphic design to meetings to writing position papers. Do you or someone you know own a restaurant, screen printing business, copy shop, or other business that might be useful during a campaign? Send us the information. Can you or someone you know write position papers or do graphic design? Send us the information. Many of our candidates don't know where to look for these things. Let's make it easy for them by letting them know where to find us.

**Statistics and other useful information** – You know what the issues are. Have you seen something in the paper that supports our position? Did you hear something on the news? Perhaps you even have time to search the web. Please send us any information on ANY issue that might help our candidates support the Libertarian position. The information should be short, to the point and should include the reference information.

These are a few of the things you can do to help our candidates get our message out. Remember, even if we don't win ALL our races, pulling the debate in our direction will mean more freedom for more people.

If all of us pull together, we can ring the bell of freedom across Colorado.

# Oppose Drug Prohibition AND Disarmament

As Martin Luther King, Jr. once put it, "Injustice anywhere is a threat to justice everywhere." One cannot attack some civil rights and hope to retain others. Our civil liberties are interdependent. When one article of the Bill of Rights is threatened, all are threatened.

Unfortunately, power elitists have effectively divided the American civil rights movement into two warring factions. Those on the traditional "left," such as the American Civil Liberties Union, denigrate the civil right to keep and bear small arms, while those on the "right," such as the National Rifle Association, demand that ever more non-violent drug offenders be warehoused in America's prison system.

The only winners in this conflict are those who control the machinery of the expansive state. The losers are the Bill of Rights and the people it was intended to protect. If the civil rights movement in America remains fractured, with various factions constantly ripping each other to shreds, it ultimately will be conquered and replaced by those who clamor for authoritarianism.

Blinded by dogma and bigotry, representatives of both sides of the civil rights divide demonize each other and compete in advocating stiffer laws infringing the favored rights of the other side. Too many civil arms advocates blame social ills on drug users and stigmatize those who call for an end to drug prohibition. Meanwhile, many who favor a repeal of drug prohibition demonize gun owners and propagate flagrant lies about civil arms.

Yet both sides are ultimately fighting for the same cause: to restore civil liberties and return to a more peaceful, less corrupt society.

Those who oppose prohibition realize that anti-drug laws don't achieve the desired results. The drug war has not made American streets safe from drugs; instead it has made drugs more dangerous and it has perpetuated gang warfare. The unintended consequences of drug prohibition have taken a heavy toll on American society. Yet many who oppose drug prohibition adopt the utopian dream that gun prohibition will somehow work to the betterment of society.

Those who oppose disarmament laws realize such laws don't stop criminals, but instead empower police agencies to harass innocent citizens and diminish the civil right of self-defense. Yet many who oppose disarmament laws blindly call for harsher drug laws, even though both types of laws result in unintended bad consequences.

The Constitution is in tatters because of the war on drugs and the associated war on guns. Nowhere does the federal Constitution empower Congress to restrict either drugs or civil arms. Because of drug prohibition and the resulting war on guns, eight of the ten articles of the Bill of Rights have been flagrantly violated.

The First Amendment guarantee of the free exercise of religion has been overturned, insofar as a religion wishes to use a non-legal drug in its sacraments. The Second Amendment right of the people to keep and bear arms has been all but ignored. The Fourth Amendment right to secure property is smashed as militarized police forces bust down doors in the middle of the night to find "illegal drugs" and "illegal guns."

The Fifth Amendment guarantee of due process has been overrun as drug and gun warriors seize property without so much as filing charges. The Sixth Amendment right of a jury trial is similarly voided. The Eighth Amendment right to be free of cruel punishment is abrogated when non-violent drug and gun offenders are locked away to be gang-raped in prison for sentences exceeding those meted out to many murderers.

The Ninth Amendment no longer protects other rights "retained by the people;" the Tenth Amendment no longer delimits the scope of the federal government. The command-and-control policies of Washington, D.C. reign supreme.

Drug prohibition has always been the prime cause of the war on guns. Following alcohol prohibition in the early 1900s, Congress passed the National Firearms Act, the first piece of federal legislation limiting civil arms, explicitly because of the gang violence caused by prohibition. (The need to reassign prohibition agents to other tasks also may have played a role in the passage of that 1934 Act.) More recently, Bill Bennett and George Bush banned the importation of certain rifles explicitly because of the violent black market caused by drug prohibition. Today, a leading cause of homicide and street violence is drug prohibition, problems which will not be solved by passing even more prohibition laws on guns.

Both the drug war and the gun war have always hurt minorities and the poor the most. The NAACP used to urge its members to bear arms in order to defend against the violent racists of the KKK. The Jim Crow laws against blacks included disarmament laws that

# Why Rapists Love Anti-Gun Million Mom March

WASHINGTON, DC — Women who participated in the Million Mom March are making a terrible mistake by attacking guns instead of focusing on the women who have been raped or killed because of gun control laws, the Libertarian Party said.

"Sunday should be a day to mourn the victims of gun control — including the estimated 4,177 women who will be raped this year because it is illegal to carry a concealed weapon in their state," said Libertarian Party National Director Steve Dasbach prior to the event.

"Instead, these marchers will demand more laws that will put more women at risk. Libertarians have to ask: What will it take to make the Million Mom marchers understand that criminals love women who hate guns?"

On Mother's Day, an estimated 150,000 people participated in the Million Mom March on the Mall in Washington, DC. They demanded what they call "common sense" gun laws — including mandatory trigger locks, gun licensing, limits on gun and ammunition purchases, an end to TV programs and movies that "glamorize" guns, more regulation of gun shows, and much more.

Unfortunately, such laws would just put more women at risk of being raped or killed, said Dasbach.

"It's impossible to count all the women who have already been victimized by anti-gun measures like waiting periods, handgun bans, and restrictions on the right to carry a weapon for self-defense," he said.

"However, we do know that at least 4,177 women are raped every year because of laws that make it illegal to carry a concealed weapon."

Violent crime dropped dramatically in 24 states that passed concealed-carry laws, allowing ordinary people to carry concealed handguns.

left black people defenseless against violent racists. Indeed, one motive for passing the 14th Amendment was to overturn disarmament laws aimed at blacks. Other disarmament laws intentionally hurt other immigrant groups.

Today, minorities in the highest crime areas, where police protection is often weakest, most urgently need their civil rights of self-defense. Yet disarmament laws and the additional costs and legal hurdles they bring hurt poor communities especially.

Because of drug prohibition, America incarcerates a greater percentage of the population than any other nation on earth. Violent felons walk free in order to

The Lott-Mustard study, "Crime, Deterrence, and Right-to-Carry Concealed Handguns," found that in those states, rapes fell by 5.2%, murders were reduced by 7.65%, robberies fell by 2.2%, and aggravated assaults dropped by 7%.

Had other states passed similar concealed-carry laws, that 5.2% drop in rapes would have translated into an additional 4,000+ women annually who would not have been sexually assaulted. Instead, tragically, they were raped because politicians illegally infringed their right to defend themselves.

"The Million Mom March participants think they are sponsoring an anti-gun event. Instead, they are sponsoring a pro-rape event," said Dasbach. "If you listen carefully on Sunday, you just might hear the sound of rapists, stalkers, and wife-beaters cheering as they anticipate how much easier it will be to commit crimes against defenseless women."

If the marchers aren't willing to consider the past and future victims of gun-control laws, Libertarians will, said Dasbach.

"Libertarians will commemorate the women whose right not to be a crime victim was taken away from them," he said.

"Libertarians will remember the girls who never become mothers because their lives were cut short by criminal psychopaths. We will remember the mothers who lost children to gun-toting thugs because it was illegal for them to defend their families. And we will remember the women whose lives have been ravaged by rape, assault, or similar crimes.

"In short, we mourn the thousands of women who cannot march on Sunday — because they are the silent victims of the lethal laws and gun-control policies that the Million Mom March so loudly advocates."

make room for more non-violent drug offenders. Police are more likely to bust a black drug offender than a white drug offender, and the courts are more likely to put the black person in prison for longer sentences. Drug prohibition exacerbates the already difficult problems of poor and minority neighborhoods.

If civil libertarians of the left and civil libertarians of the right will stop demonizing one another and join forces for the betterment of all people, the resulting political movement will be unstoppable. We will restore America to its rightful place as the defender of minorities — all minorities — and of individual civil rights. If the sides continue in their myopic and mutually destructive struggles, both may lose to the police state. It's time to stand together.

## Microsoft Ruling: More Costly than Bank Robbery

The Justice Department's plan to break up Microsoft is not just a bad legal decision — it's a case of "bureaucratic grand larceny" that has already stolen more wealth from Americans than all the bank robbers in history, the Libertarian Party charged today.

"Move over Jesse James, John Dillinger, and Willie Sutton. There's a new criminal in town that makes you look like amateurs — and it's the antitrust gang at the Justice Department," said Steve Dasbach, the party's national director. "With its decision to eviscerate one of America's most successful high-tech corporations, the Justice Department has committed the most costly and malevolent act of economic vandalism in American history."

Specifically, the Justice Department's announcement last month that Microsoft broke antitrust law — and its decision last week to try to divide the Redmond, Washington-based corporation into two separate companies — caused a massive meltdown in technology stocks. According to financial experts, the plunge in the stock market cost American investors \$150 billion to \$208 billion in lost wealth.

By comparison, bank robbers steal "only" a few tens of millions of dollars a year, noted Dasbach. For example, the Justice Department reported that bank robbers stole \$28 million in cash in 1994.

"With its Microsoft decision, the Justice Department looted the savings and retirement funds of 80 million Americans who directly own Microsoft stock or invest in one of the 2,000 mutual funds that include Microsoft stock — proving that the Justice Department is more costly than any criminal gang," said Dasbach. "After all, it takes crooks a whole year to steal \$28 million from banks, but it took the government only one lawsuit to steal \$200 billion from Americans."

But was that harsh economic medicine necessary to "save" consumers from a predatory corporation?

The alleged victims don't think so, noted Dasbach: A new public opinion survey by the Harris Interactive

polling company found that 59% of Americans support Microsoft in the antitrust battle, and only 29% say the government is treating Microsoft fairly.

"What we have here is a classic victimless crime," he said. "The Justice Department is supposedly trying to rescue consumers from the clutches of an evil corporation — but consumers support the evil corporation. What does that tell you about the merits of the case?"

And there's another important group that disagrees with the rationale behind the antitrust lawsuit: American investors.

"The Justice Department claims that breaking up Microsoft will enhance competition and innovation," said Dasbach. "If investors agreed, the stock market would have risen after the Justice Department's antitrust announcement."

"At the very least, companies that compete with Microsoft and presumably would gain the most from its breakup — Sun Microsystems and others — would have benefited from the decision. Instead, their stocks took a drubbing, and their value plummeted."

"Clearly, investors are trying to send the government a message: Attacking successful corporations is not good for the economy."

Anyone who reviews the government's assault on Microsoft — and considers the economic damage, the negative reaction of the stock market, and the rejection by consumers — can reach only one conclusion, said Dasbach: The real criminal in this case is the Justice Department.

"When bank robbers steal your money, at least they have the honesty to admit they're just thieves," he said. "When the Justice Department destroys \$200 billion in wealth, it has the gall to claim that it is acting for our own good. That's the real crime — and the reason why the tax-funded political power of the Justice Department is far more dangerous than Microsoft will ever be."

## Information Overload!

First of all, I would like to thank everyone for electing me to this position and I would like to thank Ron Bain, my erstwhile opponent, for jumping right in and helping me get started. And thanks, too, to my predecessor, Craig Stinson, for all he did for me.

The way I see it, the Public Information job is to keep our party's name and positions in front of the press as often as possible. To that end, I plan to put out press releases on a weekly basis. No, not too many of our releases are going to get printed, certainly not by the big papers. Look at it as reporter education: we want to give the press new ways of looking at things, so that they might ask our questions when interviewing important people. In time, I hope to meet with some of the reporters personally, so I can explain our positions and, maybe, guilt them into attending some of our campaign functions in the autumn.

Now that I am in this position (I demand a recount!), let me tell you how you can help:

1) If you are the one doing this same job at the local level (media, press secretary, overworked chairman who also talks to press, whatever), I would like to hear from you. I want to know who you are, where you are, see copies of your releases, and, most importantly, I want to know who your press contacts are. Nothing goes out of date quite as fast as a media list. Tell me who does the political reporting at your local television station and your local paper. Tell me about the local radio talk show host, what his views are, and

when he is on. Tell me about the morning DJ who likes to read inflammatory articles on the air. Tell me about the tiny neighborhood paper and give me all the contact information you can find.

2) If you are in an area that doesn't have a local affiliate, could I get you to take on the above tasks yourself? These are the places where we need to be heard the most.

3) Are you somebody's campaign manager or media liaison? Let me know. We need to coordinate our efforts where possible.

4) Keep those Letters to the Editors flowing. This is a presidential election year and we need to keep the "L" word in front of people's eyes as often as possible.

5) Part of my job is maintaining a speaker's bureau, basically a list of people willing to go talk to the Rotary Club or anyone else who wants to hear about us. We are well covered in the Denver Metro area and in Colorado Springs, but other parts of the state may also need speakers. Can you speak reasonably well? Can you answer questions without disemboweling the questioner? If so, let me know and I will put you on the list. I can even help you put together a speech.

This is going to be a very busy year and I will need a lot of help. The good part is that most of the help I need can be done now, rather than during the busy campaign season. Please call me at 719.532.0118 or e-mail me at JKBColoSp@aol.com.

Debra Collins, the Colorado coordinator of the Armed Informed Mothers, spoke at the rally in Washington. "If it saves just one life, it's worth it," she said, "and my gun saved my life." Collins used her gun to defend against an attacker at her home.

Sometime-libertarian Camille Paglia made the observation, "It doesn't take a weatherman to figure out that the average citizen doesn't want national policy determined by packs of weeping women led by a shrill, dimwitted talk-show host (Hillary sycophant Rosie O'Donnell)."
