### Chairman's Report for March, 2024

I am pleased to present the board report for the month of March 2024. This report summarizes the key activities and accomplishments of our organization during this period.

#### **Board Meetings:**

- •Held 1 board meetings, with a total duration of 30mins.
- •Key topics discussed:
  - •Review Policy Manual for adoption next meeting
  - Addressing the late reporting of the Audit Committee
  - Allocation of funds for Convention

#### Committee Meetings:

- •Executive Committee meeting: Held 4 meetings, with a total duration of 2 hours.
- •Political Committee meeting: Held 2 meetings, with a total duration of 2 hours.
- •Marketing Committee meeting: Held 2 meetings, with a total of 2 hours.

#### Events:

- •El Paso Convention February 10<sup>th</sup> 2024: El Paso County was moving towards a violation of their bylaws. I issued two warnings about how to keep a violation from happening, advice was not followed. I had no choice but to attend in person to call to order at the appropriate location. Attended the convention. Conclusion was to adjourn until March 16<sup>th.</sup> I spent a duration of 7 hours at the convention location working.
- •California Convention: Attended an event on February 24th with a duration of 8 hours. campaign to national delegates. Attended the full day of business and gala.
- •Nebraska Convention: Attended on March 2,2024. Attended full day of convention to campaign to national delegates.
- •CD4 GOP Candidate Panel Phillips County: Attended March 3, 2024 with a duration of 5 hours. Represented the LPCO in my official capacity with the LP Candidate for CD3. Networked through

the event. It was fun to bring our candidate who pushed Lauren Boebert out of CD3 and see her in person for this panel.

#### Collaborations:

- •Collaborated with FreeStateColorado on the Legislative Update livestreams co-hosting one livestream, with a total of 4 hours spent on meetings and discussions.
- •Met with HD26 GOP Candidate Nathan Butler, recommended through RMGO. Mr.Butler signed the LPCO Liberty Candidate Pledge.
- •Met with LPCO CD3 candidate and GOP CD3 candidate to have GOP candidate sign the pledge.
- •Met with RMGO about GOP House Reps who voted against the Civil Asset Forfeiture Bill they killed in committee. Collaborated on Lp candidate strategy in these districts.
- •Collaborated with CD4 Democratic candidate on messaging and invited her to speak to the delegates at our upcoming convention

#### Achievements:

- •We achieved a state level and federal level pledge commitment to bring to delegates at convention
- •Put the LPCO in the forefront of Colorado Politics through our single issue coalition groups and having a presence at GOP events.
- •Finished the contract for overhauling board documents and strategy and have been implementing new procedure. We are moving forward with Committee Operations Manuals.

### **Treasurer Report for March, 2024**

As per our Bylaws Article VI, Section 3d, the duties of the Treasurer are as follows:

The Treasurer shall be responsible for maintaining accurate records of all income and expenses associated with the operation of the Party. A contributions and expense summary shall be included in the Treasurer monthly Board Report and may be limited to activity since the last regular meeting of the Board. Every contribution and expenditure must be reported to TRACER in a timely manner per the noted reporting due date. Every contribution and expenditure received through any means must balance against the financial institution statements and TRACER. The Treasurer's board report shall include a calendar of Secretary of State TRACER report due dates for the previous and next 3 months together with documentation showing that the report was filed. The Treasurer may also prepare budgets for the other Directors or assist them in preparing their own budgets. The Treasurer shall maintain an efficient double-entry system of accounts and cooperate with the Audit Committee in ensuring financial integrity..

As of March 7, 2024, the state account balance was \$30,669.36 As of March 7, 2024, FEC account balance was \$1,743.23

I am still working on automating filings with SoS and FEC but have a plan in place to accomplish this. We will continue to monitor accounts to determine trend information regarding income, expenses, and mapping out trend data. Audit committee has begun the process of combing through records to verify transactions and help with lessons learned. FEC filing is completed. While doing the FEC filing I have narrowed options down for software to help with compliance. We have been finalizing the Shopify settings to update with the new account info. I continue my attempts to further reduce our outstating SoS TRACER fines and continue to improve our bookkeeping system through digital means this month. This will allow more transparency for my position and ensure the fiduciary duties are upheld appropriately. I have signed up for more SoS training to ensure compliance and build rapport.




