I'd like to thank our Affiliates Director, Kyle Furey, for contacting all the affiliates and getting all the information on their local events. I do have some questions about the Northern Colorado meetup. Which Counties are included besides Larimer and Weld? When and where do they meet? Who is the contact?

National LP recently sent an email asking people to sign the Already Against the Next Mandate petition. More than 60 Colorado people signed, 1700 nationwide. These names are available to local groups on the CRM and might come to a local meeting if asked.

At the last National HQ Staff meeting, it was reported that because of Biden's national mandate, over \$8000 was raised with minimal promotion. I believe an email campaign on this will go out next week.

Communications - a reminder that you can categorize posts as News, Press Releases, etc. You can also change the Author to LP Colorado with the Quick Edit function.

Has the Unified Membership Plan been submitted to National?

I removed about 50 people from our volunteer list because they are no longer party members and changed their voter registration to something else.

We pay \$90 per month to the LNC for 3 hours of priority support per month for the CRM.

We pay \$20 per month to Sparkpost for CRM email services to cover statewide emails. This cost is recorded as an In-Kind donation by the Database Manager.

We have a \$200 credit with MailChimp for email services in lieu of maintaining our account for \$10 per month.
