## What is wrong with the USA - Part 1

Libertarians know that something has gone terribly wrong with the USA. The USA has become a country of endless wars, torture chambers, bulging prisons, exponential deficits, meaningless elections, assassinations, and bodies hanging from bridges just beyond its steel-walled border. Fortunately, the problem is not the American people; the problem is the political system. Unfortunately, that problem is getting worse; the system is deliberately making itself more oppressive. The failings start with the Constitution, and include the election methods, the business environment, and foreign influences.

A libertarian philosophy would fix the USA. The Libertarian Party could still fix it, peacefully, in fact. Although a Libertarian victory seems unlikely now, in the near future technology might change the odds in favor of freedom. I will write more about this in future columns.

All politics being local, the problem starts in San Mateo County. Your June ballot contains only one or two Libertarians and no candidate from the LPSM. You can tell the Chair to try harder, certainly. However, under Proposition 14, the "Top Two Primary," nobody wanted to run. They realized that working and paying to put Libertarians on the ballot in June, did not guarantee any Libertarian on the ballot in November. While other countries encourage democracy, the USA discourages participation. US politicians change the rules to discourage participation, as a political strategy. At the same time that many US states made their elections more difficult, the government of Mexico put billboards around the Bay Area to remind their citizens to vote in the Mexican elections by absentee ballot.

Gail Lightfoot, Libertarian for US Senate, is buried in a list of 24 candidates. How can you moderate a 24 candidate debate? Yet, there was one candidate forum in San Mateo, recently. The incumbent, a San Franciscan, did not even show up. And the media devoted their attention to one candidate, a sensationalist rabbi who openly calls his platform "Islamophobia".

## measure w: redwood city parcel tax

Measure W proposes a new five year, \$67. annual parcel tax on Redwood City homeowners. Jack Hickey, LPSM Executive Committee Alternate and Sequoia Healthcare District Director, Chris Schmidt, LPSM Database Chair, and Don Pettengil, LPSM Treasurer, worked tirelessly throughout February and March to build the arguments against Measure W.
"According to the state's Ed-Data web site, for 2009-2010, total revenue was $\$ 89,268,648$ and they spent $\$ 93,069,252$; or \$10,356 and 10,797 per child (ADA of 8,620)," said Schmidt. Ed Data Express, a government web site covering all 50 states, currently still does not show 2011 or 2012 statistics. The site contains data collected by the U.S. Department of Education, to which school districts are required to submit financial reports. Total federal funding for elementary and secondary education programs in California in 2010 was \$5,375,461,466.

The parcel count for Redwood City Elementary School District is 25,351 . This information is a matter of public record and can be obtained by logging in as "guest" at the Assessment Roll Tracker web site provided by the San Mateo County Clerk. $\$ 67$, paid 25,351 times, is an extra $\$ 1,698,517$. $\$ 1,698,517$ is roughly $1.5 \%$ of past administrative spending, and covers less than half of the school district's 2009-2010 budget overruns.

Voters who approved 2005's $\$ 468$ million Measure A for the San Mateo County College District saw the construction of the fee based San Mateo Athletic Club out of their tax dollars, and a request from the school district for an additional $\$ 564$ million six years later.

Measure W specifies independent citizen oversight over the funds. The school board decides who will be on the committee and what the duties of the committee will be. Measure W states that funds are to be used "to improve local elementary and middle school education for all students", but does not state how this is to be achieved or what constitutes improvement.

## legalize murder?

Libertarians want many laws eliminated, from bans on individual consumption of drugs to those against prostitution, gambling and other "victimless crimes." We believe personal moral decisions should be made by adults for themselves. Politicians want more laws.

Drugs are a flash point because of the damage inflicted by the "War On Drugs." Criminalizing an activity criminalizes its participants, as historians learned from studying alcohol Prohibition. When a substance (or activity) is popular, declaring it illegal will not curtail or reduce its usage. The Drug War becomes more expensive and intrusive, while remaining as unsuccessful as ever.

When faux conservatives are confronted with hard facts on drug usage, they refuse to admit their "war" has failed after decades, preferring to blurt out non-sequiturs like, "Murder is illegal and there are still murders. Should we legalize murder?" It could be a conversation stopper, but there is an answer. "No."

Murder is not a victimless crime. No sane person believes its illegality will eliminate homicides, but society is obliged to punish murderers, who have ended the life or lives of others.

Murder is not analogous to substance usage. For instance, it is not a crime to have used "illegal" drugs. Presidents, Supreme Court justices and many other high officials have used drugs, if we can believe them. Many probably continue using them. Had they been caught experimenting with drugs when younger, their lives might have taken a different course. Now, they enact laws to punish others for doing what they did. What is that called? Oh, hypocrisy. Most so-called liberals are as vested in the Drug War as conservatives, since they love big, intrusive government.
One argument (frequently advanced by commentator Bill O'Reilly) is denying that drugs are a victimless crime. It may be true, as Bill asserts, that drug abusers make poor parents and spouses. We can see this effect with prescription drugs and alcohol as well.

Drugs can lead to the user's death. On this basis, nearly everything should be illegal.
If someone eats delicious cheesecake all day long, she may become anti-social or ill. Of course, while it is a pricey pastry, it

- Per student spending does not correlate with student achievement.
- The United States spends $\$ 809.6$ billion per year on education and an average of $\$ 7,743$ per school aged child. The next highest spending country, Germany, spends $\$ 129.8$ billion per year and an average of $\$ 4,682$ per school aged child.
- Finland spends an average of $\$ 5,653$ per year, per child. Finland's students rank first in literacy, math and science, far ahead of the U.S.
- Beginning January 2007, California teachers were no longer required to submit verification of continuing professional development to renew their credentials.
- The average California teacher's salary of $\$ 68,093$ is second highest in the nation, next to New York, according to the National Education Association.

is much cheaper than it would be if it were illegal, and she need not fear that government agents will break down her door to seize her cheesecake, unless they are serving a drug warrant to the wrong home.

On the matter of drug addiction, there is help for addicts, if they decide to quit. But the consequences of drugs being illegal are far worse than their usage, affecting everyone. If you buy a box of Sudafed®, you are treated like a criminal suspect, although the FDA classifies it as an over-the-counter medication. The draconian measures are blamed on the fact that Sudafed ${ }^{\circledR}$ can be an ingredient for mixing another government-banned drug.

So? Invasive precautions will not halt methamphetamine production. They do intimidate law-abiding citizens, who may be so shaken that they turn to non-prescription drugs. Even worse, they may get so enraged at the government that they become libertarians.

Leaving other victimless crimes for another time, the same principles apply. Laws that will not stop an activity, merely make its participants felons and violate America's spirit of freedom.

Libertarians do not advocate legalizing murder, theft or fraud, even when initiated by the government. We want to restore the freedoms delineated in the Constitution and Declaration of Independence. This great country was founded on the principle of limited government, with citizens freely in control of their bodies and minds.
