A TALE FROM THE DARK SIDE

The "Lynching Party" in Clearlake

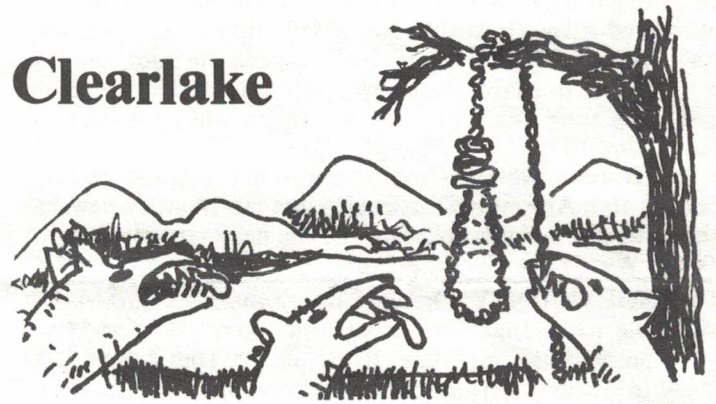
"REAL-WORLD" POLITICS is not to everyone's taste—it's certainly not for the faint-hearted. However, most people who enter the game have some idea what to expect even if they're simply trying to stop the deluge—as libertarians are trying to do. But at times the tactics of politicians and bureaucrats are so contemptible, so crude, as to shock even such savvy participants as libertarians. And the game can be played as rough and dirty in small towns as in the big city. Just ask Bill Struthers, who found out first-hand the hard way.

CLEARLAKE: The city of Clearlake, a major town in Lake County, is a beautiful, rural community. The waters of the lake are clean, the air is pure. Apparently one can't say as much for the local political scene which seems to be a moral toxic waste dump.

Last December, *CLNews* reported that a libertarian had been reelected to the city council. Bill Struthers, a close friend of Randy Grindle, was returned to office by the largest vote count in that community's history. He must be doing something right. He is. He's an outspoken critic of proposed plans introduce "redevelopment" to Clearlake, which makes him the friend of the taxpayers and long-time residents. "There's no need for redevelopment—the town isn't blighted," says Struthers.

But redevelopment isn't about "blight"—that's all PR by city administrators. Redevelopment is about money and power. Once the city has set up an agency, that agency can sell bonds for projects without approval by the voters, and the property of one person can be taken through eminent domain and given for a "higher and better use" to another. It's great for city governments that want to increase their powers (and there aren't many that don't) and developers who want to get their hands on a lot of real estate without having to deal with existing owners in the market place.

For the past couple of years Randy and Struthers have been working hard to prevent the redevelopment-pushers from setting up a redevelopment area in the town. There have been countless hearings at which Randy spoke, as did many



residents of Clearlake. But the council brought in smooth-talking attorneys and slick "consultants" to persuade opponents that redevelopment would be simply wonderful for Clearlake. "Now don't worry," said the city administrator Dan Obermeyer. "There are a number of steps that must be taken before the plan is finally approved."

One of the necessary steps is the approval by the council of

Bill Holmes, who was hoping to run in the special election for the 76th Assembly District seat (see last month's newsletter), was a few signatures short of the necessary number for filing. Well, better luck next time.

ORANGE COUNTY: Orange County chair Richard Martin was able to arrange for himself and David Bergland, our 1984 presidential candidate, to be on the Tom Lykus talk-show to discuss libertarianism in general and field questions from the calls. "We talked about every topic from foreign policy to drugs—you name it," says Richard. This was from 5-7 p.m., which is prime time for people listening to their car radios on the way home. It's estimated that at any one time at least one million people are listening, and that in the two hour period over five million people heard at least something about libertarianism.

FRESNO COUNTY: Roy Shimp and John Graham went to Drug Forum and distributed "Battle for Legalization" flyers and talked to the public. John was interviewed by Channel 24. "... If we take away the profit, nobody would be trying to sell drugs to your kids. People don't do that for fun—they do it for money. ..." That's the sound bite they put on the 11 p.m. news.



Mike Iddings to Run for V-C

Mike Iddings of Santa Clara County will seek the office of vice-chair of the Libertarian Party at the upcoming National Convention in Philadelphia (Aug. 31-Sept. 3). Mike is presently a state excom rep. for his county. As he has only just announced his decision, *CLNews* does not have many details. However, so far he has the endorsements of past LPC chair Ted Brown, *LP News* editor Karl Hess, and the Santa Clara County excom. Call Mike at the state office for more information.

• **Platform Committee Note:** Ted Brown, Bill Evers and Mike Iddings were chosen by the National Committee in April to serve on the Platform Committee at the Convention; John Vernon was elected Platform Committee representative from California at the May excom meeting. The "Clean Needle" Initiative

As of press time it looks as though the San Francisco LP's "Clean Needle" Initiative will be on the November ballot. Ten thousand valid signatures are needed for qualification, and signature gatherers have turned in 12,000. Another 1,500 or 2,000 are due, and George Meyers, author of the initiative, reports he is confident that he'll have 14,000 by the filing date. But, he adds, he'd feel a lot more certain of success if he had 15,000 to provide a wider margin of safety in case of disqualifications.

Update: Shimp for Congress

"Things are really going crazy around here," reports Merced County chair Roy Shimp, who is running for Tony Coelho's 15th Congressional District seat. Roy has just learned that Mike Stewart, a local DJ on station KTRB, has recently registered Libertarian in order to enter the race. According to reports, Stewart's not been a registered anything for years, and is doing it as a publicity stunt for the station (two years ago he ran for mayor as a joke)—but the *Modesto Bee* is treating his as a serious campaign, which could hurt Roy's efforts.

Interestingly, the news director of KTRB and another DJ are long-time Libertarian activists and were even candidates. Both had signed Roy's signature papers, and were as much surprised as Roy was at Stewart's actions. "He's probably not going to do much except announce his candidacy," says Roy. "He'll have a hard time getting signatures. There are only 300 registered Libertarians in the 15th District, and I got 60 of them to sign my papers."

As *CLNews* reported last month, Roy needs volunteers to walk precincts and hand out literature, and he wants help in formulating libertarian statements on local issues. And of course no candidate—Libertarian or otherwise—ever has enough money. To participate in this campaign, please contact Roy at (209) 7233-1768. Using the Nolan Chart

I Got Two — Do You?

Two what? If you enjoy discussing politics, then it'll be fun and easy for you to get two new Libertarian registrants each month. Just carry a couple of our registration kits around with you in your pocket or purse, and when the subject of politics arises, ask the persons you're talking with if they'd like to discover their true political identity. Most folks are interested in the three-minute quiz in the kit which shows where they fit in.

The odds are that one out of six people you encounter will be libertarian: pollsters have found that 15–20 percent of the public thinks this way today. When the self-discovery quiz reveals a new libertarian, you give them one of the "What is the Libertarian Party?" brochures and explain that this is the political party that best represents their viewpoint. Next, ask if they would like to register to vote in it, to send the politicians a clear message about what they believe. One-third to one-half of those who discover that they are libertarians will register, and you can usually get the name, address and phone number of the others on the quiz card to receive more information.

We'll send you a six-month supply of registration kits, plus instructions on how to use them, if you write or call: Libertarian Voter Registration Project, P.O. Box 684, Lower Lake, 95457; (707) 994-4817. We'll put you in touch with the person in your area who can show you how to use the kit, or with our new field coordinator **Jim Lewis**, who'll be touring the state showing the regions how to set up an effective local registration drives.

Whether the Libertarian Party remains on the ballot as the only consistent political voice of liberty depends on you. Don't be an inactivist. Please help recruit your share of new libertarians that we need to organize to keep the statists from eroding our freedom any further.

Randy is the LPC chair of Lake County and a coordinator of the state registration drive.

Where Our Friends Are

Is there a "secret" Libertarian on your city council (or board of supervisors, planning commission, whatever)? Here's how to find out. **Jim McClarin**, former California LP candidate for assembly and now vice chair of the LP of New Hampshire, mailed "Nolan Chart" postcards to all 400 representatives in the New Hampshire legislature, each with a hand-written note inviting them to take the quiz and suggesting they contact the LPNH if they scored high.

By late May, two reps had requested more information—and one of these scored a perfect 100 percent! Now if there's any lobbying to do, the LPNH knows who to talk to. **Jim** plans to mail cards to New Hampshire business owners. "I expect more of them to be Libertarian," he says.

Seems a great outreach idea, but if a full mailing to the state legislature is more than a local activist would want to take on, how about your city council? For a chuckle, why not the redevelopment agency? Or your own assemblymember or state senator, and maybe their staff? If anyone decides to do it, please let *CLNews* know the results.

the draft version of the Environmental Impact Report (EIR). On July 5, a vote to approve the EIR was to be taken. Clearlake has a city council of five members (one of whom serves as mayor), and three votes were needed for approval. The mayor and one council-member disqualified themselves due to conflict of interest, which meant that the remaining three would have to be in agreement. Two said fine, but **Struthers** put his foot down by and just said no. Later he told the press, "This report has no value in my opinion. I have told **Dan Obermeyer** over and over again that public education is needed to let people know about this." **Struthers** felt that the EIR was vague and deliberately misleading.

You'd think he'd be honored for his integrity, but the local press was outraged. "Struthers Vote Costs City \$50,000" screamed the headlines, referring to the price-tag on putting together the EIR and a redevelopment plan for Clearlake. Editors and reporters castigated him, but the worst was yet to come.

On July 10 **Obermeyer** placed an ad in the paper (which ran it at no charge) inviting those interested in bringing redevelopment to Clearlake to come to the next council meeting, on July 17. However, the published agenda listed no item dealing with redevelopment. Curious.

When **Struthers** arrived at the meeting he saw that there were at least 200 people in the room. He has since found out that the mayor and others phoned their friends and told them to come to the meeting—"if you're for redevelopment."

Mayor **Caroline Constable** opened the meeting with the first item, Public Input, and about 30 members of the "public"—developers and various city hall toadies—got in line to participate in a public bashing of **Bill Struthers**. When he tried to protest **Constable** ruled him out of order and told him to hold questions and comments till the end of the "discussion." For two hours **Struthers** suffered abuse at the hands of a pack of howling pecksniffs. When the last member of the "public" had vented his spleen it was **Struthers** turn, "But I felt so devastated I couldn't think of a thing to say. I felt completely numb," he recalls.

But he didn't feel wiped out for long. Despite hostility from the press, city council and administration, **Struthers** is hanging in there and has lined up some consultants on his side. A number of irregularities in conjunction with the drafting of the EIR and the establishment of the project area have been uncovered. Expect some fireworks when this is all brought into the open.

People like **Bill Struthers**, who are willing to stand in the frontlines, are rare and deserve our support; and it's easier to fight the good fight if you know you're not alone—that there are folks on the sidelines cheering you on. He'd sure like to hear from Libertarians—a note of encouragement or some information on your experiences with government or redevelopment agencies. Chinese Students Vow Freedom for China

Our brethren are already in the field—why stand we here idle?

Last month Libertarians watched in outrage at the events in China, wondering if there was anything we as individuals could do to help those brave young people. What could we do to assure that the torch of liberty they lighted in Tiananmen Square be kept burning. Is there anything we can do? The answer is yes!

Libertarian International (LI), the world-wide network for freedom-loving people, has learned of a new organization called the Alliance of Chinese Patriots, which was formed June 7, a few days after the Beijing Massacre. The founders are students from mainland China studying at various universities in this country and who rallied in Washington to establish the organization. With the help of several American libertarian constitutional scholars (including Roger Pilon of Cato Institute), the Alliance drafted the following statement.

Declaration of Chinese Patriots

As the world watches, we, the Chinese people are today engaged in an epic struggle to cast off the chains that have bound us for two generations. The present system has been tried in China and has failed. It has produced hunger where there should be plenty, corruption where there should be integrity, servitude where there should be freedom. The Chinese Communist Party and the government it created are today under siege because they have failed to understand that the Chinese people will no longer tolerate these conditions. The Chinese people yearn to be free. We yearn to join the community of free peoples. We will not rest until we do.

Therefore we, Chinese patriots, declare the principles that guide our struggle for freedom:

1. Every individual is born with equal and inalienable human rights.
2. The basic right of every individual is the right to be free, the right to plan and live his or her own life. This right entails all other rights, including the rights of speech, press, assembly, association, religion, property, and privacy.
3. To secure these rights, individuals create government, to which they give only as much power as is necessary to secure their rights.
4. A government is legitimate only if it rests on the consent of the governed.
5. The people retain the right to deny legitimacy to their government by withdrawing their consent.

To secure these principles through law and legal institutions, we all for a constitutional convention where the people's representatives, selected in free and open elections, will write a constitution for a free China.

According to their Statement of Purpose, the Alliance will encourage "the development and dissemination of the ideas and information that will lead to a free, prosperous, independent, and democratic China. . . grounded on the principles set for in the Declaration. . ." It will monitor the situation in China and encourage Chinese translations of the literature of freedom and democracy and the dissemination of those works throughout China through both print and electronic media.

Vince Miller, founder and director of LI, writing in *Freedom Network News*: describes the Chinese fight for liberty as "a major *cause celebre* for libertarians"; and asks that individuals and organizations in the world network, including state/local LP groups, endorse the Declaration and gather petition signatures in support of it and the students.
