LP Candidates Run Hard But Fall Short

- Turmo-Wilber loses squeaker
- Nassau breaks record

Rebecca Turmo-Wilber lost her bid to win a second term on the Woodstock Town Council, missing by just 27 votes. She finished fourth in a 5-way race for 2 seats. Turmo-Wilber was the only Libertarian holding public office in New York. The unofficial results showed her with 1,085 votes. The second place finisher had 1,112 votes.

The complete results are as follows (top two won):

Stock - R 1,362 Simonson - D 1,112 Hughes - D (incumbent) 1,099 Wilber - LP, R (incumbent) 1,085 Mercer - IP 304

In Nassau County, none of the

candidates was elected, but they did get a record number of votes for any Libertarian candidate in the county. Vincent O'Neill pulled 6,128 votes in his bid for County Executive.

In the other countywide races Richard Cooper pulled 1,652 votes for County Comptroller; James Harris got 1,382 votes for County Clerk; and Daniel Conti got 1,916 votes for District Attorney. Stephen Edmondson pulled 417 votes (2%) for Nassau County Legislature in the 5th District.

These results were impressive considering libertarian candidate vote totals in the past. In 1996, the Brown/Jorgenson ticket received 784 votes in Nassau. In 1994, our statewide ticket received vote totals between a low of 659 and a high of 1072. Furthermore, the voter turnout this year was only 40 percent countywide, which is a lower turnout than in 1994 and 1996.

In Dutchess, David Harnett pulled 37 votes (3%) in his 3 way race for Town Council. He was on the ballot on the Libertarian Party line and the Freedom Party line.

Sabrin's the Difference in NJ

In New Jersey, Murray Sabrin got almost 5% of the vote for Governor of New Jersey. This was easily more than the 1% that separated winner Republican Christie Todd Whitman and 2nd place finisher Democrat Jim McGreevey.

Sabrin's strong showing gave him the fourth best Libertarian gubernatorial showing in LP history. The unofficial vote totals are below.

If I Were Governor, Robert Goodman Announces

Long-time Libertarian activist Robert Goodman has announced that he will seek LPNY's nomination for Governor of New York in 1998.

Goodman is currently a medical scientist consulting for Nutramerica Inc. and licensing a patent he developed on a surfactant composition. His only previous run for public office was in 1988 for the assembly in the 81st district.

For next year we must learn a lesson from the campaign for governor of NJ that was run this year -- not by Murray Sabrin, able as he was, but by Jim McGreevey. Having experience in elected government offices (holding a pair at the time), being the nominee of a major party, and sticking robotically to the

message he wanted to sell nearly won him the governorship against an incumbent who'd seemed quite popular.

He never nailed down the way he intended to accomplish his main promise: a 10% reduction in car insurance rates. People inferred that he had some sort of executive fiat in mind, although it was pointed out he had no power to do that. Still, the other advantages he had (elected experience, winner of a major party primary) gave him enough credibility to do well.

I don't have those advantages. Therefore, to gain credibility I will do research to learn exactly how as governor I can quickly and surely accomplish some major benefit I'll promise that will excite a major segment of the electorate. Not pardoning convicts, not appointing

somebody; not enough votes there. Not promising to veto bills; too many variables there, and not a positive enough message.

One avenue which deserves exploration is the governor's role as commander-in-chief of the military forces of the state, which by implication of the constitution would include the unorganized militia. This year I voted for a candidate for New York City council who wanted to upgrade (volunteer) Auxiliary Police to peace officer status, thereby giving them the right to carry pistols and increasing the police force at no cost to taxpayers. That's the clever kind of solution I'd like to pursue statewide.

A 10 Point Program to Free New York By Jim Harris

Jim Harris of Nassau has announced that he will seek LPNY's nomination for Lieutenant Governor in 1998. He lives in Valley Stream and works as a salesman of pre-cast concrete. He has been a member of the Libertarian Party since 1992.

The following is his suggestion for the LPNY to use as a framework for next year's campaign.

10 Point Program to Free New York

- 1. Phase out state income taxes in three years 1/3 each year
- 2. Establish Term Limits 12 years for U.S. Senator, 8 years all other offices

After a 6 year layover, it is permissable to run again for office previously held.

- 3. Initiative
- 4. Referendum
- 5. Freedom of School Choice -50% tax credit of local government school costs for each child transferred to private school until 18.(credit age available to whoever pays tuition)
- 6. Privatize Marriage repeal state licensing of marriage replace with private contract between the two parties and/or their religious advisor
- 7. Purse-concealed carry license for .32 caliber, and under,

handguns throughout the state, including NYC, except for convicted violent felons and mentally impaired

- 8. Free all prisoners not convicted of a violent felony. Substitute restitution and other penance for those convicted of victimless crimes
- 9. Free the high schools lower the mandatory compulsory school age to thirteen
- 10. Allow the growing of hemp and use of all its by-products create a cash crop for farmers and new jobs for New Yorkers.

"Let's get everyone we know to call and push for Ron Paul's two bills that would reduce ballot access requirements for third-party candidates (HR 2477) and bar any Presidential candidate taking Federal matching funds from participating in any debate that excluded candidates on the ballot in at least 40 states (HR 2478). Garvey Seeks US Senate Seat

Christopher Garvey is seeking the LPNY nomination for U.S. Senator. He is currently working as a patent attorney at Nolte, Nolte & Hunter, P.C. In 1994, he was the LP candidate for Congress in the 2nd Congressional District

He says that the issues he plans to emphasize in order of importance are: the 2nd Amendment, the income tax and education.

"Abolish the income tax.," he said, "or, if abolition is not politically possible at least get it down to 18% max (the low end of the peak of the Laffer curve) for all income taxes combined including Social Security."

He would like to see a separation of school and state, and would start by abolishing the Dept. of Education, "that educates no one."

He would also like to abolish the FDA, DEA, and BATF. "Government has no business telling us what we can't put in bodies," he said. recommend most people avoid most drugs, but I don't know what's best for each of you. Neither does the FDA. And the DEA makes a zealous policy of ignorance. When the BATF isn't shooting at women and children it vindictively suppresses truth in advertising."
