THE CASE FOR NEUTRALISM: AWAY FROM KING-MAKING

Wars change things. Children become orphans, wives become widows, health becomes diseased, and life becomes death. If an individual kills another individual it is called murder. When it is done by a collective group it is called war.

As with individuals so is with nations; if you mind your own business no one will bother you. This is a laissez-faire doctrine of live and let live. In foreign policy this is a neutralist position. If we don't take sides in other nations' conflicts, we can't be hated. This country spent many prosperous years having a neutralist stand. George Washington warned against entangling alliances. In our early history we did not get involved in the endless warfare in Europe and the world.

Today the story is reversed. We give foreign aid to almost every nation and conflict. Foreign governments are taking advantage of us by playing up the threat and dependence of the Soviets. The nation of Turkey has just used this shenanigan. They warn us if we don't give them aid they will turn to the Soviets. Another example of this kind is Egypt. This is the second time they supposedly expelled the Soviets. In return for this action they want American help. And once we do help there becomes more financial obligations.

In return for our assistance we give to other people, they turn around and spit in our face. These people are biting the hand that feeds them. Except for Finland, no country has ever repaid us for our aid. It is about time we ask these foreign governments to start paying back what they owe to the American taxpayer.

We should have learned from our past mistakes. We cannot make the world safe for democracies by supporting every ruling class in the world. World War I was a clear example of imperialistic motives on both sides. Our purpose should have been non-involvement, but President Wilson wanted to play king-maker. The final results were that England got a great deal, Germany got a rotten deal, and America began dealing with all the world's problems.

When a government wages war, it also wages a war against its own citizens. Senator Robert La-follette in warning us against World Wars said, "War is democracy's greatest enemy. It cannot live under war conditions. If we enter the war, our own democracy would be the first casualty." During the war civil liberties are suspended, and taxation becomes the fuel to keep the war machine moving.

It becomes an impossibility for the citizen to be neutral. You either contribute your life and money for the war, or face imprisonment. If you're a pacifist or individualist you're termed a subversive. During World War I many German Americans lost their rights as citizens. Legislation was passed to make it a crime to speak German in public. German American newspapers were scrutinized by the government.

And even the name of sauerkraut was degermanized to the name of liberty cabbage. In some areas the war pitch became so fierce that anti-German rioting was produced. Japanese-Americans faced similar problems in the following World War.

Only a neutralist position can benefit America and the world. Interventionist policies have failed in the past. To arrive at this neutral position we must take the following steps. We should swiftly end foreign and military aid to other governments. We should only be able to strongly defend the United States from direct attacks. If individual Americans want to send aid to help the Irish, the Greeks, the Ukrainians, the Israelis, etc. that's their choice. But to force other Americans to support these people is immoral.

When property rights are respected along with peoples' right to emigrate, freedom of trade, freedom to communicate, and freedom from coercive governments; then true peace will follow.

LP Platform - NJ Addendum

The systemic crisis of statism in America is no where more evident than here in New Jersey.

Cancerous government, a collapsing economy confiscatory taxation and massive unemployment all lead to the conclusion that politics as usual, the politics of spend, spend, elect, elect (tax, tax) has failed. It is time to seek solutions to social problems which remove the deadening hand of government control from our lives.

We propose to move forward on four broad fronts:

the crisis of state spending,
the crisis of local autonomy,
the crisis of accountability, and
the economic crisis.

First, total state spending in New Jersey has exploded by over 2,500% in 30 years: we call for a constitutional limit to state spending and a yearly reduction of the budget by at least 1% (our "Our Percent for Freedom" program) State taxes on a per capita basis have soared by more than 250% in a decade (while per capita income was up only 97%): we call for a freeze on higher taxes with meaningful tax-rollback in 1976, including the repeal of the so-called "temporary" income tax.

Second, local communities are losing even the semblance of local autonomy: we call for a reversal of this trend by (1) repealing any legislation which denies local citizens control of their schools, such as the "thorough and efficient" Education act of 1975 as a step toward the abolition of government control of schools; (2) re-enacting and expanding the recently repealed provisions of N.J.S. 40A:9-165 that permitted local voters to challenge local government salary increases by referendum; and, (3) repealing all state and regional land and sea use restrictions as a first step toward a free market in real property.

Third, that the governor and state legislature be held more directly and immediately accountable for their actions, especially in areas of taxation and spending, by amending the state constitution to allow broad use of the citizen powers of initiative, referendum and recall.

Fourth, though the economic crisis is largely a creation of the Federal government's debasement of the dollar, New Jersey's unsound policies have caused the depression to be more serious here than in other less regulated state economies. We call for the repeal of victimless crime laws, of taxes and restrictions, of subsidies and monopolies--especially on trade and production so that New Jersey becomes a center of liberty, a tax and free trade haven to attract an expanding commerce and production to improve the quality of life for all of us.

With steps such as these, it is possible to begin to return control over our lives to all Jersians during this becentennial year. In 1776 New Jersians raised the banner of Liberty against the citadel of Power: we too stand ready to struggle as ceaselessly as they to regain the Liberty they won and lost.

TO THE GENERAL MEMBERSHIP:

A simple, but direct & well-thought-out, letter emphasizing the main points that concern the particular agency that is to receive it; an intelligent appeal for equitability in getting our sensible ideas to all citizens, is what is needed. And only you, we, can do it. If not we, then who?

Examples I have tried are: letters to -- Robert MacNeil, Channel 13, asking for the appearance of Roger MacBride as a guest on his news show.

Director of the special on Gay Rights, Ch. 13, correcting an error that only a major party was concerned about the rights & hassles of gay men and women/and quoting from our party platform/and inviting queries from all.
Tom Snyder, Channel 4, suggesting the appearance of Roger, for a stimulating show.
Johnny Carson, Channel 4, same as above.
Texaco, expressing the LP views on the oil situation, & offering a speaker for their next vacant meeting.

NJEA-PAC, returning a form reflecting our LP views on education, & enclosing LP literature.

Some of you may think that this is naive, and nothing could possibly come out of it. I say, wrong, for our NAMES are placed before MANY influential eyeballs -- not by sloppy, irrational letters/rather by intelligent presentations & suggestions. And the cost to you? Nil, merely a stamp at a time, plus your time. Don't just think about this...DO IT NOW!

On July 25th I sent a covering letter on New Jersey Citizens For MacBride stationery to six New Jersey PAC's obtained from a recently updated listing of all PAC's prepared by the U.S. Chamber of Commerce in Washington. Enclosures included a large New Dawn, the Government and Business position paper, LP background statement and a copy of Roger's book in addition to a 5-page memorandum (also on NJCFM letterhead) which I prepared as a personal statement cum condensation of Roger's work. A copy of the covering letter is set forth below as well as the six Committees with names, addresses and phone numbers.

I was somewhat surprised by the paltry number of PAC's in this state as compared, for example, with almost 100 in New York.

TAX REBATE: Return Of Stolen Money

CURRENCY DEPRECIATION
THE HEROS AND THE VILLIANS

Next month, this writer will compose a complete review of The Paper Aristocracy by Howard Katz.

The purpose of this article is to discuss some of the concepts upon which the principal arguments of the book are based.

In a column last month, Mr. Katz's tactic for using the term "currency depreciation" rather than "inflation" was explained briefly. He maintains that Lord Keynes economic theories are not the result of honest intellectual effort. Rather, Keynes was an agent for the banking and financial interests. His goal, according to Katz, was to present a system of economic manipulation in terms which appeared to be pro-labor and pro-benevolence. Keynes wanted people to draw certain conclusions (e.g. an expansion of the money supply is good for the country), and framed his concepts accordingly. His great accomplishment was gaining universal acceptance of his carefully chosen terms.

Keynes strategy is important because of the way the human mind works. The vast majority of people follow the path of least resistance when dealing with difficult concepts. Even those people who understand the fallacies in Keynesian theories have a difficult time explaining the nature of the errors because they frame their arguments in Keynesian terms. As an example, Murray Rothbard's writings are generally complex when refuting Keynes. If Dr. Rothbard were permitted to define the conventional economic terms, the Keynesian arguments would be shown to have no merit. It would be obvious to anyone. If you wish some specific evidence consider these Keynesian terms:

"inflation" is defined as a rise in prices. When establishment economists explain "inflation" they talk about the goods which rose in price; if they were required to discuss "currency depreciation" they would have to explain how the Fed is destroying our money.

"reserves" is a term which defines a portion of all the depositors' monies to be retained in an available status by the bank; there is a strong implication that these funds are assets of the banks to be "managed" by the banks. Contrast this with the nineteenth century terminology of "issuing bank notes in excess of species," the latter leads one to conclude that the banks are doing something morally wrong while the former is supportive of this banking practice; The power of these terms is reflected in the law - your deposits are viewed legally as bank assets.

"wages" is assigned a dual definition in the Keynesian literature; Sometimes it means wage rate while other times it means total wages earned by the worker.

"velocity" is a term which refers to the rate at which money exchanges hands. In practice this rate cannot be measured; whenever Keynesian economists are in error in their predictions, they explain that the velocity of money was greater or smaller than normal, since velocity cannot be measured, it is not possible to determine if the economists' explanation is true; thus, the validity of the theory can not be tested empirically in the real world.

Keynes was a brilliant man. The fact that he chose terms such as those listed above is an indication that he was a fraud. Lord Keynes was a villian.

One of the favorite slogans of the conservatives is that we must have a balanced budget. More importantly, most conservatives assume that "inflation" is a result of "government running the printing presses." The conservatives go on to explain how someday America will be punished because of its deficit spending - the economy will be in ruin on that day. The conservatives tell us that big government is the villian and we will all pay the price in the future.

HANNIBAL BATTLES BERGENFIELD BUREAUCRATS

The Bergenfield Taxpayers Association, spearheaded by our U.S. Senate candidate, Hannibal Cundari, has once again evoked a flood of protests from the boro bureaucracy. Rapidly reaching an SST decibel level, the collectivist noise machine has accelerated into high gear hurling their usual innuendos and employing intimidation and harassment against the members of the BTA. They have lowered themselves (can they really go any lower?) to such a level of irrationality where slanderous and libelous epithets are being directed at Hal, personally.

"Senator" Cundari (how sweet it is!) has uncovered a N.J. Constitutional law which permits the citizens of any N.J. community to petition for a referendum which will allow the voters to set the salaries of their municipal employees, elected and appointed.

After Hal had researched the necessary particulars including obtaining a list of the official salaries from the Boro Clerk, he submitted the proposal to the members of the BTA (I am a victim of the government's alphabet soup logic). After lengthy discussion, the petition was put together by 9 members and Hal placed it in circulation on Memorial Day weekend.

Having always been an enthusiastic supporter of local police departments, I was going to refrain from mentioning that the Bergenfield Police Department is the leader of all the opposition to our petition. Recent events have precluded that possibility.

A scurrilous advertisement has been placed in the town newspaper by the Bergenfield Police Assn under the nom de plume: Concerned Citizens of Bergenfield (sic). The gist of this ad was to list positions which they attribute to Hal Cundari and which bear no relation to the contents or intent of the petition in question. Some of these positions are so outlandish that the intent can be no other than to establish guilt by association. Did you know that Hal favors abolition of all fire departments and apparently supports pyromania?

Without presenting a detailed chronology, the American Civil Liberties Union, an organization I do not revere, has agreed to handle the case on behalf of Hal and the BTA.

The 1st Amendment to the U.S. Constitution states "Congress shall make no law respecting an establishment of religion... or the right of the people to peaceably to assemble, and to petition the government for a redress of grievances." Keep that in mind.

What can be done to help?

Aside from a petition blitz in Bergenfield, the drawing up and circulating of similar petitions in your own community will serve to not only bolster liberty in your town but to show Bergenfield, other N.J. communities, Trenton and maybe even the other 49 states, that WE ARE FED UP WITH TAXATION AND COLLECTIVIST INTERFERENCE IN OUR INDIVIDUAL LIVES. WE HAVE DRAWN THE LINE AND MEAN TO FIGHT.

The more communities that become involved, the greater will be the pressure exerted upon the bureaucrats and the quicker other townships and even states will begin to realize that it is not "you can't fight City Hall" but rather CITY HALL CANNOT FIGHT YOU!

The manorial lords in Trenton, with their convoluted logic and income tax psychosis, will I feel certain, seek to circumvent the implementation of this referendum if adopted by the voters. They nullified our 1975 referendum relating to salary increase and this is why it is vital for as many communities as possible to become involved in instituting their own petition. King Byrne will ignore the rabble until the pressure grows even unto the doors of his Trentonship.

Although we may not reduce the tax level at present, it can be the proverbial "foot in the door." 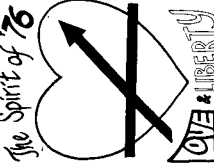

LIBERTARIAN PARTY Statement of Principles

We, the members of the Libertarian Party, challenge the cult of the omnipotent state and defend the rights of the individual.

We hold that all individuals have the right to exercise sole dominion over their own lives, and have the right to live in whatever manner they choose, so long as they do not forcibly interfere with the equal right of others to live in whatever manner they choose.

Governments throughout history have regularly operated on the opposite principle, that the State has the right to dispose of the lives of individuals and the fruits of their labor. Even within the United States, all political parties other than our own grant to government the right to regulate the lives of individuals and seize the fruits of their labor without their consent.

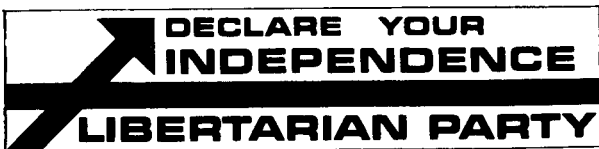
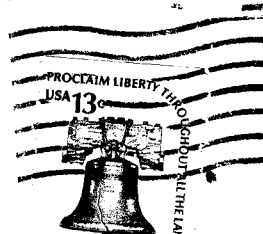
We, on the contrary, deny the right of any government to do these things, and hold that where governments exist, they must not violate the rights of any individual: namely, (1) the right to life—accordingly we support prohibition of the initiation of physical force against others; (2) the right to liberty of speech and action—accordingly we oppose all attempts by government to abridge the freedom of speech and press, as well as government censorship in any form; and (3) the right to property—accordingly we oppose all government interference with private property, such as confiscation, nationalization, and eminent domain, and support the prohibition of robbery, trespass, fraud, and misrepresentation.

Since governments, when instituted, must not violate individual rights, we oppose all interference by government in the areas of voluntary and contractual relations among individuals. People should not be forced to sacrifice their lives and property for the benefit of others. They should be left free by government to deal with one another as free traders; and the resultant economic system, the only one compatible with the protection of individual rights, is the free market.
