LEI Presents Exciting Line-up of Speakers for LP National Convention

The Libertarian Education Institute hosting the 1991 Libertarian Party Presidential Nominating Convention is presenting a great line-up for libertarians and non-libertarians alike. Speaking on the main floor will be Joseph Sobran, syndicated columnist for *National Review*, on "From Conservative to Libertarian." Following him will be Richard Dennis, retired commodities broker, president of the Drug Policy Foundation, and publisher of *New Perspectives Quarterly*, who will speak on "From Liberal to Libertarian."

A panel discussing the Bill of Rights and the erosion of such rights will include Jarret Wollstein, member of the International Society for Individual Liberty; Nadine Strossen, president of the American Civil Liberties Union; Red Beckman, author and lecturer on tax resistance and grand-daddy of the Fully Informed Jury Amendment; and Bill Grossman, president of the Free Press Association, the organization that gives out the H. L. Mencken awards every year.

A panel discussing the Fully Informed Jury Association will include Larry Dodge, founder of FIJA and libertarian activist in Montana, and Red Beckman.

Richard Dennis along with Northwestern University professor, Daniel Polsby, will take part in a drug legalization debate against two unannounced foes.

Jack Herer, researcher, activist, and author of *The Emperor Wears* No Clothes will discuss libertarian activism, relating his experiences in trying to get a hemp legalization amendment on the ballot in California.

Larry Pratt, president of Gun Owners of America, will speak for the Thursday morning breakfast on the importance of the individual right to bear arms.

Karl Hess, editor emeritus of the LP News, author, lecturer, community organizer, and master welder, will host the Friday morning breakfast, speaking on Libertarian unity.

The Saturday morning brunch will be presented by the two announced Libertarian presidential candidates, Dick Boddie and Andre Marrou. They will discuss their visions of the future of the Libertarian Party.

Our own Joseph Bast, president of The Heartland Institute, will host a panel on educational choice.

Economist and Soviet defector, Yuri Maltsev, will speak on European capitalism.

NTUI president Jim Tobin will team up with financial advisor Mark Skousen for a tax-fighting panel.

Ron Paul will be present as a commentator for CSPAN, as well as introducing the Saturday night banquet LP nominee for President.

Workshops include FIJA, initiatives, campus activism, cable TV, marketing/fundraising.

WLS talk show host and libertarian, Stacy Taylor, will be the emcee for a good part of the convention.

CSPAN says it will supply gavel-to-gavel live coverage.

Other events rounding out the convention include a "Second City" presentation, a "Taste of Chicago", a Bill of Rights anniversary party, a Chicago Tour, and the lakefront Jazz Festival.

Add all the excitement on the floor including platform debates, election of national party officers, and the nomination for President of the United States, and the National Convention in Chicago becomes a can't miss proposition. See ad on page 5 for registration information.

Assault Weapons?

For those not familiar with firearms, and not well informed about the state of current firearms law and the use of firearms in crime, the gun control issue can be confusing.

You may intellectually agree that disarming the public would remove the last resort of Government "accountability" available to the people, yet find your convictions wearing down after the latest gun control offensive. The advocates of gun control have emotional manipulation down to a science, and they do a great job of making their latest demand sound reasonable and necessary. The news media have supported this with a massive disinformation and brainwashing effort. This has fit very neatly with the entertainment media's love of "machineguns," to give the public the impression that every street punk is equipped with the latest of hi-tech military weapons. The truth is, most violent crime is still committed with clubs and knives; firearms styled after modern military weapons make up an insignificant part of those firearms used to commit crimes.

If you aren't familiar with firearms you may have been led to believe that there is a definable class of firearms known as "assault weapons". Politicians and the news media have waged an hysterical campaign to convince the public that these weapons must be outlawed immediately. Yet no two politicians ever give the same definition of assault weapons when asked. This is not surprising if you understand that this is a political term, not a technical one. If they can pass this term into common usage, they can call any gun they want to ban an assault weapon. How can anybody disagree when there is no definition of the term?

"Assault rifle" is a military term for a rifle which fires a less powerful cartridge than a standard rifle and is capable of both semi-automatic (one shot with each pull of the trigger) and automatic (machine-gun) fire. Assault rifles are not available to the public. Replicas of some assault rifles, which are only capable of semi-automatic fire are legal to own. Despite the frightful appearance of some of these weapons, they are no more deadly than weapons which have been available since the beginning of the twentieth century.

Politicians, bureaucrats and the news media encourage you to believe these weapons are bad because they LOOK LIKE machine guns. The news media has been working for about five years to confuse the public to believe that "semi-automatic" means machine gun. They

have been successful in this effort, partly through the use of trick film clips.

A common media tactic is to show an AR-15, a legal semi-automatic replica of the US Military M-16, on a gun-store rack, then cut to a firing range where a real automatic M-16 is being fired. The two different rifles look very much the same, so the unaware viewer is convinced that the corner gun store is selling machine guns to anybody who wants one.

Semi-automatic replicas of automatic weapons must be approved by BATF, to insure they cannot be easily converted to automatic fire. Anyone who has the skills and tools to convert a semi-automatic firearm to automatic fire could probably build a weapon from scratch.

Despite the "crisis", semi-automatic firearms are nothing new. Semi-automatic guns have been available in the United States since the 1896 Maser Broomhandle. Colt semi-automatic pistols, Remington and Winchester semi-automatic rifles and Browning semi-automatic shotguns have been available since the first decade of the twentieth century. Why the sudden emergency?

We are told these weapons are used in "drive by shootings" and gang wars over sales territory. There is nothing new about these events either; they both happened during alcohol prohibition. The government's new prohibition, drugs, has brought these violent practices back again.

What we have here is the typical statist scam. One statist policy causes a problem, so instead of stopping what they did to cause the problem, they want to impose another statist solution, which increases the original problem.

When they have an excuse to tie the new "solution" to a longstanding statist goal such as total civilian disarmament, all the stops get pulled. This is why we are seeing such a bizarre coalition of leftist police administrators and statist politicians of every stripe working together to ban "assault weapons".

Banning all civilian firearms ownership is the goal of many politicians and government careerists. Laws against ill-defined "assault weapons" will be an important step toward that goal.

Henry George Offers Summer Schedule

A special summer schedule will be offered by the Henry George School. Classes will be available 2:00 PM and 7:00 PM on Mondays, Tuesdays and Wednesdays from June 24 to August 28. Each class will meet once a week for ten weeks. Sessions usually last about an hour to an hour and a half.

Fundamental Economics and Social Philosophy, the School's introductory course, will be conducted by Libertarian Sam Venturella, a retired City Planner; George Menninger, a real estate developer; and LPI Treasurer, Scott Walton, a real estate broker. No tuition is charged for this course. A registration fee of \$10 is asked to help cover the cost of materials. Text for the course is Henry George's *Progress and Poverty*.

New Spectrum

Debbie Davis [letter, May 21] perpetuates the myth that the spectrum consists only of "conservative," "liberal" and "centrist." Readers should get beyond this left-right spectrum.

A new spectrum, conceived by David Nolan in the late '70s, plots a person's support for liberty along two axes—personal liberty (military draft, drug laws, homosexuality) on the vertical axis and economic liberty (free trade, farm subsidies, welfare) on the horizontal.

The more a person supports personal liberty, the higher he scores on the vertical axis; strong support for economic liberty moves a score higher on the horizontal axis.

Liberals appear in the upper left corner of the Nolan Chart, because they favor personal liberty but oppose economic liberty.

Conservatives appear in the lower right corner, because they favor economic liberty but oppose personal liberty. Centrists appear where you would expect to see them—in the center.

The two new groups also appear on the Nolan Chart; authoritarians (who oppose both personal and economic liberty, and thus appear in the lower left corner) and libertarians (who favor personal and economic liberty, and thus appear in the upper right corner).

If you've wondered why the Democrats and Republicans appear to be more alike than different, the Nolan Chart helps explain why.

Both oppose a form of liberty; liberals oppose economic liberty, while conservatives oppose personal liberty.

Only libertarians favor liberty across-the-board and oppose government interference in the economic and personal lives of responsible individuals.
