Ron Paul in California NON-STOP CAMPAIGNING

POMONA: A spur-of-the-moment visit to a large gun show at the Pomona Fair Grounds in July resulted in some good press for candidate Ron Paul, and may have made friends among those who recognize the importance of the Second Amendment. It was part of a brief tour of the Southland, a weekend marked by virtually non-stop campaigning.

Originally only one event had been set up, a fundraiser at Kenneth Gerbino's home in Beverly Hills, Saturday evening, July 9. But volunteers went to work and booked interviews for him with the press, and Region 63 chair Gail Lightfoot and Paul supporter Ed Valens arranged for an LPC booth at the gun show. When Ron flew into LAX July 8, he was facing a very full schedule.

He was met by Congressional candidate and local Paul Campaign coordinator John Vernon, who took him on a round of interviews: the Orange County Register; the Hispanic newspaper, *La Opinion*; and to L.A. State where Laura Brown interviewed him for the *University Times*.

The gun show visit was coordinated on just a couple of days notice. While Ed Valens arranged for the LPC booth,

Gail Lightfoot set up a schedule for people to staff it all weekend: Ed Moss, Ted and Laura Brown, John Tuttle, Ken Valentine and Gail herself. The booth was ready when Ron dropped by Saturday morning. There was patriotic music, a '76 flag (13 stars), papers about the Libertarian stand on gun control and, of course, Ron Paul literature and a video tape.

He walked throughout the hall, introducing himself to exhibitors and talking with people. "Ron's such a good campaigner," says Gail, "he can really get his points across. He just needs a bigger audience."

He was interviewed by two local papers, the *Daily Report* and the *Progress-Bulletin*, both of which presented very thorough write-ups, with Ron quoted at length about the Libertarian views on drugs, foreign policy, the Federal Reserve and the likelihood of a depression. "The recession will come — I think it's most likely to be a depression, you cannot prevent it. But what I think Libertarians can do is bring sense to the system. That is, to explain why it happened and make sure it is very short-lived."

Unfortunately, the interviewers or their editors did not choose to report our concerns about gun control or go into any depth on why we regard the right to own guns such an important right. Strange, considering Ron was visiting a gun

Karl Hess Suffers Heart Attack

Karl Hess, editor of LP News, suffered a massive heart attack while addressing a group of Connecticut Libertarians at a supper club the weekend of July 16. The meeting was being held on the campus of the University of Hartford, so he was rushed directly to the University Hospital where he underwent ten hours of heart surgery. Although the original odds for survival were only 50-50, so far he has beaten those odds. But Karl is by no means out of the woods. Although no longer in intensive care, his condition is still rated very serious. A hospital stay of at least three weeks is expected.

News and Events from the Regions

Update on Call-In Project

Last month *CLNews* announced a planned media call-in campaign, in which Libertarians, on specific days, would call certain newspapers and TV stations and ask that they do really serious covering of the Paul/Marrou campaigns. That project has gone through several permutations, the latest version being that the LPC will form a united front with AIP and Peace and Freedom, requesting that the media in question give better coverage to all third parties. The main target is still the *L.A. Times*, but the call-in date has been postponed till September. Details next issue.

Here and There

RANCHO PALOS VERDES (Los Angeles County): Libertarian Alan Carlan can claim credit for the defeat of a proposed extension of a 5 percent utility tax increase (Proposition H) which had been OKed by the city council in February, 1987, but needed approval of the voters.

Alan, a candidate for city council last November, wrote many letters of opposition to the tax-hike which were published in the two local papers. He also submitted a ballot argument against it, but this was turned down by those that decide such matters in favor of one from a taxpayers group.

Then it happened. A representative from the group, who was scheduled to debate Mayor Jackie Bacharach about this issue on a local public access TV channel, cancelled out at the last minute. With only two hours notice, Alan agreed to step in. Also, a new monthly paper, *The Monitor*, published his rejected ballot argument so it was in the hands of many voters before June 7.

Alan pointed out that the tax costs a family \$100 to \$200 a year, that it is particularly hard on seniors and retired persons, and that the city council had embarked on some very expensive projects. "Perhaps," he suggested, "what the City Council really wants are additional expensive projects, like a brand new City Hall with all the bells and whistles."

On June 7, Rancho Palos Verdes voters showed they agreed with Alan and said no to the tax hike.

SANTA CLARA COUNTY: Local Libertarians have been experimenting with the format of their monthly meeting. They used to have fairly formal dinner meetings, mini-banquets with a speaker — and attendance slumped. So they tried something else, and attendance has climbed. They meet in the back room of Coco's Restaurant, ordering off-the-menu. After that a video tape is shown: Ron Paul's cam-

paign, something taped off the TV. Recently they ran a tape about Jim Hedbor's campaign (the Vermont Libertarian who is running for Congress and may win!). Michael Prah and the IRS

Michael Prah, Libertarian candidate for the 40th Assembly District, pleaded *nolo contendere* (no contest) at a June 30 pre-trial motions hearing. Michael had been charged with four counts of felony tax evasion by the IRS and was scheduled to appear at trial July 5 (See last month's *CLNews*). Michael was urged to plead guilty, but literally minutes before the June 30 hearing his attorney asked him why he refused to file. What were his reasons. He explained his Constitutional arguments, and his attorney told him she could not concur with the guilty plea — she believed him innocent of *willful* failure to file and tax evasion. For a person to plead guilty, the attorney must concur — this was a highly unexpected turn of events.

The judge suggested entering a plea of *nolo contendere*, which seemed the best thing to do. It means that although Michael does not admit guilt he submits to punishment. However, his original arguments and motions will be preserved for his appeal to the Ninth Circuit Court. Sentencing is scheduled for Oct. 3, and Michael faces fines and a possible prison term pending appeal. For more details, call (818) 762-7632.

No Lazy Days This August

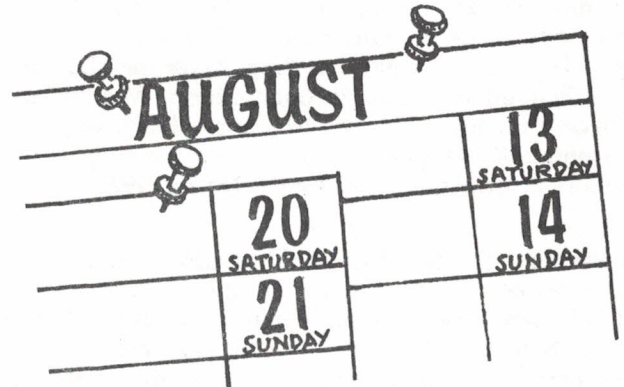

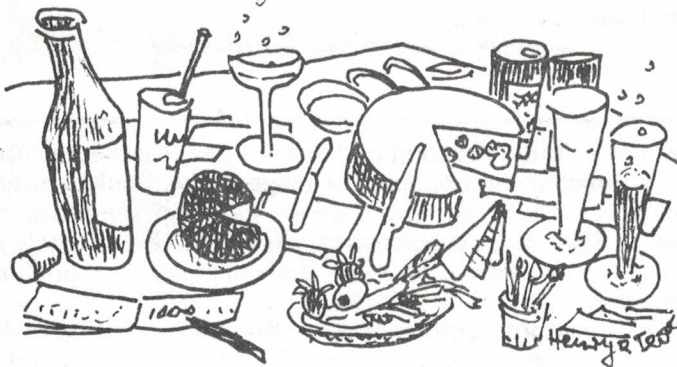

show. Libertarians hold that the right to self-defense is basic, that is the right to defend oneself (by force of arms, if necessary) against any persons who would destroy our other rights to life, liberty and property. We're not talking only about taking care of the occasional rapist on the prowl. In the last analysis, an armed citizenry is the only defense against that all-too-real danger, the state — and even that may not be enough.

ESCONDIDO: Ron is always willing to touch a number of bases when on tour, not only those which have been pre-arranged. So on an earlier visit in June, when he was scheduled to attend a reception in San Diego, he took advantage of the visit to go with San Diego County chair Pat Wright and other local Libertarians to Panchali's, a gay bar in Escondido. Pat knew that Panchali's owner Mary Anne Francis had a problem: without a cabaret license her patrons are not allowed to dance, and the city council has twice denied her the permit.

As reported in the Escondido *Times-Advocate* for June 4, "Bar owner Mary Anne Francis says she's not a Libertarian, but she was enthusiastic about Ron Paul's visit and the attention he is sure to draw to her plight. and commissions, churches and charities (particularly those involved with helping homeless people) to come out in favor of it. So all of you who are in touch with your local governments and civic groups, alert them to the dangers.

Watch Out for Proposition 95

A particularly vicious proposition will be on the November ballot, and you can expect a lot of publicity about it between now and the election. It's called the Housing and Nutritional Assistance Act. Sounds relatively innocuous, doesn't it. Just another welfare measure — more money down the rathole. Right? **DON'T BE FOOLED BY THE TITLE!** This is NOT a simple welfare plan, it is a revenue-raising bill, and although the authors say it's to help the homeless and the hungry, it will fall heaviest on those least able to bear the cost: the poor and the elderly. Its passage will lead to a sharp decrease in the number of affordable apartments and individual homes, particularly in the inner cities and rural areas.

Proposition 95 sets up a public corporation with the power to issue bonds which have not been approved by the voters, thereby adding to the state's bonded indebtedness. The monies from the bond sales will go into two "slush funds:" the California Housing Fund and the Emergency Housing and Nutrition Fund, to finance a new statewide bureaucracy whose job will be to develop various schemes and programs ostensibly to "alleviate hunger" and the housing crisis by providing emergency services and low-income housing.

But bonds must be paid off with interest! The money for the debt repayment will not come from the general fund, but from a new statewide system of fines and penalties supplementing enforcement of existing local housing and food preparation codes. A person charged with code violations would be penalized twice: over and above any fines levied by the city or county for a code violation, he or she would be fined an additional \$250 per offense per day by the state. Moreover, the enforcing agencies and the courts will be under mandate to ensure that a minimum of 50 million dollars per year in penalties is collected statewide. That's a quota system, and it's specified right in the law itself!

If you think this applies only to absentee slumlords of rat-infested tenements, read the fine print of Proposition 95 and the State Housing Code. The owner of any housing structure could be penalized — even if it's his or her own home. Possible offenses listed in the code include broken windows, damp rooms, loose plaster, and "general delapidation or improper maintenance." It doesn't take much to see who would be the

losers when zealous code inspectors start prowling through less affluent, older neighborhoods — particularly when those inspectors have a quota to meet. Low-income property owners in poorer neighborhoods, including seniors on fixed incomes who are owner-occupants, cannot afford double penalties and could lose their homes. Is that any way to solve a housing crisis?!

Libertarians know that the only way to solve the housing shortage is to make it easier for builders to provide low-cost homes and apartments. Elimination of oppressive building codes and nit-picking regulations — that's the goal to work towards, not increased enforcement of these codes.

Obviously, this is a issue for Libertarians and their allies. It must be defeated. Our candidates should speak out loud and clear against it. *CLNews* is not certain yet who is the real force behind this horror, but we have definite leads and are checking them out.

Meanwhile — and this is urgent — proponents have been soliciting city councils, county supervisors, various boards
