## Paul Salander's Campaign Picks Up Steam

### Best shot for Libertarian to win in Illinois

The campaign for Libertarian Paul Salander, candidate for state representative in the 76th district, has been increasing with great significance. Over the summer he was in several parades which spanned the district. Other LP members showed their support by attending and participating in the various functions. More recently, Paul has been invited to do interviews for the radio and newspapers. He also has been present at luncheons, as well as a forum with the other candidates which aired live on the local cable channel in Ottawa, the largest city in the district.

The district is becoming more and more aware of Paul, his ideas and goals. On September 19th—a sign painting party was held at the home of John T. Wilson. Now, the billboard size signs can be seen in high traffic areas throughout the district. In addition, Paul purchased 100 reusable professional signs containing the Statue of Liberty. These are being displayed in local businesses and yards of supporters. In some of the businesses, the Salander for State Rep. signs replaced those of his opponents.

There is reason to believe the Republican Party has stopped funding their candidate's campaign. Lloyd Chapman's coverage has decreased to a near stand still and signs in his local business have disappeared. The polling reports show Paul Salander is gaining support apparently at the expense of Chapman.

The campaign will continue to increase until the last day—November 3rd. At present, the campaign expense is currently \$1300.00 Any contributions would be greatly appreciated and put to good use. ## Dr. Michael Rosing Running Active Campaign

Michael Rosing running in the 41st district for state senator is on the campaign trail and reports excellent press coverage. Dr. Mike and his colleagues from the Illinois Marijuana Initiative have already handed out over 5000 flyers in his district, which covers the south part of Downers Grove, Westmont, Darien, Bolingbrook, and Lemont. Also, Mike recently talked to a group at Argonne National Laboratory, where he works, and was received warmly with quite a few libertarians in the audience.

## Andre Marrou and Kenneth Prazak Endorsed by Tax Accountability '92

Andre Marrou the Libertarian Party presidential candidate and Kenneth Prazak the Libertarian Party candidate for state senate in the 20th district (Downers Grove, Lisle, Naperville, Glen Ellyn, and Wheaton) have been endorsed by Tax Accountability '92, the political action arm of National Taxpayers United of Illinois, an affiliate of the National Taxpayers Union.

To qualify, Andre and Kenneth took the Illinois Taxpayers Protection Pledge, declaring any opposition to and pledging to vote against any and all efforts to increase taxes.

They support the Tax Accountability Amendment, which would make it tougher to raise state taxes. Signed by half a million taxpayers, the tax Accountability Amendment is supported by 77% of the citizens of Illinois. Prazak obtained 5,000 signatures on his own during the Tax Accountability Amendment petition drive.

They also support the Tax Freedom Act, which will roll back and cap property taxes and other local taxes at 1988 levels, or will freeze all local taxes and user fees at the current amount, whichever is less.

"Confiscatory taxation and related spending is ruining this country, and unfortunately Illinois is a leader in taxing its citizens. As a child in the government school system, I was informed of how terrible it was that the serfs had to give up 25% of their income to their landlords in the Middle Ages. The average American pays close to 50% of his or her income in taxation per year. If 25% taxation makes people serfs, what does one call a person who pays up to 50% of his or her income—a semi-slave?"

## Moive Review

### Zentropa

**Fascism:** (American Heritage Dictionary of the English Language) a single party system of government that allows private ownership, manipulates the economy typically through the merger of government and business leaders, enforcing their rules using secret or military police

Zentropa is the name of a Danish-made film (dubbed in English) that ran at the Fine Arts Theatre on South Michigan Avenue in Chicago in September. It is also the name of the "private" railroad company that efficiently shipped Hitler's undesirables to the death camps. After the surrender to the Allies, the railroad accommodated high-ranking American officers who were manipulating their own little private economies, power-trips, and sexual fantasies. Before the Americans, it was high-ranking German officers.

Hey, Why not? Anything for a buck! Right?

The narration of Max Von Sydow takes you through this surreal story of a young German-American pacifist, Leo Kessler, who comes home to Germany to work as a sleeping car conductor referred by his dad's brother who has worked for Zentropa for years. Leo's father had fled Germany in the early thirties.

The movie weaves through intrigue, sub-plots and a "different" sex scene. What happens during the movie and at the end is not the point of this review.

Leo is a libertarian idealist who merely wants to live and love and let others live and love. He has thrust himself into a den of interventionist men-in-power who corrupt, twist, and pervert everything around them for their own personal gain (like being at the Democratic or Republican party conventions).

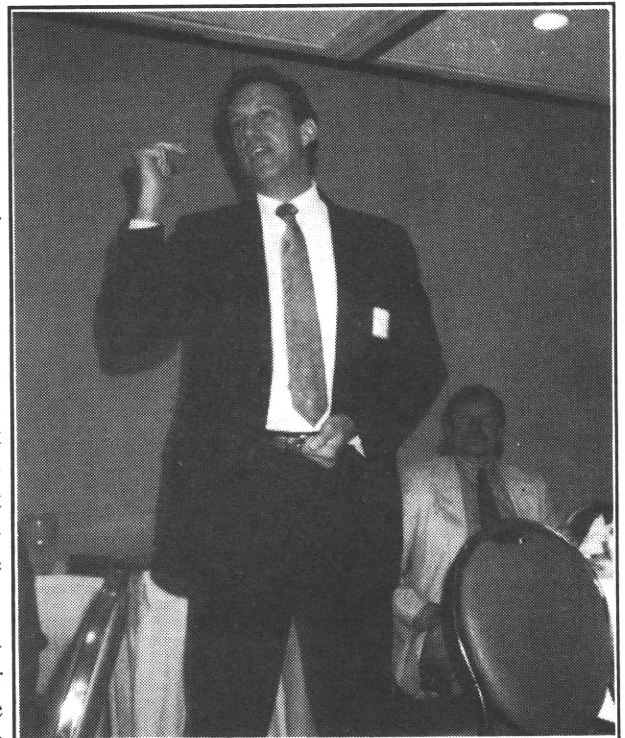
One could equate this movie with Graham Green's "The Third Man." An American coming to an occupied country after armistice, seeking a job, wanting to just live and let live, falling in love with a woman who loves someone or something else, while being surrounded by a host of maniacs.

I highly recommend this movie to any of my fellow libertarians especially those who like art films. This movie is not so much about anti-Nazism or anti-Ally occupation but about authoritarianism and interventionism and what people will do to survive.

Another film about interventionists is "Inner Circle" that is now out in the video stores. This movie is about Joseph Stalin's personal movie projectionist inside the Kremlin played by Tom Hulce (Amadeus).

"Inner Circle" shows us the personal life (if you can call it that) of the projectionist and the inner circle of Stalin and his political hacks designing and engineering their perfect society.

Try to watch both of these films back-to-back as close as possible to get the full flavor of left-wing and right-wing totalitarianism, authoritarianism, and interventionism.

### The choice is easy for local Libertarians

Inverness resident Bob Franke says George Bush and Bill Clinton are both liars. But Franke said he trusts the presidential candidate he plans to vote for—Andre Marrou.

Marrou is not exactly a household name, but he's the presidential candidate for the United States' third largest party, the Libertarians.

When Pioneer Press brought together 10 northwest suburban residents last week to discuss the presidential election, two of them happened to be Libertarians.

"I see no appreciable difference between the Democrats and the Republicans," Franke said. "They have lied to us all along and I think it's a joke."

Franke said he was a Republican voter for many years until he became a Libertarian in 1988. He voted for Patrick Buchanan in the GOP primary in March, but he said he will vote for Marrou in November.

Another local Libertarian, Schaumburg resident Neal Reynolds, voted for Buchanan in March. He, too, plans to vote for Marrou.

Reynolds said he believes the Libertarian Party's philosophy that government should have a minimal role in people's lives.

...Schaumburg Republican Gary Peltier said, "I would not vote for a third-party candidate, because we have a two-party system, and it would be throwing away a vote."

However, Franke said the surge of Perot's popularity earlier this year showed that people want an alternative to the two-party system.

"This fiction that Democrats and Republicans keep turning out that one party is more fiscally responsible than the other is a joke," Franke said.

Franke said he sees liberal bias in the media, and he criticized the press for failing to cover third-party candidates like Libertarians.

"On a level playing field, a Libertarian third-party candidate could win," he said.

"I don't think you can blame the media for focusing on these sleazy issues," Reynolds said. "The candidates have forced it by being too similar on issues."

**Fostering ideas**

Chicago—The Department of Children and Family Services plan to recruit AFDC mothers as foster parents for abused children is a bad idea. It is bad for the children, bad for the AFDC mothers, and bad for the taxpayers.

The financial problems of AFDC mothers are often compounded by multiple social problems. In a study recently published in American Behavioral Scientist, sociologists found the single variable that was the strongest predictor of child and adolescent risk for problems in health and development was the rate of births to unmarried mothers.

AFDC mothers need to avail themselves of every possible opportunity for education and job training. Their top priority, after caring for their children, should be to get into the work force as

soon as possible so they can make a better life for themselves and their children and can stop living at public expense. Increasing their family responsibilities, whether by having more children of their own or by taking in foster children, will only be an impediment to this process.

The proposed \$200 per month rent subsidy will be an added state expenditure since this is a benefit not previously being paid to foster parents. Furthermore, having an extra \$200 a month in spendable income may give many AFDC mothers a false sense of security which will make the goal of eventual self-sufficiency seem less urgent. None of this is good for Illinois' already overburdened taxpayers.

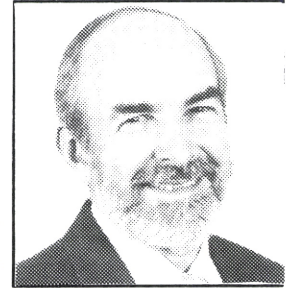

In 1984, Andre Marrou was elected to the Alaska state legislature. As an elected Libertarian legislator, Marrou fought government growth. Voting against every new tax and every tax increase, he was also instrumental in the successful initiative that abolished the Alaska state income tax. In addition, he co-sponsored and spearheaded the successful Alaska initiative that deregulated transportation services.

In office, Marrou was called “the conscience of the legislature,” according to Terry Martin, Republican minority leader of the state House of Representatives. “Andre has a revolutionary spirit...he can't get liberty off his mind.” When asked the source of his legislative success, Marrou replied, “One elected Libertarian goes a long way.”

Marrou was the 1988 Libertarian Vice-Presidential nominee and running mate of Congressman Ron Paul. During this time he campaigned in all 50 states plus D.C. and was interviewed by over 1000 television, radio and newspaper reporters.

Andre's major goal if elected president is to repeal the federal income tax and abolish the IRS. In conjunction with this, he would lower spending by one-third in four years through attrition. Another goal is to establish sunset legislation on all regulations, sharply reducing regulation by the federal government. Andre believes we can restore individual freedom and individual responsibility in this country by the year 2000, his projected date when the Libertarian Party will be the dominant party in this country.

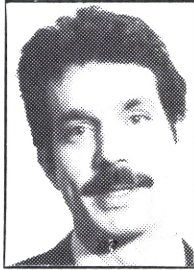




## Blaise Grenke for U.S. Congress 5th Congressional District

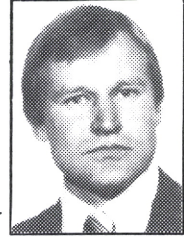

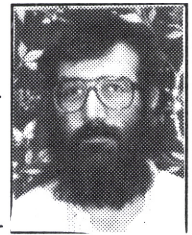

## Libertarianism in One Lesson

Perhaps the most common question put to Libertarian Party (LP) candidates is: "What is libertarianism?" Or, What does the LP stand for?"

First, let's avoid some common errors and confusion by stating what libertarianism is not. It is NOT some variant of liberalism or conservatism. It is NOT a combination of left and right positions. That spectrum does not admit the idea that all people have the right to control their own lives, in all respects, and the obligation to take responsibility for themselves and their own actions. Liberals and conservatives agree that the rest of us are evil or incompetent or both and must therefore be controlled by government. They differ only on which aspects of our lives should be controlled most.

By contrast, Libertarians hold that each person has the absolute right of self-ownership over his or her life, body, speech, action and honestly acquired property. Each has the obligation to respect those same rights in each other person. The proper way for people to deal with each other is by mutual respect for each other's right of self-ownership. Anything that is peaceful, voluntary and honest violates no rights and thus is not a proper subject for governmental intervention.

Law enforcement's only proper function is to assist us in defending our rights. The only proper laws are those which penalize such conduct as murder, rape, kidnapping, robbery, burglary, arson, trespass, pollution and fraud. On an international scale, the U.S. armed forces should be confined to providing security against foreign attack on American shores. They should not be used in foreign wars.

Libertarianism is the philosophy of the Declaration of Independence and the American Revolution. Most people, most of the time, deal with each other on the libertarian basis of mutual respect. Two groups don't: **criminals and government**. Libertarians challenge the notion that government can legitimately coerce the rest of us through taxation, regulation, conscription and criminal penalties imposed upon peaceful, voluntary conduct. We demand that laws be limited to their proper functions and that government personnel be held to the same standard of respect for our rights that the rest of us follow.

The Libertarian Party is for all people who do not want to be controlled and who do not want to control others. On all issues we will support increased personal liberty and reduced government control. We know that a free society is possible and that it is practical. We are committed to work for as long as it may take to achieve it.

As the youngest township supervisor in Illinois, Paul administers all township payrolls and township funds and is the local liaison to the state treasurer's office. He has enacted numerous reforms that save taxpayers' money. He has reduced expenses, streamlined accounting procedures, and reduced insurance costs by 18%. Paul has proposed an ongoing strategy to reduce township taxes by 50%.

"I would push to enact a state property rights code that would protect the owner from arbitrary zoning laws so that he is free to do with his property what he wishes as long as he doesn't interfere with those same rights of his neighbors."

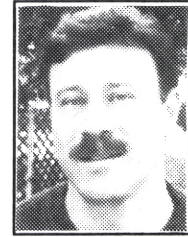

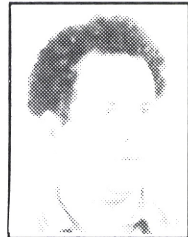

## DEFEAT BERMAN TAX INCREASE AMENDMENT

An amendment to the Constitution of the State of Illinois has been proposed by State Senator Arthur Berman, and will be on the ballot for your approval in November.

This amendment has been misleadingly titled the "Education Amendment" by the media, politicians, and the education bureaucracy. Opponents of the measure have more appropriately named it the "Berman Tax Scam".

This amendment would require the State to fund every school district in Illinois with 50% plus \$1.00 of the cost of a "high-quality" education, whatever that might be.

The amendment makes no mention of the increases in state taxes that will be needed to provide this money. It also does not require local property taxes be reduced to compensate for the increase in state funds that local school districts receive.

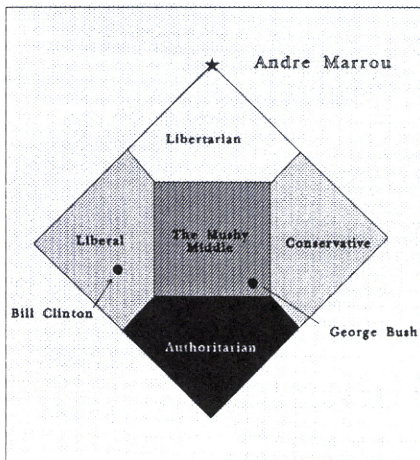
The supporters admit that at least \$1.5 billion dollars of new state revenues will be needed. Opponents

say it will be more like \$3 billion. This would mean a **50% increase in state income tax**, a large increase in the sales tax, or perhaps even re-establishment of the state property tax.

Of course, some people will support this amendment in the misinformed belief that more money will solve our educational problems. The truth is, we are spending more than ever on education. Illinois educational spending per student has increased 57% (adjusted for inflation) over the last 20 years.

On average, public education costs twice as much as private schooling, for much lower achievement. Nationwide, there are 129 education bureaucrats for every 100 teachers in public schools. In Chicago, public school enrollment dropped 30% in the last ten years while school board employment rose 14%.

**Spending more money on bureaucrats buys more bureaucracy, not better education. Vote against the Berman Amendment.**

"Right now those who cannot afford to attend college are still forced to pay taxes to support those who are well off. This would end the unjust burden on the poor, and ensure that those who benefit from higher education are the ones who pay for it."

**THE MYTH OF "WASTING YOUR VOTE"**

Politicians, journalists, and other supporters of the incumbent parties tell you that voting for anybody except the Democrats and the Republicans is wasting your vote. The truth is, there are many practical reasons to vote for the candidate and ideas you believe in, regardless of whether the news media says your candidate can win. The history of both of the current incumbent parties proves that voting for minor parties can and does make a difference.

The United States has always settled back into a two-party system after periods of social and political turmoil, but often not with the same two parties as before. **In the Presidential election of 1856, the Republican Party came in fourth place.** Their candidate, John Fremont, managed about 5% of the vote. **In 1860, Abraham Lincoln was elected president,** leading to decades of Republican political domination.

For forty years after Lincoln's election, the new Republican Party was the driving force of government. At first the Republicans were agents of change, but by the early years of the twentieth century, they had become the reactionary establishment party, maintaining the status quo on behalf of the rich and powerful.

By the late 1920s, the economic situation had become critical. As the United States went into the Great Depression, voters began looking for new answers. **The Democrats responded. They kept the same name but were not the same party after the 1930s.**

In the 1928 presidential election the Socialist Party won 7% of the vote. By 1932, the Democrats had adopted the most popular planks of the Socialist platform. Since then, every plank of the 1928 Socialist platform has been adopted by the Democrats. Even some of the most conservative Republicans no longer question many Socialist-inspired programs such as Social Security and Unemployment Insurance.

The Democrats won the following 8 presidential elections, and have had control of Congress for the last sixty years, except for two years during Eisenhower's first term. The bureaucracy, and the news and entertain-

ment media overwhelmingly support the goals and policies of the Democratic Party.

The Democrats have now become "the establishment party", determined to expand their grip on power and prevent any changes except for more power.

The United States is now experiencing a period of intense change, re-assessment, and turmoil. **The established policies aren't working and the established parties offer only more of the same.** The two established parties will not be the source of the new thinking we need to deal with the challenges of a new age.

The United States may have a stable, two-party system sometime in the 21st century. Without a doubt though, they will have either different names, or their guiding principles will be radically different than the two we have now.

The Libertarian Party can reverse the growth of government, taxes, and the erosion of our liberty. We don't even have to win office in government. All we need is to become a credible threat to the established political parties and they'll steal our platform. That is a theft we will gladly live with.

In Illinois, a new political party has to win 5% of the vote in a statewide election in order to qualify as a political party, and be automatically listed on the ballot in the next election.

That is the hurdle the Libertarian Party of Illinois needs to clear before we can run a winning campaign. The money we had to spend on our ballot petition drive this year could have paid for one million pamphlets, over 100 local TV commercials, or over 200 radio ads. This would have raised enough money for a winnable campaign.

**It will not really matter whether the Democrat or the Republican candidate wins any office in the current election.** No matter which major-party candidate wins, we will all suffer higher taxes and more government interference in our lives. If we are to survive as a nation, the political debate must be expanded to in-

clude individual responsibility and personal liberty. This will not happen until the Libertarian Party becomes a serious contender for political office.

If voters would support the candidate they believe in instead of limiting themselves to voting for candidates they think can win, more Libertarians and other alternative candidates would get elected.

In 1982, the Libertarian candidate for Governor of Alaska had a survey taken two weeks before the election. Voters were asked who they were going to vote for, and who they would vote for if they thought all three candidates had an equal chance of winning. The answers to the first question were very close to the actual votes. 16% of the voters polled said they were going to vote for the Libertarian candidate. Two weeks later, the Libertarian got 15.7% of the vote. When asked who they would vote for if they thought any candidate could win, **the Libertarian candidate won!** If the voters of Alaska had voted for the candidate they agreed with instead of voting for a candidate they thought could win, the first Libertarian Governor would have been elected ten years ago.

The only opinion poll that really counts is on November 3rd this year. Be sure that the people who do get elected hear *your* opinion.

**If you vote for either of the incumbent parties, you are telling them that you like the way they have been running things.** You are telling them you want higher taxes and more government. You are telling them that you like lies, deception, arrogance and corruption.

If you vote for Libertarian candidates, you are telling them that you want *real* change. **You are helping us gain automatic ballot status so we can campaign to win in future elections.**

Politics is played on the margin. Your vote for Libertarian candidates will make a bigger difference than any other vote you can cast this year.



# Privatization Comes to Bosnia

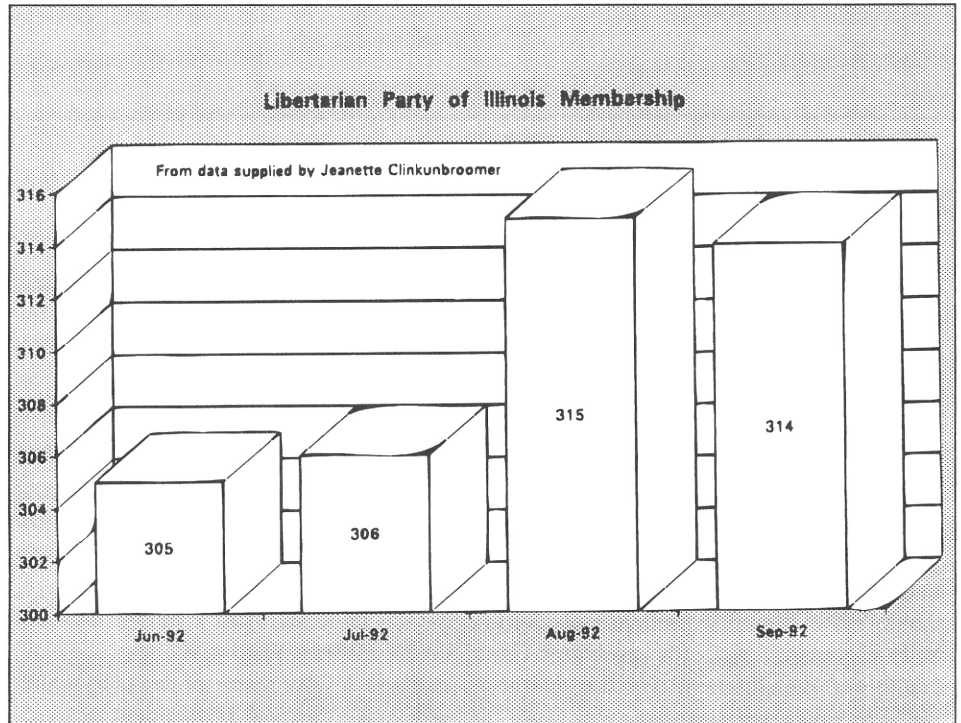
