### **CAMPUS ORGANIZING**

### **University of Virginia:**

Students for Individual Liberty (S.I.L.), the oldest and largest of the Liberty Coalition groups, will sponsor several speakers during the spring semester, including Philip Van Cleave (Virginia Citizens Defense League), Peter Ferrara (Americans for Tax Reform), and Chad Thevenot (Criminal Justice Policy Foundation). In addition, we shall probably show the film "Waco: The Rules of Engagement."

University Libertarians will concentrate during the spring semester on helping with the LPVA ballot access effort. UL members will also assist the Jefferson Area Libertarians with the various efforts of the J.A.L.

In late November, I prepared an invited article entitled "A Libertarian's Foreign Policy Wish List" for the U.Va. publication *Hoo Knows*. I have been invited to participate in a "Diversity and U.Va. Admissions" panel discussion on Feb. 9, and to discuss Libertarian ideas during the "Tuttle Tuesdays" lecture series at U.Va. on March 28.

#### Other Campuses:

We have Libertarian contacts this year at Radford University, James Madison University, Virginia Tech, Mary Washington College, William and Mary, Old Dominion University, and Washington and Lee. On Dec. 16, I spoke to three law students from William and Mary who attended my speech to the Peninsula Libertarians club in Hampton. They wish to build a Libertarian club at William and Mary. During the next weeks, I am planning to contact all of our campus activists to enlist their help with the ballot access effort, and to lay the foundation for the "Reams for Senate" campaign on college campuses. I shall endeavor to visit several colleges during the spring to assist with the ballot access effort and the Reams campaign. I also wish to prepare a coordinated petitioning/outreach effort to high school students.

### **JEFFERSON AREA LIBERTARIANS**

November 1999: J.A.L. members Jim Lark and Gary Westmoreland assisted candidates in other parts of the state. Dr. Lark and Mr. Westmoreland continued their effort to monitor the activities of local politicians, planning commissions, and other governmental agencies.

December 1999: The sixth issue (in 1999) of the J.A.L. News was published. On December 15, Greg Cunningham, Jim Lark, Gerhard Schoenthal, and Gary Westmoreland held a "Bill of Rights Day" celebration in front of the Federal Building in downtown Charlottesville. They distributed literature about the J.A.L. and LP. exhibited signs, which provided information about the Bill of Rights and the LP, and read aloud the Bill of Rights. Dr. Lark distributed a press release about the event to local media. The Daily Progress mentioned the event in its Dec. 15 issue. WINA radio interviewed Dr. Lark at the celebration and ran the interview at various times (including an airing on Jan. 3, 2000). Note: J.A.L. member Nancy Howell deserves special mention for her work in helping to plan the celebration.

January 2000: On Jan. 10, the J.A.L. held a business meeting at the Golden Corral restaurant in Charlottesville. The major item on the agenda list concerned activities during 2000, with emphasis on the ballot access drive and the Reams for Senate campaign. A goal of 2000 signatures gathered by J.A.L. area members has been set. ("2000 in 2000.") In addition, the J.A.L. has established an ambitious list of outreach activities during the coming year.

Gary Westmoreland attended the Jan. 12 meeting of the Albemarle County Board of Supervisors and spoke against the proposed purchase of "conservation easements" by the county. Mr. Westmoreland's comments were used in a news story by WINA radio.

#### Three's the Charm

Having tried twice before to get published, Joe Cadrin was elated when Amy from the Daily Press asked him if the Hampton Roads daily could publish his Letter to the Editor. The Letter, published on January 20, 2000, criticized the Federal Election Commission's new criteria for candidate inclusion in the televised presidential debates.

### Thank You, Candidate Allen

Former Governor and U.S. Senatorial candidate George Allen inadvertently raised interest in the Libertarian booth at Talk Fest 2000 when he failed to answer a question specifically. During his "First Town Meeting", Allen was asked: "You mentioned your desire to reduce taxes. Which specific areas of government spending-and I don't mean giving tax credits--would you cut by introducing legislation?" Following the candidate's vague response, several attendees looked for the Libertarian booth. Talk Fest 2000 is an annual event during which nationally syndicated talk show hosts broadcast live from the Tidewater Area. Ken Hamblin. The Black Avenger, joined local talk show host, Tony Macrini. attracting crowds to the Chesapeake Conference Center. Libertarians Greg Lloyd from Richmond and Richard Braun from the Southside Club joined Peninsula Club members James Hicks, Greg Goy, Steve Stahl, and Joe Cadrin to give the World's Smallest Political Quiz to scores of attendees. Fighting fatigue during their twelve-hour shift, volunteers were reenergized when talk show host Tony Macrini mentioned the presence of the Libertarian Party several times on the air.

be able to vote "Libertarian" for the two highest offices in this year's election. And remember that submission of just these few signatures will qualify you for a drawing of a new DVD player (drawing will take place at our State Convention in May). So, PLEASE do your share!

As soon as the weather warms up we will begin collecting larger numbers of signatures at stores, libraries, DMVs, etc. (Of course, if each and every one of you "does your share" before then, this will be unnecessary!) If you can help with the petitioning effort, or if you are available to serve as a petitioning coordinator for your area (coordinators will be scheduling petitioners and places to petition), please contact me.

On the legislative front, we failed to find a State Senator to introduce another Party Petition Bill in the VA General Assembly this year. Delegate Callahan also refused to re-introduce one since it would waste his time to get it through the House a second time without support on the Senate side. We will need to build public pressure to get the Senate to act on this issue.

Delegate Marshall has introduced House Bill (HB) 807, which is one of several Party Labeling of Ballots bills. This is the only one that supports labels for unrecognized parties. Please call the Legislative Hotline (800-889-0229; in Richmond 225-4973) and ask your representatives to support HB 807 and NO OTHER PARTY LABELING BILL. Also, please send a "thank you" to Delegate Robert G. Marshall for introducing it (House of Delegates, POB 406, Richmond, VA 23218).

### The rich get richer, the poor ... pay Social Security tax

It came as no great surprise when two Washington think tanks -- the Economic Policy Institute and the Center on Budget and Priorities-- reported this week that the gap between America's haves and have-nots has expanded in the past decade, with the earnings of the poorest fifth creeping up only 1 percent, while fat-cat income has jumped 15 percent.



"The benefits of this booming economy are not being evenly distributed," and Jared Bernstein, economist at the Economic Policy Institute.

The main questions should be: Is this evil, and should government do anything about it?

In fact, even the report's authors concede: "In the last few years, persistent low unemployment and increases in the minimum wage have fueled wage gains at the bottom. As a result, there has been a lessening of wage inequality between the bottom and the top, although the gap between middle- and high-wage workers continues to grow."

Nonetheless, the redistributionists predictably intone in this report that "As the administration and financing of government programs continue to be shifted from the federal to the state level, state policy-makers must be prepared to shoulder additional responsibilities for pushing back against growing income inequality."

What the states should do, according to the analysts, is continue to raise the minimum wage; "implement a wide range of supports for low-income working families"; and, of course "reform regressive state tax systems" -- raise taxes on the rich.

There are a few problems with this prescription.

First, the poor are not worse off in America than they have been. America's "poor" would be considered

wealthy anywhere else in the world. The statistics used in these studies don't even count non-cash government benefits to the "poor," like Food Stamps or Medicaid. The Cato Institute reports America's poor people manage to spend a dollar and a half for every dollar these government statistics claim they have.

More importantly: If sharecroppers in the 1920s saw their incomes tripled when they moved to Detroit and went to work building cars for Henry Ford, but Mr. Ford's own personal income jumped by a factor of 100 in the same decade, who did that hurt? Would anyone (other than the bureaucrats) have been better off had government stepped in immediately with punitive taxes to impoverish the Ford family -- even if the result had been cutbacks and layoffs at the factories?

Third, many "rich" families were actually in the "poorest fifth" a few decades ago. Then struggling college kids, they are now two-income couples at the top of their income potential -- doctors, lawyers, executives and airline pilots. Is it really right to try and "redistribute" their wealth to the young, the indolent, or those who decided to drop out of school to bear illegitimate children, at just the time in their lives when these high wage earners are finally educating the children they waited for, and trying to invest for their own retirements?

Finally, there's the question of whether policies advanced by outfits like the Economic Policy Institute and the Center on Budget and Priorities have actually contributed to this perceived "problem."

"I find there's a great deal of irony here," explains Michael Tanner of the Cato Institute.

"It's true that wealth is moving into fewer and fewer hands. We are in a society where about one fifth of the society holds about half of all the wealth. But these two groups (that issued the report) are the most active in fighting the remedy ... which is primarily Social Security privatization.

"The real reason for the wealth gap is that the wealthy can invest, and the poor can't," Mr. Tanner explains. The poor are "left with 12 and a half percent going into the Social Security program, which has a negative return and leaves them nothing to invest anywhere that will generate real wealth."

Martin Feldstein at Harvard has estimated privatizing Social Security would cut the "wealth gap" about in half, Mr. Tanner reports.

"We still have one of the most mobile societies in terms as moving from rich and poor, and vice versa. In 10 years, 14 percent of the poor will still be poor, and 14 percent will be rich. It's just that wages are becoming progressively less important; we have to create opportunities to invest," Mr. Tanner concludes.

Which means freeing the poor from the Social Security Ponzi scheme -- often the single biggest tax they pay.

As mundane as it may sound, incomes are still generally a factor of job skills and early life decisions. The best way to become financially secure in life is to complete one's education, get a job, and marry before having children. If state governments instead follow these analysts' advice and intervene with ever more redistributionist tax schemes -- removing both the incentives for those who work hard, and the real-world disincentives and penalties for those who indulge deadend behaviors -- who do we really think that's going to help?
