LP may help develop legislation

s President Bill Clinton's health care plan continues to free-fall in public opinion polls, the Libertarian Party's free market proposals made some remarkable gains in February—including, for the first time, the possibility that Libertarian experts may be invited to help craft health care legislation.

The Project Healthy Choice scorecard for the past month includes one debate victory, a possible invitation to meet with a congressman in Washington, a private meeting with another congressman to explain the Libertarian proposals, and a Libertarian protest against the Clinton plan that earned front-page newspaper coverage.

The good news started in Oregon, with the health care debate between former LP state chair Paul Smith, MD, and liberal Democratic Congressman Don Wyden. The debate took place in Clackamass County on Feb. 17, and was sponsored by the local Chamber of Commerce.

"It went well," said Smith of his successful debating effort. "I had the congressman on the defensive most of the time." According to news reports, Smith said the Clinton plan would "have the federal government calling the shots, raising millions of dollars in new taxes, and dictating what

kind of health benefits Americans can receive."

Smith urged the audience to "just say no—no to more taxes... we need to tell them 'Go balance your budget and leave us alone.' We don't need a top-down program run by Queen Hillary [Clinton]."

Congressman Wyden was forced to agree that the Clinton plan had flaws, and said he could not "fully support" it.

LP scores more victories in NH

Libertarian Party members in New Hampshire once again showed why they lead the nation in LP office-holders.

Local town elections were held throughout the state on March 8 and the LP fielded candidates in at least five races. One new Libertarian was elected, two current officeholders were re-elected, and one current officeholder was elected to a higher office. Additional election results were not available at press time.

The new officeholder is John Drabinowicz of Hudson, who received 887 votes for budget committee. The race was uncontested.

In Dunbarton, Scott Ives was elected town selectman with 51 percent of the vote in a two-way race. Ives currently holds the office of school board clerk, but the election to town selectman is several "steps up the political ladder," according to Jim McClarin, editor of "Libertarian Lines," the newsletter of the state LP.

Howard Wilson, a former LP state chair, was reelected town selectman in Andover. Wilson received 55 percent of the vote in a two-way race.

In Litchfield, Cecil Williams was re-elected town selectman. Williams won with 52 percent of the vote.

Cliff Barry, an LP member who has been active in his local taxpayers' organization, finished third in a three-way race for Derry town council.

Libertarian Danielle Donovan also ran in a special election for state representative in Goffstown. Donovan finished third in a three-way race.

"We were pleased with the results," said McClarin.

Land grab?

LP in MD challenges Block raid

When Earle Pearce, vice chair of the Baltimore City Libertarian Party in charge of media and public relations, reported for work on the morning of Jan. 15, 1994, he thought a hurricane had just visited the place.

Pearce works as a janitor in two lounges on "The Block," an area of downtown Baltimore that has been the city's center for adult entertainment since the 1920s. Effectively, The Block had just been hit by a human hurricane.


Four months of undercover work had culminated in a massive raid of the two block area adjacent to city police headquarters. Assisted by the National Guard, 500 state troopers—nearly one-third of the entire state police force—descended on The Block's 24 clubs and made 52 arrests for gambling, prostitution, narcotics, and weapons violations. Rented moving trucks stood by to haul away gambling equipment, such as video poker machines. Maryland Governor William Donald Schaefer was on hand to observe the police action and make comments to the press.

By a happy coincidence, the Freedom Forum, a monthly gathering of Baltimore area Libertarians and Libertarian sympathizers, was scheduled to meet the next night in the living room of LP state chair Lorenzo Gaztanaga.

Pearce held the group of 15-20 forum attendees spell-bound as he described how the police had entered each night club and made everyone lie face down on the floor, at which time they were handcuffed, tagged, and left lying there for an hour or more. The dancers lay on the floor virtually naked, as there was no time to put on so much as a robe. Doormen had to endure freezing temperatures, handcuffed face down on the sidewalk.

Pearce passed around samples of the disposable plastic handcuffs and tags used in the raid, and he challenged his listeners to respond actively to this heavy-handed show of government force. "Are we just living room Libertarians, or are we actually going to do something?" he asked.

The next day, six or more Libertarians called in to three different radio talk shows with comments about the raid.

Baltimore City LP chair Doug McNeil, Lorenzo Gaztanaga, and state LP secretary Susan Gaztanaga wrote letters to *The Baltimore Sun*. Fliers, petitions, and posters were prepared for a demonstration to take place after work on Jan. 24, a date chosen to coincide with a city council meeting.

A group of activists from Prince George's County and members of two newly-formed Libertarian groups at the University of Maryland and Price George's Community College joined with Baltimore Libertarians in a "Rally for

Libertarian political party forms in South Africa

The new Federal Party was recently founded and registered in South Africa by international libertarian superstar Frances Kendall of Johannesburg.

Frances Kendall, advisory board member of the International Society for Individual Liberty, author, political analyst, public speaker, businesswoman, and Nobel Peace Prize nominee, registered the newly formed Federal Party for South Africa's national election.

Kendall said the Federal Party's goal is to elect members to Parliament who will work for a strong federalist constitution that will decentralize power, uphold individual liberty, and promote economic

"What sets us apart from other parties is that we don't want to control people's lives," Kendall said. "We want a constitution that ensures that people have control over their own lives through maximum devolution of power-not only to regions, but also to local communities and residents' associaright to veto any legislation.'

The Realists Party and the Wes-Caap have joined the Federal Party to fight the addition, negotiations are still in progress with other registered parties and non-party

Kendall believes the reason for this surge in support is that "The Federal Party takes a very strong stand on community empowerment. Smaller groups feel they have been overlooked by the other centrally oriented parties, and are very concerned that they should have a voice in Parliament.'

Talking points

A look at the hot issues: crime, guns, and drugs

Cliches and uninformed statements are easy to dismiss as senseless prescriptions from political outcasts and fringe ideologues. Libertarian advocates—be they candidates, state officers, speakers, pamphlet writers, or other spokespersons—may gain credibility for Libertarian ideas by presenting facts and quoting expert opinion that bolster LP positions. This column will provide the ammunition you can use to confound the skeptics and impress those searching for answers by citing mainstream publications and recognized opinion leaders (for and against individual liberty). Send in your submissions, with a clipping to verify the statement and the source, for inclusion in future issues of the NEWS.

This month we concentrate on three related "hot" issues that the American people are thinking about: Crime, Guns, and Drugs.

Issue: Crime

The last time I read a civics textbook, it seemed that fighting crime and the administration of justice were always the numberone reasons given why government exists and is necessary. So just how important is its number-one job to the people who run our government?

"Even though crime has long been a leading public concern, barely a half percent of every government dollar (federal, state, and local) goes to keeping convicted criminals behind bars, and just over three-cents goes to all criminal justice activities (cops, courts, and corrections). Indeed, American taxpayers spend about seven times more on transportation, 12 times more on public welfare programs, and 27 times more on education and libraries than they do on prison and jails."

John J. DiIulio, Jr., professor of politics and public affairs, Princeton University, in Wall Street Journal, Jan. 26, 1994.

Slightly different statistics, but just as compelling:

"Police, courts, and prisons account for only six percent of state and local government expenditures and less than one percent of the federal budget. Special interests that demand agricultural supports, entitlements, and other programs dominate such a large share of government budgets that little is left over for such essential services as crime control, which affects everyone."

And what is government's role in creating crime in the first place?

"(The people committing heinous offenses) simply don't know right from wrong. In a government that teaches abdication of all responsibilities—that encourages people to sue whenever they are not satisfied with the outcome, no matter how justified crime will continue to flourish. Of course we want the crime bill to succeed. But if the Libertarian talking points

government spends more money for police and jails, while continuing to break down the barriers of individual responsibility, the result will be nothing more than another government boondoggle with our

Issue: Guns

Many commentators and politicians favor going beyond the Brady Bill to lengthen so-called waiting periods before a citizen may purchase a handgun. How effective are such "waiting periods?"

"In Illinois, after a 30-day waiting period was installed, that state experienced a 31 percent increase in violent crime and a 36 percent increase in the homicide rate. And, a handgun ban in Washington, DC, has made it the murder capital of the world! The results are in. Gun control makes the street safe for violent criminals. It disarms their victims—you and me. The people's right to protect themselves should be restored, not restricted."

"(I)t is California's experience that puts the waiting period argument to rest. California has had a waiting period requirement since 1923 and has regularly increased its length—from one day to three in 1955, to five days in 1965, and to 15 days in 1975. But as a study has revealed, while waiting periods were increasing so were murder rates, from two per 100,000 in 1952, to 10 by 1975... The president, Congress, and state legislatures are constitutionally prevented from infringing on our right to bear arms, and a look at the statistics makes one question why they would want to anyway, since gun control hasn't worked where it has been tried. It is an authoritarian step in the wrong direction and a convenient distraction for people who don't want to deal with the real issues of removing from the streets the people who commit the crimes."

"Strict gun laws are about as effective as strict drug laws. The drugs flow and so does the supply of weapons. It pains me to say this, but the NRA seems to be right. The cities and states that have the toughest gun laws have the most murder and mayhem. Just as junkies find drugs, criminals find weapons. And I haven't the faintest idea how to prevent it. And now we've reached the point where most law-abiding gun owners believe that they need their guns because of all the artillery that is in the hands of the loonies. They are against

unilateral disarmament."

Issue: Drugs

Early in December last year, the Surgeon General of the U.S., Jocelyn Elders, created a firestorm of controversy by suggesting a study be done on whether legalizing drugs would reduce crime. Most people believe only a small number of Americans favor such a step. Most people may no longer be right:

The Orlando (FL) Sentinel asked its readers to respond to this question: "Should drugs be made legal to reduce crime?"

Over 2,500 people called in and 60 percent said YES.

One major argument against legalizing has always been that legalization sends a message that society now "approves of drug use." A prominent conservative columnist has laid that argument to rest:

'(W)e hear again and again the complaint that the last thing society wishes to do is to communicate that it 'favors' the use of drugs . . . When a society decides to authorize the production of a good, there is no more reason to suppose that there is popular approval of that good than there is to assume that Congress likes Dr. Pepper because you can buy it on the street. It pays to go back to the axioms of a free society, among which is that government should not stand athwart a willing buyer and a willing seller . . . No death from marijuana has ever been recorded . . . there are few calls on Congress to prohibit the sale of tobacco for one primary reason, which is that the prospect of keeping 46 million tobacco users from their narcotic is a job the government simply wouldn't want to undertake. Its experience with Prohibition demonstrated the inadvisability of trying to stop (alcohol consumption). But nobody is going around saying that the government 'approves' of either drug.'

estimated 650 tons produced there. 'That's peanuts,' he said. In one indication that there is no shortage on the streets, the prices and purity levels of illegal drugs sold in the United States have remained relatively stable during the past four years."

Meanwhile in Europe, tolerance for drug users has appeared to work. In a piece subtitled 'Lower crime statistics support Elder's claim,' the Associated Press filed this news from Amsterdam:

"In a city known as one of Europe's major drug bazaars, purse-snatchings are rare and drug-related crimes of violence are almost unheard of. 'I think the tolerance of both hard and soft drugs has reduced crime in our cities,' Amsterdam police spokesman Klaas Wilting said . . . The Dutch government eliminated penalties for drug possession in 1976, setting a policy that possession of up to a gram of heroin or 30 grams of marijuana or hashish was not a punishable offense. Even though heroin is readily available, the Dutch addiction rate is one of Europe's lowest, with about 15,000 hard drug addicts and 600,000 marijuana and hashish users in this nation of 15 million. The crack cocaine that has contributed to urban violence in the United States is almost nonexistent."

Also from overseas is this view from London:

"(Prohibition) makes drugs artificially expensive, thus forcing their consumers to commit even more crime to pay for them. It

Waco

LP praises jury decision

The Libertarian Party said the jury "reached the right decision" in the acquittal of 11 Branch **Davidians on murder and** conspiracy charges.

Libertarians are now demanding an investigation of the government agencies that launched the bungled raid in Waco, TX a year ago, leaving more than 80 people dead.

"This verdict makes it less likely that Bureau of Alcohol, Tobacco, and Firearms or FBI agents will engage in unprovoked, lethal raids in the future," said Steve Dasbach, chairman of America's third-largest political party.

'The jury reached the right decision," he said. "They realized that the BATF and the FBI acted in a criminally irresponsible fashion. They realized that David Koresh and his followers may have had eccentric religious beliefs-but, in America, having eccentric religious beliefs should not be punishable by death."

Dasbach said he was disappointed by the conviction of five defendants of voluntary manslaughter. "We mourn the loss of life on both sides," he said. "But no one would have died if not for the misguided paramilitary attack by the BATF.

Now, said Dasbach, the federal government should appoint an independent council to investigate Attorney General Janet Reno, the BATF, and the FBI.

There is irrefutable evidence of official misconduct, excessive force, and possibly even homicide on their part," said Dasbach.

The jury cared. Libertarians care. Americans care. Now we must make sure that tragedies like this never happen again.

"The conduct of the BATF and FBI were reprehensible. They ignored opportunities to peacefully arrest Koresh; ignored reports that their 'surprise' raid wasn't a surprise; bombarded the compound during the siege with the sounds of rabbits being slaughtered; lied about the reasons for the final, deadly attack; and assaulted women and children with the same heavy tanks used in Desert Storm. This is not the kind of law enforcement we want in America,"

Dasbach cited the words of Koresh's attorney Dick DeGuerin, who said an "arrogant" BATF launched the raid because "it had looked to them like a dream situation—a bunch of religious nuts their SWAT team could practice on. Who'd complain? Who'd care?'

"The jury cared. Libertarians care. Americans care," said Dasbach. "Now we must make sure that tragedies like this never happen again."

Rational Law Enforcement" on Jan. 24 outside City Hall. A handful of indignant citizens from the downtown area also participated, bringing the total number to about 30. The group's literature and statements to the press focused on two main points:

1) In a city where the homicide rate has now reached one per day, the deployment of more than 500 law enforcement officers against what were essentially victimless crimes amounted to a serious misallocation of resources.

2) It was well known that the city government, particularly the mayor, wanted the night clubs off The Block so the land could be turned over to developers for office buildings and swank restaurants as part of a grandiose plan entitled "Baltimore 2000." The Jan. 14 raid was therefore an illegitimate use of government force in support of a land grab.

Small as it was, the rally had considerable impact. WJZ-TV, the most-watched local station for television news, aired an interview with Lorenzo Gaztanaga, while the two other local television stations also reported on the rally.

Susan Gaztanaga spoke briefly with city council president Mary Pat Clarke, a political rival of Baltimore Mayor Kurt Schmoke (the two will be competing in the Democratic primary in 1995). Clarke had been noticeably silent on the matter of the raid.

Susan Gaztanaga told Clarke "to take into consideration our feelings, which are that there are a lot better things the police could be doing." Clarke admitted that she could think of several street corners in the city that could use state police assistance more than The Block.

The following day, The Baltimore Sun began publishing letters to the editor on The Block raid, starting with the letter from Lorenzo Gaztanaga. Interestingly, that letter has attracted almost as much attention, if not more, than the television interview. Weeks later, acquaintances and coworkers are still coming up to Lorenzo Gaztanaga and saying, "I saw your letter in the paper. Well done!"

The indignities suffered by those who make their living on The Block, and by those customers unlucky enough to have been there at the wrong time, have provided the local Libertarian Party with opportunities for dialogue, and served as a catalyst for several members to make the transition from "living room Libertarian" to activist. Since the demonstration, Earle Pearce has been working with other Libertarians to launch "Citizens for Rational Law Enforcement." The coalition has begun gathering petitions within Baltimore City, and plans to move from there into Baltimore County and the rest of Maryland.

spawns ruthless criminal conspiracies to supply them. Legalizing drugs is in every sense a terrible admission of failure, yet it remains the only plausible strategy for making a dent in the crime statistics. In neither Britain nor California will mainstream politicians admit it."

"In a recent survey of persons in prison for robbery or burglary, one out of three said they committed their crimes in order to buy drugs. Forty-five percent of callers to a cocaine hot line said they had stolen to buy cocaine . . . In several studies of prisoners, 65 to 80 percent have admitted regular or lifetime illicit drug use . . . Numerous studies show that drug users commit far fewer crimes when undergoing outpatient drug therapy or even when the price of drugs drop(s).

"Drug prohibition also fosters crime by producing official corruption . . . In many cities, half or more of the arrests are for drugs or other crimes related to drug trafficking. The energy of the police expended on drug offenders is not available to be focused on domestic violence, rape, and other serious offenses. As a consequence, all criminals have a much better chance of escaping detection and punishment than if drugs were legal.

You want them. I want them. Most Americans want them. Most congresspeople do not want them.

Now, those of us who do want them seem to me to be in the majority. But those who do not want them run the show. And if we are honest with ourselves, we admit that Tom Foley and the other careerists are not suddenly going to change their ways and allow term limits legislation to be debated with anything approaching serious consideration. So, what's a nation to do? The school books say we're a democracy so let's vote on it!


I know you're saying to yourself "Sure, Diedre, that's a funny joke. As if we could just vote on it! Besides, we're really a Republic..." Yes, yes, Iknow we're a Republic and so does Rep. Peter Hoekstra (R-MI). He also knows that a national vote that binds Congress is not going to happen right now. So he's come up with something more palatable to the politicians and yet potentially significant. His bill, called the National Voice on Term Limits Act of 1994 (HR 3835), will provide for a national advisory referendum on congressional term limits. The vote will be non-binding on Congress and so those who want to defeat this bill will have to argue that the American people should not even be heard.

Hoekstra calls term limits a watershed

issue and believes that the marriage of term limits to a national referendum can "fundamentally alter the culture of ruling and decision-making in Washington D.C. He may seem a bit optimistic about this legislation's effect on issues other than term limits, but that's because he sees this referendum as merely the first in a series of national referenda that will set the agenda in D.C.

Picture yourself on Nov. 8 of this year. You're sitting at home in front of the news. You're watching the election results. Yes, you're concerned about all those bond issues and some very statist attacks against rights that you hope will be voted down, but you're also watching the returns come in on the term limits referendum. They show a solid majority in support of national congressional term limits. You think happily of the now inevitable introduction of term limits legislation in Congress and you know that your representative is going to have a hard time justifying a "no" vote now. THIS COULD HAPPEN! Make it happen.

When you write your letter or place your phone call on HR 3835, your representative will have a difficult time justifying opposition to this bill so make him or her take a position and explain it to you. Some of you have representatives who will easily support this bill if given the slightest encouragement. Others, like me, will have to fight through the sludge of double-speak to force their representatives to take a clear stand.



Whichever group you are in, take up your pen, lift up the receiver on the phone. So small a price for so much satisfaction!

Those of you who were reading this column last September may recall our unsuccessful attempt to eliminate funding for Selective Service. Although many of the key congresspeople were sympathetic to us, the Appropriations Committee finally decided that if Selective Service is to be abolished it must be through a bill with that express intent, not through a defunding action. We now have such a bill!

Recently, the Department of Defense issued its long awaited report on the necessity of draft registration. The DoD found that there was no such necessity. Clinton, however, refuses to end Selective Service before his administration completes its own

So, rather than wait around for that report's uncertain conclusion, Rep. Peter DeFazio (D-OR) has introduced HR 3634, which prohibits draft registration. It does not quite dismantle the entire system, but it does remove its teeth (and its need for funding ...).

If you wrote your congressperson on this issue last September and received a positive response, write again and remind him of his commitment to eliminate the draft. If you got a negative response, use the DoD study to challenge your representative's position. If you never received a response or are new to this issue, call your representative's office or send a letter and explain your position in a paragraph or two, then ask for a response.

NAFTA

Therefore, it is important to educate ourselves about the truly limited authority that NAFTA can exert-if it is to be consistent with the supreme law of our land.

Medical Savings Accounts (MSAs)—one of the core elements of the LP plan—should be considered in any health care proposal passed by Congress.

"He said to me that he would be interested in discussing this further with individuals from our organization," said Smith.

Smith notified LP national headquarters in Washington about the offer, and Director of Communications Bill Winter immediately dashed off a letter to Congressman Wyden's office.

The letter said: "Congressman Wyden told Dr. Smith that the Medical Savings Accounts idea—as expounded in the Libertarian Party health care reform proposals—had some merit, and that he would be interested in discussing this further with us. I'm very interested in helping you arrange this meeting, and would be happy to discuss a convenient time, and arrange for experts from our organization to meet with you."

Winter offered the services of Michael Tanner, the principal author of the LP proposals; Henry Butler, Shadow Cabinet Secretary of Health and Human Services; Dr. Paul Smith; and Nancy Lord, MD, JD.

Further, wrote Winter, "Health care reform is a vitally important issue, and the Libertarian Party is eager to do whatever we can to help Congressman Wyden craft a responsive and effective legislative solution."

Wyden is on the Democratic Party's Health Care Task Force, and is a member of the Energy & Commerce Committee, whose subcommittee on Health & the Environment will have a major role in shaping the final health care bill.

At press time, there was no reply from Congressman Wyden's office.

Meanwhile, across the country, longtime LP activist and current National Committee member Don Ernsberger had a personal meeting in Pennsylvania with Congressman James Greenwood (R-PA) on Feb. 10 to discuss the Libertarian Party proposals.

During the 15-minute meeting, Ernsberger said, "I presented him with an overview of our plan. I emphasized that our plan has some elements he may be familiar with, but is a synthesis that is Libertarian."

The congressman's response was positive, said Ernsberger.

"He said this is the very kind of thing he welcomes, because he is not convinced that any of the current plans [before Congress] are what he wants. To him, this represents a new approach."

Ernsberger noted that Greenwood is on the House Interior Committee, which will also play an influential role in the health care legislative process. "He is under great pressure to jump aboard a plan. [But] he wants to see all the alternatives [first]."

Ernsberger gave the congressman the entire Project Healthy Choice package, and said, "I am certain he sat and read the whole thing [afterwards]. He said he would."

In Norwich, CT, Libertarian Party activists rallied against government-run health care when the president came to town to try to bolster his sagging plan. Their protest won front-page newspaper coverage over the border in neighboring Rhode Island.

A story in the *Providence Journal* noted: "Mr. Clinton's plan didn't win universal

acceptance. Outside the auditorium, pickets from the Libertarian Party held a sign reading: 'Leave Us Alone.' Libertarians believe the government's role should be kept to a minimum.

" 'Government already has too much power, why do they have to get into health care, too?' said Libertarian Dawn Haefele. We're against socialized medicine because it doesn't work.' "

Libertarians across the country are also starting to get responses to the letters they have sent to Congress, urging consideration of the Libertarian Party plan. Some of them have been supportive.

For example, LP member Robert Zimmerman received a letter from Con-

gressman Randy "Duke" Cunningham (R-CA), promising to fight against "tax increases, costly mandates on employers and shifting of costs to already struggling state governments" in any health care proposal.

Finally, the general news continues to be bad for Clinton's plan. Several public opinion polls indicate that voter support for the president's plan is rapidly eroding, with more than 80 percent of Americans saying that health care quality would decline under a Clinton-style health care system.

An independent report than the Clinton plan could cost more than two million jobs—compared to the administration's estimate of only 600,000 jobs lost—also damaged the president's momentum.

Tax help

Dave tries to beat the system

Perhaps you do not believe that the Internal Revenue Service (Motto: "We'll Answer The Taxpayer Assistance Hotline When You Pry The Coffee Cup From Our Cold, Dead Fingers") would allow you to take anything so ridiculous as a perch-farm deduction.

Listen: You can deduct anything. People have deducted used underwear. And when I say "people," I of course mean "Bill Clinton." According to news reports, in past years President Clinton deducted as much as \$2 per pair for used underwear that he donated to the Salvation Army, which in turn gave the underwear to some needy individual, who in turn threw it into a Dumpster.

Quote of the Month

The following quote is from Neil Hamilton, MP, the British Government's Minister for Corporate Affairs. Hamilton spoke at a special seminar in mid-January hosted by the Libertarian Alliance, a British free market think tank. The discussion was of the government's newly announced proposals for deregulation.

"Deregulation is really part of a much broader Libertarian agenda which I fully share. John Major's statement in 1989 of a philosophy of freedom and responsibility, a vision of a world where 'people . . . choose for themselves, and not have choices made for them by politicians, self-styled experts, or for want of a better word, the Establishment,' is the road we should be taking.

The Libertarian agenda rationale of economic deregulation is one that should be extended into the broader realm of personal and social liberty. Those who would control, regulate, and interfere in the free choices of ordinary people do not seek power merely over our economic choices. The health fascists, the mandarins of 'political correctness,' the self-styled arbiters of morality are equally a threat to Britain's traditional liberties. A radical Libertarian agenda should seek to deregulate the widest possible range of free choice and action for all the people."

North Carolina

On Feb. 25, U.S. District Court Magistrate Russell Eliason ruled three North Carolina ballot access laws unconstitutional:

1) The mandatory checking fee of 5 cents per signature; 2) Mandatory notarization of petitions; 3) Wording on the petition to create a new party that the signers "intend to organize a new political party."

The magistrate upheld the 10 percent vote requirement for a party to remain on the ballot, and also the law that says that no one can register other than as a member of a qualified party or "Independent." The magistrate's findings must be approved by a federal judge. Assuming the findings are affirmed, the Libertarian Party, which brought the lawsuit, will probably appeal to the 4th circuit the parts it lost.

Nancy Lord meets with U.S. senator

Dr. Nancy Lord, the LP's 1992 vice presidential candidate, recently met in Washington, DC, with Sen. Paul Coverdell (R-GA).

Lord reported that the meeting was "surprisingly positive." According to Lord, Sen. Coverdell promised to investigate DEA conduct in the Tucker case (see Feb. NEWS, page 1), restated his opposition to gun control, expressed concern over the current crime bill, said he was willing to consider repealing mandatory minimum sentencing, and said he supports many aspects of the LP health care plan.

Lord also met with Rep. Barney Frank (D-MA). According to reports, Frank said that he will shortly introduce legislation to decriminalize marijuana. Ahoped-for meeting with Surgeon General Joycelyn Elders did not occur.

The LP of Montgomery County issued a statement in support of State Rep. Joseph Gladeck's efforts to privatize the state liquor store system. State legislators estimate that the state liquor monopoly would sell for more than \$1 billion. In addition, privatization should generate nearly 1,000 new small businesses in the


