Date of 2023 Convention	4/1/23	Bylaws Section 1(a) The Party shall hold a Convention of Party Delegates ("Convention") each calendar year, scheduled so that it convenes at least six (6) months after the previous Convention and adjourn no later than seventy-three (73) days before the day of the Colorado
Last day to publish convention dates	3/17/23	Article IX Conventions, Section 1(b) ...the time and place of any Convention and remote locations shall be published no later than fifteen (15) days prior to such Convention in a newspaper of general circulation in each county wherein the Members of the Party reside.
Last day to call convention	2/15/23	Article IX Conventions, Section 1(b) ...No later than forty-five (45) days prior to Convention, in accordance with state law, the Chair shall call the Convention by notifying Members of the date and location of the Convention, as well as any remote locations..
Last day to qualify as state convention delegate	1/1/23	Article IX Conventions, Section 1(d) A Member, having been a Member for at least the ninety (90) days immediately prior to the Business Session of the Convention may attend and vote at the Business Session as a "Delegate."
Member amendments to Bylaws and Platform must be received	3/2/23	Article XIII(a) and (b) Amendments ...written notice including the formal language of the amendment and signed by two (2) Members is provided to the Board at least thirty (30) days prior to the Convention. Such notice shall be posted to the Party's website within two (2) business days of receipt.

Dear Members of the Libertarian Party of Colorado,

As your Candidates Director, I am honored to have been reelected to this position, and I want to share with you some of the progress we have made in recent months.

One of my key areas of focus in this last month has been supporting candidates running for city council. I have been working closely with two such candidates, providing them with the resources and guidance they need to run successful campaigns. Both candidates have demonstrated a strong commitment to our party's values and have run highly effective campaigns, engaging with voters on issues that matter to them and building grassroots support in their communities.

In addition, I have had the privilege of working with a local woman who recently won a court case against the county government. Her victory is a testament to the power of grassroots organizing and the importance of holding our elected officials accountable. I am proud to have been part of her legal team and to have supported her in this important fight.

I am continuing to recruit local candidates as well as start to prepare for the 2024 election season. I have put together a team to work on a platform/agenda that our state candidates can run on. Something to show voters next year. This means the party must recruit solid candidates. Lines holders will no longer be accepted. All candidates must at least be educational candidates.

I am also working on a plan to present to national which includes asking for money for Colorado that I will be sharing at the board meeting.

Progress:

Google Docs spreadsheet created to measure efficacy of each event. Shared with board members. I will be responsible for keeping this up to date for events I am able to attend. When I am unable to attend an event, I will reach out to other board members or volunteers (when necessary) to keep this spreadsheet up to date and accurate.

Future state: this data should be housed in a more sophisticated CRM. Perfect world, we would keep data not only of the quantity of people in attendance, but of who specifically attends which events. This would enable us to reach out with targeted communications (emails, texts, automated telegram or discord messages?) reminding people to attend types of events they have attended in the past. And encouraging them to check out events that may be of interest to them. For example if we notice that someone attends many LOTR events but has never attended a convention.
