C.	Starchild requests committee decision on whether survey should include names and contact information for people who fill out to be made publicly available. That information is always available to the committee.
	The Chair would note that we can add a question on the form asking people to opt out with a public default but would also note that this would require the Chair or a committee volunteer to spend potentially hours redacting information with the potential for error and liability to the Party. PII being inadvertently released is a hot legal issue. In the past two Committees which is the extent of the Chair's knowledge the survey contents but not any PII was made public.
D.	Recuero proposal on 3.6 Representative Government <u>The Libertarian party encourages, when necessary, the right</u> to petition the government for redress of grievances. <u>This is absolutely dependent upon openness in government,</u> which therefore must never act behind closed doors. <u>We-As such we</u> support election systems that are more representative of the electorate at the federal, state, and local levels. As private voluntary groups, political parties should be free to establish their own rules for nomination procedures, primaries and conventions. We call for an end to any tax-financed subsidies to candidates or parties and the repeal of all laws that restrict voluntary financing of election campaigns. We oppose laws that effectively exclude alternative candidates and parties, deny ballot access, gerrymander districts, or deny the voters their right to consider all legitimate alternatives. We advocate initiative, referendum, recall, and or repeal and oppose any effort to

	deny these options when used as popular checks on government.
