Audrey Capozzi declared the bank balance to be \$26,754.41 as of January 24.

Chris Garvey proposed the following resolution: "The Libertarian Party of New York supports the use of human readable paper ballots for all public elections in New York State." The resolution PASSED with Mark Axinn, Gary Donoyan, and Thomas Ruks voting "nay".

John Clifton led discussion about the Eminent Domain rally proposed for late April.

Audrey Capozzi announced that BB&T Bank passed a resolution not to do business with any municipality that exercises eminent domain.

Mark Axinn proposed the following resolution: "The Libertarian Party of New York supports the action of BB&T Bank in refusing to lend money to entities that use eminent domain to acquire property." The resolution PASSED unanimously.

Bill McMillen conducted discussion about the Annual Convention in Albany.

M Carling moved to appoint a subcommittee with power to plan the Annual Convention consisting of Werner Hetzner, Bill McMillen, Richard Cooper, and Chris Garvey. The motion PASSED unanimously.

Gary Donoyan moved to appoint Bill McMillen Platform Committee Representative to the National Convention. The motion PASSED unanimously.

Tom Stevens moved to require that any vote taken by the State Committee to approve Bylaws amendments to the next Annual Convention per Bylaws Article XII.D.2.a. be made at an inperson meeting only and not via the on-line voting procedure. The motion FAILED 4-5 with 1 explicitly noted abstention.

M Carling moved to adjourn. The motion PASSED.
