### Delegates to Meet Candidates

Candidates for the LP nomination for president and vice-president will meet with California Libertarians at two Delegate Caucus meetings, July 11 and 12, in Orange County and the Bay Area.

These events are for all Libertarians, not only the delegates to the National Convention. This will be the time to listen, ask questions, evaluate answers and decide who would be the best standard bearer for the Libertarian Party in 1988.

Sure-to-show will be Russell Means, Carol Newman, and Ron Paul. James Burns (Vermont) and Jim Lewis (Connecticut), who have also announced their candidacies, have been contacted and will probably be there, too. Jim Lewis was the LP vice-presidential candidate in 1988. Besides the presidential hopefuls, Andre Marrou, who has announced for the vice-presidential position, is also planning to attend.

The Southern California meeting will be Saturday, July 11, at the Sequoia, 7530 Orangethorpe Ave., Buena Park. # News and Events from the Regions

## Election Results

In the special election for the 5th Congressional seat formerly held by the late Sala Burton, Libertarian Sam Groves came in with 1,007 votes — 1.4% of the total. Maybe not great, but it was twice as good as his vote total in the primary or that of the LP candidate in the special election in 1983, who received only 400 votes.

Campaign manager Will Wohler says it's hard to tell whether mailing to the decline-to-state voters in certain precincts had much impact. The best precinct was one where every voter — not just D/S or Libertarians — received Sam's literature. There he got 12% of the vote.

## Here and There

**ORANGE COUNTY:** Past state chair Jack Dean and Lee Connelly, chair of Orange County, were at a press conference sponsored by a group called "Orange County Tomorrow" which is promoting a "Traffic Control Ballot Initiative." Interestingly, libertarians and the folks who formed Orange County Tomorrow had worked with together in 1984 to defeat Proposition A, a proposed one cent sales tax increase, but, says Lee, "we want to make it clear that we don't support this initiative." In a prepared press release, Lee described the initiative as "a misdirected effort. . . People need to attack the root cause of this problem — local governments' transportation policies." He also called on the Orange County Transportation Commission (OCTC) to study private alternatives in attempting to deal with the county's traffic problems. "A lot of research has been done in this area by private groups such as the Reason Foundation, yet the OCTC has yet to indicate any interest in looking at such creative approaches. Perhaps it presents a threat to their ever-expanding tax-funded empire."

Jack and Lee were able to suggest to those present that comparable goals might result by reliance upon the private sector. To explain their position in more detail, they handed out copies of a speech given by Bob Poole of Reason Foundation this past April at a conference on rental housing. The talk, "Freeway Privatization: Solution to Orange County's Traffic Gridlock?" describes a number of private alternatives to government funding and building of new freeways.

## StratCom Recommendations

The LPC Strategy Committee met in Fresno June 21 and came up with several recommendations which are being implemented.

The state office in San Jose will maintain a database of libertarian speakers throughout the state who are available for discussion of various topics. The office will also put together a database file of "canned" speeches.

A library of audio and video tapes is being assembled, to include, for example, televised tapes of the presidential candidates, talks by libertarians on local radio stations, video tapes by foundations like World Research, Inc. in San Diego, and so on. Many of these will be provided by libertarians who have taped the different programs for their own interest. Professor Murray N. # LPC Letter Log

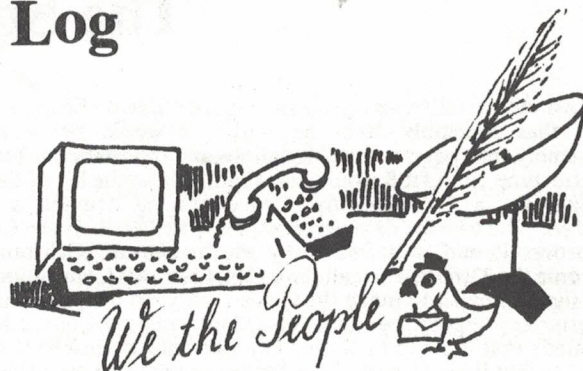

**LAKE COUNTY:** Libertarians in Lake County are going for a "Landowner's Bill of Rights" initiative, reports Lake County chair Randall Grindle. The initiative will incorporate several policies: (1) Any land use regulation for public use that goes contrary to what the owner wants to use that land for will entitle the landowner to just compensation; (2) a clause will be inserted making land use variances easier to obtain; (Randy points out that this is permitted by state law, but is resisted by planning departments); and (3) persons taken to court for a zoning ordinance violation will be informed of their right to seek jury nullification of the particular ordinance.

The initiative is being drafted and will be ready to be circulated sometime in November.

**REGION 62, Beverly Hills Breakfast Club:** The Beverly Hills Libertarians are changing their meetings to a breakfast club, which will meet an hour earlier at 10:00 a.m. First speaker under the new program format will be Phil Fixler, Director of the Local Government Center, which is connected to the Reason Foundation. Phil will be speaking on "The Positive Potential of Privatization in Beverly Hills." The new meeting place is Ernie's Deli, 430 No. Roxbury Dr., Beverly Hills. Guests are always welcome. In addition to the usual conversation, announcements and inside gossip, this month the Nolan political position testing program is available for PCs and clones (Mac is on the way). Check the upload area under NOLAN.EXE or NOLAN.ARC. You may remember this program from the county fair, where we used it to stop traffic and attract people to our booth. The current version has snazzy graphics and gets the questions down to eight by having gradations in the responses (Awful Idea to Super). # The Sounding Board

Last month *CLNews* ran an alert in the "Eye on Sacramento" section that Assembly Joint Resolution 8 would be heard in the Assembly Intergovernmental Relations and International Trade Committee June 10. AJR 8 would add California to the list of those states calling for a Constitutional Convention to demand a balanced budget. The hearing date was postponed to July 1. If the Committee approves it and it is passed by the legislature, California would become the 33rd state to call for a Constitutional Convention. It takes ratification by 34 to make the idea a reality. In the piece I urged that libertarians oppose the calling of a Constitutional Convention on the grounds that it could be a runaway Convention, just as the first one was — that there is, perhaps, a hidden agenda and once the delegates are in their places, ready to discuss a balanced budget amendment, the orders of the day would be set aside to discuss a complete overhauling of the Constitution. I had written, "Don't worry," say the optimists, 'if anyone tried that they'd be such an outcry from the public that they'd back right off. They'd never get away with it.' It must be wonderful to have such faith." I also quoted Sen. Patrick Leahy's (D-Vt.) concern that the Bill of Rights could be repealed.

Bert Donaldson, of Ventura County, does not share my fears and wrote a letter explaining why. As editor, I prefer to have readers discuss this sort of thing in letter exchanges, but the time is short so I'll answer Bert directly, particularly as it provides an opportunity to further clarify the issue, clear the record, and to present information on where the bill stands. *CLNews* is by no means claiming the last word and will run letters on both sides of the issue.

To the Editor:

I'm suprised that you're against the move to force a Balanced Budget Amendment. There is no justified fear that a Constitutional Amendment Convention could run-away. I'd prefer that Congress be completely prohibited from amending the Constitution — I trust state-organized conventions more than I do Congressional action. In any case, it's been the big spenders mostly who have been fighting this — against the National Taxpayers Union (NTU) — along with the John Birchers who no longer oppose income tax, (or any taxation as far as I can tell, or inflation either). It's these who have been using the "runaway" excuse. You shouldn't have used Sen. Leahy's quote. His record on spending is a miserable 27%, as rated by the National Taxpayers Union. If people like Sens. Proxmire of Wisconsin (99%), Helms of N. Carolina (98%), or Phil Gramm of Texas (95%) are against it, then I'd reconsider. The need for balanced budgets is critical for libertarians. The NTU recognizes this and welcomes an amendment from Congress. It is urging Congress to put the amendment out before a Convention is called, along with the Liberty Amendment which would repeal the income tax and ban government industry. This would place the United States 90% of the way towards libertarianism. Back to the politicians you

mentioned, the only other one I'm familiar with is McClintock who is about as close to libertarian positions as a Republican assemblyman gets. By the way, you're the first person who's ever called me an optimist! But it's available evidence and experience, such as the states' resolutions that say "for the purpose of a Balanced Budget Amendment," not wonderful faith that I have. Let's press for a Balanced Budget Amendment by some means!

Editor's Comment: Bert Donaldson is not alone in his opposition to the views of the *CLNews* editor. It turns out that the Libertarian Party is on record as supporting the call for a Balanced Budget Amendment. However, it is not clear to those I have discussed this with whether that support includes the endorsement of the idea of calling a Constitutional Convention, and *that* is what I am concerned with. Moreover, it is not certain whether the endorsement by the Libertarian Party was made by the LPC or National LP. It bears looking into, but the answer was not available as of press time. I'll check it out and report next month.

Now, to the questions raised by Bert's letter. I applaud the movement that calls for a balanced federal budget. One doesn't need to be a libertarian to be concerned over government spending and the \$1.6 trillion debt. An aide in Gil Ferguson's office points out that the interest on national debt is the third greatest item in the federal budget — after general welfare services which is first, and military spending, second. The questions are: (1) is it necessary to amend the Constitution in order to ensure that the budget is brought under some kind of control; and (2) if so, is it necessary or desirable to call a Constitutional Convention in order to pass such an amendment? I'd answer probably yes to the first question, definitely no to the second.

But to find out how others felt, I phoned the offices of the three senators Bert mentioned in his letter. Sen. Proxmire does support the calling of a Convention, but only if it is severely limited in scope. He does so "reluctantly and with grave qualms," says his aide. Sens. Helms and Gramm were contacted, but their staffs have not gotten back to me. It is interesting to note that of the co-sponsors of AJR 8 Quackenbush has withdrawn his support and Longshore and Zeltner are having second thoughts. When asked why, an aide in Longshore's office said simply that the assemblyman had not been fully aware of there being any danger when asked to support the resolution, but has received information that it is not as clear-cut and straightforward as it had seemed. Ferguson so far discounts the dangers, but is aware of them.

In fairness to McClintock and his endeavors in the legislature, his resolution would seem to be very binding upon the delegates to a Convention. If only there weren't this nagging distrust of folks in the background who have openly admitted that they can and will use a Constitution Convention as a way or bringing new, updated Constitution, without all those checks and balances and separations of power. If only we could trust the delegates, but experience says, don't.

## LPC Platform Available

We've all been asked, what's the Libertarian Party position on eminent domain, gun control, drugs, undocumented aliens — you name it. The LPC Party Platform is nothing if not thorough but it is also cumbersome — a full 23 pages, typewritten. Lee Connelly, chair of Orange County and Region 65, has done us all a favor by formatting it into a handy eight page document, just what's needed for quick and easy reference. It's typeset and looks professional, so you might want to order a bunch for an information booth or to mail to your "inquiries" list. And this is the *complete* platform, not an abridged version. Only the typesize is reduced. Each copy is \$2.00 if ordered by mail, but Lee will have copies at the Southern California Delegate Caucus for just \$1.00.

## URGENT: Fight SB 442

One of the worst bills ground out of the hopper in Sacramento this session, or any other session for that matter, is SB 442, which gives private citizens one of the most awesome of police powers — eminent domain. If passed, folks will be able to form "readjustment agencies" (a sort of private redevelopment agency) with the right to readjust their neighbors property boundaries, even if that means taking their land — and never mind the Fifth Amendment. This bill was formally condemned by the LPC ExCom on May 3.

Libertarians have been working with other activists against it, and one of these friends, community organizer for property rights Sherry Passmore, has put together a flyer outlining the dangers of SB 442 and listing the members of the Local Government Committee of the Assembly to write to. A copy of the flyer is included in this newsletter. We are urging that you sign it today and send it to your assemblyperson (his or her name will be in your local phonebook under government offices); also, that you notify Sherry that you have sent it so she can log the responses. She reports that sometimes letters and petitions like this one get mysteriously "lost."

This bill is on a fast track and has already cleared the Senate 28 to 0. How did your senator vote? Did he or she even know what it was about? For more information about this bill, contact Sherry Passmore (her address and phone number are on the flyer) or *CLNews* editor, address and phone on page two.

Reprinted below is the resolution passed by the ExCom on May 3. You may want to refer to it in your correspondence. For a while the LPC was the only group to announce condemnation and opposition, but Sherry Passmore (see page one) is working to line up others and we are no longer standing alone. Sherry reports that she has convinced city council members in several communities to try to get council disapproval, and several homeowner groups have decided to begin letter writing and other efforts. The Taxpayers' Watchdog, an L.A. group, has alerted its membership and sent Sherry's flyers to the readers of their newsletter. If you have contact with any civic or other organization, now is the time to get them to sign on.

### Resolution of Opposition to SB 442: A Bill to Permit the Creation of Private Land Readjustment Associations.

Whereas: the Libertarian Party of California recognizes the right of property owners to control, use, transfer or dispose of their property in any manner that does not violate the rights of others, and

Whereas: we advocate the repeal of eminent domain and all forms of condemnation of property, and

Whereas: SB 442 would authorize individuals to form private land readjustment associations empowered to exercise eminent domain over certain parcels of land, thereby creating a kind of private redevelopment agency,

Therefore be it resolved that as we oppose legislation which expands the powers enjoyed by redevelopment agencies, so we oppose legislation which gives comparable powers to the private sector. Therefore, we unequivocally condemn SB 442 and urge its defeat by the legislature.

Be it further resolved that we make our opposition known to the appropriate parties.
