Libertarian Party of Pennsylvania Convention to Host 2004 Presidential Candidate, Michael Badnarik!

Michael announced his candidacy for the Libertarian Party presidential nomination on February 17, 2003 (Presidents' Day) and traveled over 25,000 miles across the U.S. in the 15 months leading up to the Libertarian Party National Convention in Atlanta. He entered the convention as the underdog against two strong challengers, yet won the endorsement of our party through his strong performance in the presidential debate. His ability to convey the libertarian message is inspiring. In addition to being our keynote speaker, Michael will be offering a class on the constitution on Friday prior to the start of the convention. His understanding of the U.S. Constitution and his unique ability to convey its pow-

with a number of other third parties in our state in the hope of leveraging our legislators to implement more equitable ballot access laws. Governor Rendell has formed an Election Reform Task Force to address several matters, and I've been invited to appear before this task force on March 3rd. With any luck we will be presenting our concerns and recommendations in a public meeting on March 17, 2005.

I'm also pleased to report that we have several standing committees now forming that should help propel our party to greater levels of success. The standing committees now ramping up include the membership, fundraising and election committees. Each of these committees faces different challenges.

As a result of the membership committees' recent efforts, our state membership has doubled. I want to thank the membership committee and all of you who have recently signed on with our state party. As our membership grows, so does our ability to affect change in Pennsylvania.

The fundraising committee will soon be announcing some programs that will benefit our party greatly, and the election committee under the leadership of Chuck Moulton is striving to identify candidates for local elections this year. They are also looking ahead and working to identify candidates for the offices that will be open next year. Of course, next year, we face the challenge of getting statewide candidates on the ballot which we must do if we want to retain minor party status under current law.

These committees are all open to suggestions and can use your support. Please give me a call or send me an email if you are interested in contributing to their success. I'll look forward to seeing all of you at our state convention.

Costa Rican Libertarians Seek Presidency

On a recent trip to Costa Rica, I had the opportunity to meet Jorge Codina, an activist from Movimiento Libertario, the libertarian party in this Central American country. We went to Costa Rica to enjoy the warm climate, natural beauty and abundant wildlife, but I had heard about the success they were having and I wanted to find out how they were doing it. I wanted to know how liberty could take hold in a country knee deep in socialism. How did these libertarians secure 8% of the national legislature? I also wanted to learn what they had been able to achieve while in office.

Over a long lunch with Jorge, I had a great time learning about Movimiento Libertario and Costa Rican government. The first thing I learned was that these guys are real uncompromising libertarians, fully dedicated to the principles of individual freedom and personal responsibility. Not surprisingly, the challenges they face are similar to what libertarians face in the US. Deficit spending, corruption, declining education quality and bloated government give the Libertarios plenty to work on.

Costa Rica's electoral system is quite different from the American system. People vote for political parties, not individual candidates. The legislative seats are awarded proportionally. The largest district, San Jose, gets 20 Diputados (legislators). Because the Libertarios earned 5% of the vote in that district, they won their first seat in 1998. (American Libertarians may be familiar with Costa Rica's first Libertario Diputados, Otto Guevara from his address at the 2002 Libertarian Party Convention.) In 2004, they won 6 seats out of 57 (one Diputado later changed to independent, leaving the Libertarios 5 seats). According to Jorge, they expect to do even better in 2006 and even have a shot at the presidency.

Corruption scandals and infighting in the major parties have created additional

opportunities for the Libertarios. The incumbent party currently has no presidential candidate and has two past presidents in jail. I was impressed to learn that unlike in the states, they actually prosecute their corrupt politicians.

Although substantially out numbered by the larger parties, the Libertarios have achieved quite a bit in a short time. The party was able to raise nearly \$250K for the last election cycle. Considering a population, 1/3 the size of Pennsylvania, I found that quite impressive. They refused to except \$750K in government election funds available to them based on their vote totals.

The Libertarios have been able to successfully interject new concepts into the legislature which get reported on by the media even if they don't pass. They have successfully blocked and hopefully killed a colossal new tax plan that included the formation of an IRS equivalent. The elected Libertarios have gained notoriety by exposing government corruption at the local and national level, and establishing a tighter accounting system in the legislature that has saved taxpayers millions.

According to Jorge, many libertarian concepts resonate with Costa Ricans, where they have a strong tradition of free speech, individual freedom and disregard for the state. The Libertarios have gained the most support for their economic and personal freedom positions. Their position on open immigration is less popular, as anti-Nicaragua sentiment is somewhat prevalent. The current administration is seen as xenophobic.

"Our greatest challenge is getting the word out." said Jorge. When Libertarios address community groups, they are warmly received and respected as the ones who bring the facts and numbers with them. While the Libertarios do enjoy some media exposure, their competition outspends them considerably on advertis-

ing. La Nación, the country's leading newspaper, has moved from calling the Diputados of the Movimiento Libertario "anti-democratic obstructionists" to calling them "valiant defenders of the people's money".

Anecdotal evidence indicates that the Libertarios are getting the word out. As I travelled around Costa Rica, we noticed quite a few Movimiento Libertario signs on trees and poles, some in extremely remote places. When I wore my "No mas impuestos" (no more taxes) t-shirt with the Movimiento Libertario logo, I received multiple thumbs-up and positive comments from locals.

Costa Rica is jaw-dropping beautiful and its people are educated and quite friendly. Although they still suffer from the ravages of socialism, liberty appears to be on the rise with the help of the Libertarios. They abolished their army in 1949, and have since enjoyed peace and relative prosperity. According to Jorge, Costa Rica would be a better "Free State Project" than New Hampshire. Entrepreneurial freedom seekers from the US are warmly welcomed and the Costa Rican libertarians are gaining ground. The gorgeous environment, friendly inhabitants and low cost of living do make it tempting.

Every Citizen Pays \$8,213 Today for Pennsylvania Government

Cost of state and local government increased under Rendell by more than \$800 per person!

Harrisburg, PA - As Gov. Rendell delivered his third budget address, the Commonwealth Foundation released a report showing Pennsylvanians are paying more than \$800 per capita today to support state and local government spending than they did prior to the start of the Rendell Administration-an increase in government spending of nearly 11 percent in just two years.

"Big Government is Pennsylvania's major growth industry," said Matthew J. Brouillette, president of the Commonwealth Foundation. "Under Gov. Rendell's leadership, we now have more people working for government than we have workers in manufacturing. How long can our commonwealth survive-let alone thrive-when we continue to create more 'takers' than 'makers'?"

The Commonwealth Foundation report, *Total Cost of Pennsylvania Government: 2005 and Beyond*, calculated that Pennsylvania state and local government spending rose from \$4,407 per person in FY 1991-92 to an estimated \$8,213 per person in FY 2004-05.

"In just the first two years of the Rendell Administration, the cost of state and local government has increased by \$803 for every man, woman and child in Pennsylvania," noted Brouillette. Total Pennsylvania government spending rose from \$7,410 in FY 2002-03 to \$8,213 in FY 2004-05-a 10.8 percent increase.

The total cost of state and local government in Pennsylvania is projected to exceed \$102 billion in FY 2004-05, and will likely reach more than \$115 billion by the 2008-09 fiscal year (by conservative projections). This increase in total Pennsylvania government spending is more than double (112.8 percent) the

concurrent combined 40.6 percent rate of population growth and inflation.

Commonwealth Foundation Senior Policy Analyst Grant Gulibon, and report author, noted that if state and local government spending had been limited to the previous year's combined rate of inflation and population growth between FY

1991-92 and FY 2004-05, the amount each Pennsylvanian paid for state and local government today would be \$2,103 less (\$6,110 for every man, woman and child rather than the actual government price tag of \$8,213 per capita).

"This is money families could use to pay for prescription drugs, tutoring for their kids, or fixing the car," said Gulibon. "It's money that should have been left in the hands of citizens."

Brouillette said the explosive growth of government spending over just the past two years is severely hindering job creators and hurting families. "For the sake of Pennsylvania's working moms and dads, state lawmakers must get control of government spending."

"If policy makers are truly concerned about making Pennsylvania a better place to live, work and raise a family, they must begin working on a 'spending and tax accountability' amendment to the Pennsylvania Constitution," he said. Such a measure will control future spending by requiring voter approval of increases in state and local spending exceeding the combined rates of inflation (or any other measure of wage or

income increases) and population growth.

Brouillette noted, "If such spending limits had been in place before Gov. Rendell's tenure, every Pennsylvanian would be paying \$544 less today for Pennsylvania's big and growing government.

Philadelphia Libertarians Oppose Smoking Ban

Philadelphia, PA - The Libertarian Party of Philadelphia (www.lpPhilly.org) announced the beginning of its campaign to defeat the bill to ban smoking in most workplaces introduced in City Council recently.

"This anti-smoking bill is nothing more than a vicious attack against anyone who owns property in Philadelphia," said Joseph Leibrandt, Chair of the lpPhilly. "Why does City Council think it should dictate to a bar or restaurant owner where customers can smoke? The choice of allowing smoking or not should be left to business owners, employees, and patrons. If ordinary people really want smoke free bars, bar owners will voluntarily open smoke free bars. In fact, in the past few years several new

smoke free bars have opened in Philadelphia." If a customer is caught by the police smoking in a bar every week, the bar owner will have to pay \$15,000 in fines every year. Said Leibrandt: "This has nothing to do with health -- along with red light cameras, this is just another way to get money from the hard pressed Philadelphia taxpayer!"

Leibrandt continued: "The City of Philadelphia takes on average \$150 via the wage tax every month from each Philadelphian. Given a free choice between (a) a city government that takes this much and interferes in whether you can smoke in a bar, or (b) a smaller city government which doesn't take any money from you in wage tax, which would you rather have?"
