Dr. Lord Tours Illinois December Third through Fifth



Libertarian vice-presidential candidate, Dr. Nancy Lord, will make a three-day campaign swing in Illinois kicking off the 1992 Illinois political campaign. She will arrive on December third. On the fourth, she will travel to Peoria, where she will be interviewed on radio talk shows including WTAZ, and by newspaper reporters. A banquet will be held in her honor that

night in downtown Peoria. On the fifth she will swing back to Chicago for more talk shows and interviews. The campaign kick-off dinner will be held that evening with Nancy as the featured speaker. Also, other candidates who have announced in Illinois will be introduced. The dinner will be held at Zum Deutschen Eck Restaurant, 2924 N. Southport Avenue, in Chicago. There is a cash bar at 6:30 PM, a family-style dinner will be served at 7:30 PM, and Nancy Lord will speak at 8:30 PM.

Nancy Lord is an incredibly talented, intelligent, and warm person to experience. She has doctorate degrees in both medicine and law. She recently took third in the race for mayor of Washington D.C. running as a Libertarian. Nancy speaks with spirit, resolve, urgency, and determination. She has the credentials, class, and commitment to help the LP "break through" in the '92 election. Do yourself a favor and see this singular woman in action.

At this time, there are more Illinois Libertarians interested in running for local political office than there has been for years. Let's amplify this interest with a great showing at the banquet.

Wolin Is Winner in a Loss

Running in a non-partisan race for school board in District 21 of Wheeling Township, **Libertarian Ken Wolin** received approximately 1300 votes in a race he wasn't given any chance to win. Three people were elected to the board, the top vote getter receiving 1900 votes, the next two garnering a little over 1600. Wolin spent only \$200 in the effort receiving a great deal of volunteer effort from Libertarians in the race.

Wolin ran on a theme of school choice, bloated-bureaucracy reduction, and lower taxes. Even though he lost the race, he and his ideas won the respect of the local educational establishment. Ken has been appointed to the budget committee for the school district, a plum appointment indeed. Also, the superintendent asked to meet with him so that they could further pursue the idea of educational choice in the school district!

Wolin's campaign concentrated on canvassing 21 of the 58 precincts in the district, and in a few of those districts he actually out-pollled all other candidates. "This is a phenomenal success for a first-time effort," said Wolin. "If we had canvassed all the districts, we would have won the race. In the past five elections, 1300 votes would have been enough votes to win." Wolin's candidacy forced the other candidates to run a far more active campaign than they would have otherwise. The only other time 1900 votes were required to win in the last five elections, was due to a controversial school bond issue being presented to the electorate.

The campaign received some help from a few unlikely sources. During one "candidates night" when Wolin was extolling the virtues of educational choice, one British lady stood up and stated that she isn't familiar with the American educational system, but in Great Britain, educational choice is a way of life, and everything Wolin said about it was true. During the last week of the campaign, a reporter for the *Daily Herald*, Bonnie Booth, ran two favorable front-page articles on Wolin's campaign, even though the *Herald* didn't endorse him.

Ken wishes to thank all Libertarians who helped him so much on the campaign, especially Jeanette Clinkunbroomer, her nephew Bill Kovac, Michael and Toya Dixon, Helen Heyden, Glenn Olofson, Ted Beckman, Neal Reynolds, Steve Berman, and Palatine high school student (who heard about us by viewing the national convention on C-Span) Adam McCabe.

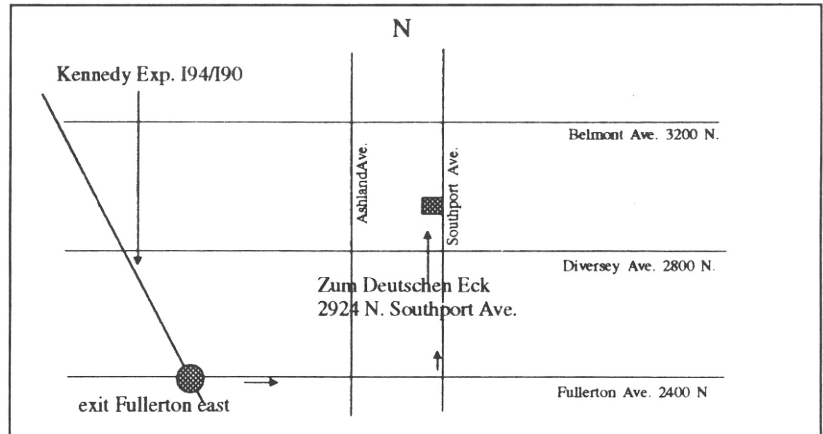

S&Ls, Airlines not Good Examples of Deregulation

Editor, Southern Illinoisan:

I would like to reply to the editorial page article claiming that deregulation has not worked ("Dream in trouble: Deregulation the Problem, not the Cure," Sept. 5). Like much current received wisdom, it is simply not true. The article tackles two major areas of deregulation—the airlines and the savings and loan industry.

The airlines were deregulated by Jimmy Carter (something most people forget). Prior to that, airlines were not only protected they were subsidized to the extent that no matter how bad the management, how stupid the business policy, or how expensive the service provided, the individual airlines never had to worry about staying above water.

When the airlines were deregulated, one of the major results was that those airlines that had been protected from their own stupidity began to experience the consequences of their own bad business decisions, and they have begun to fail. As a result, there may end up being fewer airlines—the final result of fifty years of subsidies and coddling has not yet shaken down.

What is clear, however, is that the author of the article has not flown at all in the past few years or else has not had to pay for his own tickets. He says one needs 'a second mortgage on one's house' in order to be able to fly. This is the kind of bald untruth one can get away with only by not reading the newspapers.

Last week there were ads by the major airlines advertising round trip flights to New York from St. Louis for under \$250. That is less than it cost 10 years ago. Can you think of the price of anything that has gone down in the last 10 years? If you look at the facts, deregulation is producing exactly what it was supposed to—more efficient airlines and lower prices. It is also

the fact that U.S. airline travel is now safer—but that's a story for another day.

Then there is the savings and loan crisis. Reagan deregulated the S&Ls. But then he did something else—he raised the insurance limit from \$10,000 to \$100,000. This is a complicated issue, so I will try to simplify somewhat.

Supposing you had a business making widgets, and the government told you could run it any way you wanted, but if you goofed, it would pay you \$10 for every widget that didn't work. How careful would you be about how you made widgets? Then the government changed its mind and decided to pay you \$100 for every widget that didn't work. Can you imagine what kind of widgets we would get?

In a real free market one is responsible for one's successes, and liable for one's errors. But the S&Ls were completely protected from their bad choices, and as a result, they made a lot of them. This is what the author of the article laughingly calls deregulation. If you deregulate an industry, but then subsidize its failures, you haven't deregulated anything.

The Democrats gave us airline deregulation, and it worked, but now they attack it as "voo-doo economics." The Republicans gave us S&L deregulation then abandoned it at the same time. Real deregulation works but neither side believes in or practices it. Only the Libertarian Party advocates making individuals and corporations responsible for their own decisions, which is what deregulation is all about.

An Open Letter to Ron Paul

Dear Ron,

I am writing you in response to your proposed candidacy for president of the United States as a Republican. I was a delegate in 1988 in Seattle when your eight minute video moved me to tears and convinced me to vote for you for the Libertarian nomination for president. I have followed your political career and recognized you as a libertarian before you declared yourself as such. I was overjoyed when you resigned the Republican Party and signed on as a Libertarian. I have always regarded you as a man of principle. From your unpopular stands in Congress, to your resignation, to your unflinchingly principled positions you took during your presidential race—you have proven to be a man of principle. So that is why I am writing you today and urging you to refrain from running for president as a Republican. Your candidacy will smack of expediency and opportunism. You will ruin your reputation and harm the Libertarian Party's chances of breaking through in New Hampshire.

During your resignation speech in Congress, you presented an eloquent and impassioned case against the Republican Party and their movement away from the principles of liberty. Those arguments made sense then, and they make even more sense now. I find it rather incredible that you would consider running for the nomination of a party whose leader lied about tax increases, continues the destructive war on drugs, and mounted an ill-advised war that may have killed 200,000 Iraqi people just so he could consummate the New World Order that we both fear. And Bush is not the only culprit; Republican congressmen are willing participants in this continual onslaught against individual freedom. By associating yourself with these enemies of freedom, you are sanctioning their policies. You give them credibility at a time when they are losing more and more credibility from those who do believe in individual freedom. And your own credibility gets damaged in the process.

Yes, a good argument can be made that running as a Republican may attract some dissatisfied Reagan Republicans that a Libertarian may not attract. If you had never resigned from the Republican Party, I would say, "Go for it." After all, ideas are what count, not party labels. Alas, it is too late for such an approach without seriously damaging your own reputation and that of the Libertarian Party.

I know that you aren't all that thrilled about Andre Marrou's candidacy. Frankly, neither am I; my candidate lost the nomination. Nevertheless, we are all Libertarians. If we are to participate seriously in the political process, then we must show the general public that we are organized and mature enough to set aside petty differences and coalesce behind one candidate. If

every libertarian splinter group feels that it must run its own candidate, it will always remain a splinter group. When splinter groups can't coalesce, it sends a message to the general public not to coalesce with us either. Splintering is antithetical to successful politics.

Think of the possibilities of success if you went to New Hampshire and helped the Marrou and Lord campaign. You could convince frustrated Reagan Republicans to protest Bush's policies by voting Libertarian; your influence would be immense. We could definitely put ourselves on the map politically. The Manchester *Union Leader* recently ran a straw poll and discovered that Marrou took second place to Bush, beating all Democrats in the process. Your support for the

Libertarian nomination could make the February primary very interesting indeed, so interesting that the establishment news media could not ignore us.

Just so you know where I am coming from, I consider Murray Rothbard my favorite economist. I have been a tax protester since 1976. I am pro-life. I have always been an avid Ron Paul supporter.

I know that your good friend, Lew Rockwell, is urging you to run as a Republican. Lew has done great work with the Von Mises Institute. He has spread a pro-liberty message on "Crossfire" as well as tangential libertarian publications. I have to admit that I don't fully understand his vitriolic hatred of the Libertarian Party. His criticisms are completely off base as is his support of LA Police Chief Darrell Gates, and his policies. To me, Lew Rockwell is a living tragedy. Don't let Rockwell's apparent blindness drag you down in his tragic mire. Ron, you are a giant among men. Your support for the Libertarian presidential campaign will demonstrate true class that our movement desperately needs. Don't take the easy route. Don't pursue the expedient way.

Help us achieve the breakthrough that you helped begin with your candidacy. Come home, Ron Paul.
