Convention to feature candidates, issues

Nancy Lord, the LP vice-presidential candidate headlines an all-star cast scheduled to appear at the 1992 Libertarian Party of California State Convention on Feb. 14-17 (Presidents' Birthday holiday weekend). Orange County is hosting the convention, which is to take place at the Radisson Plaza Hotel adjacent to John Wayne Airport.

Recently confirmed as featured speaker is **Neal Knox**, former Executive Director of the National Rifle Association and now the Natioonal Chair of the Firearms Coalition, a lobbying group promoting Second Amendment rights. Knox will speak at noon on Saturday, Feb. 14. His appearance will be publicized among gun rights groups in the southland which is expected to boost the growing coalition between the LP and members of those organizations.

Local candidates combine efforts, plan strategy

Orange County LP candidates are organizing a campaign strategy for 1992 that will be streamlined and professional at minimum cost, under the chairmanship of local activist **Eric Sprik**.

Sprik ran a highly visible, well-received campaign for the 35th State Senate District seat vacated by John Seymour in a special election last year. This year as Candidates Committee Chair he will apply what he has learned to helping all local candidates in their respective campaigns.

Fred Singer, media coordinator for the committee, is assembling a press kit for all candidates which will be sent to dozens of area media outlets. Sprik has also arranged for an experienced accountant to work as campaign treasurer to those candidates running for state-level office.

Other candidates participating in this plan are John Beatty, Scott Bieser, Roger Bloxham, Geoffrey Braun, Gary Copeland, Mark Logsdon, Brian Schar and Dan Wilson. This coordination of effort, in addition to external events alienating voters from the major parties, may make 1992 the year the LPC makes electoral history in California. More people are blaming dismal economic circumstances on both Democrats and Republicans. "Professional politician" is a nasty name. Outsider, anti-incumbent, anti-tax candidates have won election in other states.

The libertarian message and approaches to the issues will sell, if we are there — on the ballot — to sell them. We are the only political party consistently working for everyone's liberty, on every issue, all the time.

The party hopes to have a Libertarian candidate on the ballot for every position. It is important that, in every election, the voters have the chance to vote Libertarian. There are still a few open spaces on the LP ticket. Those interested should call County Chair Brian Schar at 714-840-6833 to get details. The deadline for filing for most offices is Feb. 10.

Goldsworthy runs for State Chair

Kim Goldsworthy, LPC Southern Vice Chair, has announced that he is a candidate for State Chair. The position will be filled at the state convention to be held Feb. 14-17 in Costa Mesa. He is challenging incumbent **Pat Wright**, who is running for re-election.

Goldsworthy is running on a six point program: 1) a public relations program for the LPC; 2) giving greater recognition to grass roots activists; 3) getting thet state executive committee to work through committees; 4) creating an outreach program for th enon-reading public; 5) a professionally crafted LP exhibit booth; and 6) county fair participation throughout the state.

Besides the six-point program, Goldsworthy has set goals of visiting every active county in California in 1992, doubling the amount of monthly pledges of the LPC, and using more fully the electronic bulletin board (EBBS) "Liberty Bell."

Structurally, he plans to implement an "internal education" program for newly elected chairs and new activists, and see that every county has a set of bylaws, a media list, and an updated list of registered Libertarians in the county. Thursday, Jan. 16, a new members' reception will be held at the Waterfront Hilton. A letter was mailed to each registered Libertarian in Huntington Beach and Seal Beach who isn't currently a duespaying member, with the intention of encouraging them to join. The results will be known at the next Central Committee meeting. **Gary Hull**, who put this reception together, is planning to do several more in the coming months.

Congratulations to **Scott Bieser**. He got through to David Duke on the Tom Leykis Show two days after our last meeting. Scott tenaciously went after Duke, forcing him to admit "I am not a member of the Libertarian Party." Scott struck a blow against disinformation and made sure that the public knows the truth about Duke.

As an ongoing activity, if you notice media features that should have featured the Libertarian Party but didn't, write a letter or make a phone call. Let them know, calmly and politely, that we exist, and you would have liked to have seen us or read about us. They'll keep on slighting us only as long as we let them get away with it. You **can** make a difference!
