CITY LOBBIES WITH TAX DOLLARS

City of B'ham Says Vote Yes to More Taxes! It's one thing to hold an election to raise taxes. Even when there is nothing else on the ballot and turnout is sure to be low -- leav-

ing the decision to a small percentage of voters -- mostly those with a vested interest in seeing the tax pass.

But it's another thing entirely to spend our tax money to influence people to vote FOR more taxes. It's unethical for sure, a scary precedent to set, and probably illegal!

Yet that's just what Birmingham City Council and the mayor did in the May 12th election to raise taxes for E-911 and the libraries. They threw away \$20,000 of your money on newspaper and radio ads to convince you to give them more money to waste.

It is immoral and arrogant for government officials--who, after all, live off taxes--to spend tax money to lobby us on behalf of more taxes

We at <u>Common Sense</u> checked with attorneys, the Attorney General's office, and the State Ethics commission. The immediate response of everyone we talked with was, "They can't do that."

Indeed, a state law says no government official may use his office to influence the outcome of an election. The Elections Code is clear, "No person shall attempt to use his official authority or position for purpose of influencing the vote or political action of any person. Any person violates this subsection (b) shall be guilty of a felony and punishable by a fine not to exceed \$10,000.00 or imprisonment in the state penitentiary for a period not to exceed two years, or both." If "Vote Yes" ads aren't an attempt to "influence the outcome of an election", we don't know what is.

Even The Birmingham News, which ran one of the ads, said in an editorial that we were right to question the "Vote Yes" flasco. We are doing more than that. We intend to sue the wrongdoers over the "Vote Yes" campaign. We will not ask that the election be overturned, because they would probably hold a new one--with all of its expense. We WILL, however, demand that the city officials responsible personally repay the \$20,000 to the taxpayers of Birmingham.

If we don't stop them now, what's next? Spending tax dollars on ads telling us to vote for the incumbents in this year's mayoral and city council races?

By the way, fewer than 10 percent of the voters turned out to decide this great referendum that was supposed to show the "will of the people". Between the expense of putting on the election, and the "Vote Yes" ads, the city spent over \$100,000. That's over \$7.50 per vote! Something's not right, don't you agree?

POLITICOS NEED PAI INCREASE

Pay increases for Birmingham's city council
and mayor have been introduced into the
legislature. Under the bills the mayor's pay
will increase over 30% (\$16,000/yr) from \$52,000
to 68,000. The current expense allowance of
\$12,000/year will stay the same. Rep. Gary
White, R-Homewood(!?!) sponsored this bill.
Rep. George Perdue, D-Birmingham was even more
generous with our money. He sponsored two bills
for Birmingham city council. Under them Council
members could get salary and expense increases
of \$11,200/yr (council president even more).
Added to the \$15,500 they now get this whopping
72% increase is a pleasant bonus for part time
work.

(That ought to make souvenir shopping easier on all their worldwide junkets.)

Council staff members in Birmingham average \$23,567/yr and are not scheduled for an increase. (Atlanta by comparison pays their staff people an average of \$16,437/yr). Russell Yarbrough (who was against adding personal assistants in 1984), now favors them possibly because his grandson is now making the maximum of \$24,960/yr as his administrative assistant. (Not bad for a UAB college student.) Linda Coleman appears to be more cost conscious starting her sister-in law off at only \$18,720/yr as her administrative assistant. While not ruling out a pay increase later Ms. Coleman said "It was a learning situation for her".

MISVOD ON WHAT IS THIS, RUSSIA? 6 0890AZ

"Welcome to the Soviet Republic of Birmingham. Latest in the attempt to regulate, prohibit or destroy our economic and personal freedoms is a proposed sign regulation ordinance." So begins the editorial in the Birmingham Business Journal 5/18/87.

Besides driving sign makers out of business this law will hurt people involved in any kind of business. Some examples from the third draft of the ordinance which <u>Common Sense</u> reviewed:

Service stations and hotels (would not be able to direct traffic to their locations.

Grocery stores would not be able to put up banners advertising their specials. Even a Coke machine with writing on it could be outlawed.

Many landmark billboards would have to come down, like the Liberty National sign or the Michael's restaurant sign.

For what? Just to force some bureaucrat's idea of what looks nice on the rest of us.

The draft we reviewed went on and on. After all our Central Planners worked on it for over six months. Business people would have to get a permit for every sign they own and would be severly limited in the number of signs they could have. The law also sets up "Scenic Corridors" where signs would be virtually outlawed.

Our City Commissars even have the gall to say this will make Birmingham more attractive to business! As Birmingham Business Journal wrote: "That contention is so ridiculous it! doesn't

deserve comment."

Simple research in other cities with restrictive sign ordinances shows businesses have been devastated by fines and by the cost of changing signs. Not to mention the revenue lost by the lack of outdoor advertising, compliance cost in Lubbock, Texas (a city about 1/4 the size of Birmingham) is estimated at over \$2 million.

On the moral side this law is a full-scale attack on freedom of speech and property rights. It does in fact bring us one step closer to living in "The Soviet Republic of Birmingham," SOURCES Birmingham Business Journal, 5/18/87. City draft (#3) of proposed sign ordinance,

2. The nation's toughest smoking ordinance which forbids smoking in many private businesses. Forces private business to file written smoking policy reports and post signs. 3. The new City budget. Almost a 7 million dollar increase for all sorts of goodies. Meanwhile we had a 12.5% increase in violent crime in Birmingham last year. Solution cut the police request for new manpower by Arrington said "The solution to crime would have many roots." Well, sir, more wild spending by city hall is not a solution.

4. New restrictions on use of our Parks. Parks WE pay over 11 million dollars a year to Now Birmingham's bureaucrats have restricted Freedom of Assembly in most City Parks. Numerous new restrictions are now in effect. One example, groups (even family reunions), of 100 people or more must hire off-duty policemen to supervise them.
