## PETITIONS

The first day for collecting signatures on the nominating petitions is July 12th. The three days for filing the petitions with the Board of Elections are August 21-23.

While the minimum number of signatures required by law are 7,500 for city-wide races and 5,000 for borough-wide, we will be needing at least 15,000 to 20,000 signatures. Because of the large number of candidates that will be running in November, we can be sure that there will be challenges to our petitions.

In order for a signature to be valid the signer must be a registered voter who **did not** vote in the primary and who **did not** sign another petition.

There is an old cliché, "The more the merrier." But for us it should be, "The more the better."

We cannot take any chances with this petition drive. The FLP is putting most of its time, effort and resources into this election, and we cannot run the risk of having our petitions knocked out because we tell a few short of the **valid** number of signatures.

As you will see elsewhere in this issue our candidates for public office, especially Fran Youngstein, have stirred up a great deal of enthusiasm in the Libertarian Party, not only in New York, but around the country.

If you want to show **your** enthusiasm for bringing the message of **libertarianism** to the people of New York, (and there is no better way than through an election campaign) then you will work with us on this **very important** petition drive. For without our candidates on the ballot this November — where will we be.

## FROM THE CHAIR

Dear free libertarians,

Last summer we had our first petition drive to get candidates on the ballot. We didn't make it. On July 12th we will begin another petition drive. Both the stakes and requirements are much higher but this time, with your help, we *will* make it.

At the LP Convention in Cleveland many people commented on the warmth and personal feeling we obviously had for each other despite the fact that our group was certainly less homogenous than any

other. That warmth grew out of the petition effort we made last year, both on the streets and at the Board of Elections. We learned to respect each other; we developed a closeness soldiers on the battlefield understand. None of us who worked together last summer — and we did work *together* — will ever forget it.

Now we want to let the rest of you in on the fun. It's going to be fun, although I admit some of it will be in retrospect. It's going to be hard work too but as someone commented about the FLP, "they've

started a new precedent for libertarians; they work instead of just talking."

I've focused before on what's in it for us personally in working within the FLP. Well, what's in it for us in this project? There will be a great deal of attention given to the 1973 New York Mayoral race. This is our best chance to be noticed, to become known, to begin to expose our ideas to the rest of New York, and to the whole country.

It's our chance to say NO. NO to the politicians who steal our money. NO to the agencies that give us nothing in return except poorer services and higher prices. NO to the would-be dictators who call us children to be protected. NO to tax hikes to pay for programs we don't want. NO to those who want to regulate our morality. NO to those who want to regulate our productivity. NO to those who want to control our lives.

It's our chance to really fight for our freedom, and an acknowledgement that it's worth fighting for. It's a chance to do something instead of sitting back hoping the power-lusters will *somehow* be eaten by worms and we will magically be free. It's our chance to get in on the action with other people who think as we do. It's a chance to make good friends...to smash the state...to learn the ropes...to strike our blow...to DO SOMETHING.

There are people all around the country who want to help us. When we get on the ballot, we can count on their help. But we've got to do this part *ourselves*. We've got to collect 20,000 signatures so there will be no point in the hacks' challenging us. We can do it if everyone helps. If you don't want to fight City Hall, then you're going to be stuck with it. This is the real revolution in the streets, the only kind worth fighting and the only kind that has a chance of success.

We're not asking for every minute of every day. You must decide how much time and effort you can spend. We'll take any time you can give us. We ask for as much as you can give. These are the most important six weeks in the FLP calendar. On August 23rd, when we file those 20,000 signatures, you can all hop a plane to Acapulco...or hitch a ride to Fire Island. The politicians say minor parties don't count for anything. They've thrown down the gauntlet; help us pick it up in the next six weeks. I promise you'll be glad you did.

Harvey Michelman, who is running for Civil Court Judge on the Republican-Conservative lines, and who sought the FLP endorsement, was interviewed by the State Committee. When 3/4's of the Committee were finally present there was lengthy discussion on the endorsement. The Committee finally voted 'no endorsement.'

## IN THE NEWS

### LP NATIONAL CONVENTION GOES FRANTIC

Just under 200 delegates attended the Libertarian Party's national convention, June 8-10. The New York delegates, having rented a bus, constituted about 15% of the delegates.

Although a quiet convention was expected due

to the off-year politically, Fran Youngstein, FLP candidate for Mayor, charming the delegates with a post Friday night dinner speech, turned the convention into a buzzing hive of activity by pointing out to the delegates the national importance of the NYC mayor's race in terms of publicity for the LP. I can only describe the reaction to Fran's candidacy as nothing less than frantic (pun intended). Prior to the speech on Friday night, Fran was featured on several news broadcasts on Clevel and television.

In recognition of Fran's race, the National LP Executive Committee took several concrete steps to support the election effort. The delegates also responded by donating or pledging enough funds to provide the seed money for launching the campaign. One particularly exciting experience was the warm and enthusiastic response of the large Canadian delegation. Speaking at a Canadian caucus, Fran told the delegates that "the United States has been messing into foreign politics so much that it's heartening to see Canadians get their chance to mess up American politics."

Also speaking at the Friday night dinner were Dave Nolan, who gave a stirring keynote address, Sue Nolan, national chairperson and guests of honor Toni Nathan and Roger McBride, both of whom received enthusiastic receptions as a result of their past efforts on behalf of the LP. Toni Nathan, of course, was the Party's Vice-Presidential candidate and the first woman to ever receive an electoral vote. Roger McBride is the elector who cast the infamous vote.

There were several other speakers that Friday night including Andrea Millen, Sharon Presley, David Friedman, Bill Lawry, Sam Konkin and Howie Katz.

Friday afternoon involved a seminar on "issues" featuring Karl Bray, Willis Stone and myself. It is rumored that several New Yorkers slipped away to go to the pool but I don't believe it.

Saturday featured seminars on fund raising and media. Wainwright Dawson, who is a prominent political activist, spoke at the the fund raising seminar and later gave much valuable assistance to the FLP campaign staff. Paul Streitz hit some responsive notes with some important observations regarding the media.

I was extremely impressed with the caliber of the delegates in attendance. They were very attentive to the speakers and the questions asked were uniformly good. No time was wasted with arguments and pet peeves.

Saturday afternoon also featured several well attended tax rebellion seminars led by Karl Bray,

Willis Stone and Ken Kalcheim as well as many regional caucuses. We can look forward to the start of a healthy LP to be organized in Canada.

Oh yes, I was able to confirm that the Klasperson led a pool caucus of pleasure parasites.

Saturday night featured the poolside luau followed by the FLP hosting a special "victimless crime" seminar in the hospitality suite.

Sunday saw Kay Haroff, Ohio Chairperson and convention host, elected by her regional caucus as the National Executive Committee member for the region. Winston Duke of Illinois and Bill Westmiller of Canada were elected as Committee members at large.

On the bustrip home it appeared to be the unanimous opinion that the convention was a great ball and most of us felt that it was quite instructive.

If sincerity counts in building a movement we expect the Great Pumpkin to settle in the LP patch. Sorry Linus.

## GOVERNMENT IS ORGANIZED CRIME

Lysander Spooner put it quite aptly when he said, "Whosoever desires liberty should understand these vital facts, viz.: 1. That every man who puts money in the hands of a 'government' (so called), puts into its hands a sword which will be used against himself, to extort more money from him, and also to keep him in subjection to its arbitrary will...." He had no doubt that "THE POWER TO TAX IS THE POWER TO DESTROY."

Howard Katz is not a tax rebel, yet. But thkt is no bar to IRS harassment. In fact, the government, unknowingly, has become an ally by turning taxpayers into tax rebels through its tyrannical procedures.

In 1971 he had his first contact with the IRS. IRS agent, George Hornecker called him to arrange an audit of his 1968 tax return. The agent failed to keep the first appointment and Howard, waiting past the appointed time for the second meeting, could wait no longer. Finally, the third time around, the meeting took place and the agent worked all day on the audit. As the audit wasn't finished, the agent said he would have to return. This was in or around November 1971 nearing the time when the statute of limitations would run out. As the time was so near, the agent asked Howard to waive the statute and he naturally refused. This meant that the IRS would



have to conclude its investigation and audit by April 15th, 1972. Because of this turn of events, the agent closed the case by assessing Howard with a liability of \$12,686.06 in taxes for the year 1968. Now, he had only earned \$8,000-\$9,000 for that year. This shouldn't be a surprise to anyone. Howard had lost about \$15,000 on the stock market in '68. This negated any tax that would have been due on his income. In december '67 Howard bought some stock which he finally sold in January '68 without making a profit and yet, the agent arbitrarily decided that Howard had gotten the stock for nothing. This is an example of IRS abuse of power and also one of the reasons that the agent arrived at the assessment of \$12,686.06

After the statute ran out, Howard received a letter demanding the payment of \$12,686.06 to which he replied that he owed the government nothing. This continued for a time until he was called down to the IRS where nothing of importance transpired.

Then, suddenly on May 14, 1973, he was called down again to the HOUSE OF THIEVES. Through an act of trickery, Howard volunteered the information on his bank account and stock account. By pulling out an IRS form for uncollectibility, they made Howard believe that they were writing off the tax liability for 1968. The next day his stock was seized and on the 16th his bank account was seized. They were seized without Due Process of Law and without even a seizure order from a constitutionally empowered court.

As Howard's rights have been violated, he has retained this writer to file suit against the government, the IRS, the Commissioner of the IRS, the IRS agents involved, the bank and the officials involved, and the stock brokerage house and the brokers involved. Criminal charges will also be filed against the same parties.

So you see, whether you are a tax rebel or not, you still stand a chance of being harassed by the GESTAPO. Hitler is alive and well in the White House.

*The following letter has been received:*

Dear LP chairmen or newsletter editors:

For career reasons, I have decided to resign my post as region 8 co-chairman of the Libertarian Party (the holder of this post has a seat on the National Executive Committee ed.) as soon as a successor can be selected. The following describes a process that I think will pick my replacement quickly and fairly. Please inform your state members of it through your newsletter or a special mailing as soon as you can.

First, all nominations for the post must be submitted to Mark Frazier (% NTU, 625-27 East Capitol Street; Washington, D.C. 20003) in letters postmarked no later than August 1st of this year. Only those sending in a letter of nomination will be eligible to participate in the final vote for the new regional co-chairman. No nominations will be held valid unless accompanied by a self-addressed stamped envelope, in which the final ballot will be later mailed to the sender.

The final ballot will contain the names of the two individuals receiving most nominations, and will be mailed out to all eligible voters by August 15th. Selection of the new region 8 co-chairman will be announced on September 15, on the basis of who receives a majority of the ballots sent to Mark Frazier at the above address in letters postmarked no later than September 5, 1973.

Thank you for your cooperation. It has been a pleasure to be associated with the Libertarian Party, and I wish you all the best.

### FREEDOM OF CHOICE

Have you ever been attacked on the sidewalk and dragged into a porno book store against your will? Has anyone ever locked you in a room and forced you to listen to a "topless radio" broadcast under pressure? Were you ever tied to a chair and made to view an X-rated movie on television despite your protests? How many people do you know who were forced to see movies like *Deep Throat* and *Last Tango in Paris*?

No doubt the answers to the above questions are all negative. Perhaps, however, you have chosen to see and listen to one or more of those presentations of your own free will. Should the government have the right to prevent you from doing so? Should some bureaucrat be given the power to determine what you are permitted to see and hear?



The government says "yes." Already the Justice Department has proposed an extensive revision of the U.S. Criminal Code that defines obscene (illegal) material with a detailed description of the things depicted in such material. Already the Federal Communications Commission has fined a radio station \$2,000 for a "topless radio" broadcast, and is conducting a "non-public (i.e., private) inquiry" into a broadcasting of such programming. Congressman Torbet MacDonald of Massachusetts has urged FCC Chairman Dean Burch "to use all of his known powers" to put a stop to such programming.

Do you get the impression that certain things are being overlooked here — things like freedom of choice, for instance? Then the time is NOW to start organizing to STOP government interference with individuals who choose to engage in reading, listening and viewing of their own free will and who harm no one one in so doing. Fight for FREEDOM OF CHOICE — before it's too late.

## THE CRISIS OF OUR TIME

[continued]

There is one libertarian solution for inflation, and it should occasion no disagreement between the anarcho-capitalist and limited government wings of the Party. It is monetary anarchy — to get the government out of the sphere of money. Let people choose their own money, which means in practice — as all history teaches us — that they will choose gold as their standard of value.

If considerations of reality did not lead one to this conclusion, then considerations of politics would. In the past six months public protest against inflation has reached a fever pitch. When there is enough sentiment in the country so that consumers across the nation can spontaneously boycott meat, it is a sign that the public is aroused. No political party today can afford not to have a position on how to deal with inflation. This is already the number one issue of our day, and it will remain so for some time.

If libertarians dissipate their strength among several dozen issues, they will have minimal effect on each one. There is one issue which cries out for our attention. In America in the 1970's that issue is the libertarian solution to inflation — the gold standard. If we do not throw all of our strength into this issue, there is not going to be much of a party, or country, left.

When the Republican Party followed Nixon into Keynesianism, it lost its last, sorry reason for existence. It committed a moral treason which, if not reversed, will mean the death of millions of

Americans and the enslavement of the remainder. The Libertarian Party, despite its small size, can play a very effective role in defeating this impending runaway inflation. By presenting its conservative side to the public it can hold a knife to the Republican throat. It can run candidates against Republicans in marginal districts, candidates who run on the basis of conservative (or what once was conservative) fiscal policies; balance the budget, reduce government spending, fight inflation, restore the gold backing to our currency. It can thus tap the, still considerable, conservative sentiment in the country and take votes away from Conservative and Republican candidates. It can thus say to the Republican Party: "Return to the principles of sound economics or be defeated at the polls." If it does this, then the same pragmatism which caused the Republicans to sell out will cause them to come back to the fold. For our part I would suggest that the FLP take as a long range objective the defeat of James Buckley in 1976 by running against him a conservative candidate who will draw away from him enough votes to cause his defeat.

For some time I have felt a sense of quiet desperation. The country has entered a crisis which could easily lead to its demise. Yet people conduct business as usual. They cannot see the forest for the Trees. Libertarians *should* understand this point, but most of them do not. They advocate the gold standard but only as one of a number of issues. They go about as though there were no crisis.

In other times there have been and will be other crucial issues; war versus peace, democracy versus dictatorship, capitalism versus socialism have and possibly will again take their place on the stage of history. But for our day and age there is one issue which is crucial for the survival of our civilization. That is the gold standard versus paper money. If libertarians, of all people, do not know this and rally to the cause, then there is no hope for anything.

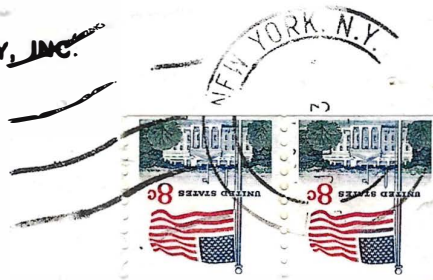
