ON THE CAMPAIGN TRAIL

Russell Means and Ron Paul, candidates for the LP nomination for president, spoke to California delegates at two Delegate Caucus meetings in Orange County and the Bay Area. Both candidates are living up to their supporters' hopes of being exceptionally articulate, dynamic speakers, obviously enthusiastic about carrying the libertarian message to the American voters; and both have generated considerable media attention and received terrific write-ups, particularly in local newspapers.

In Orange County, the who-gets-to-speak-first coin-toss was won by Russell Means, a leader in the American Indian Movement during the '70s. Describing the reception he's received from audiences, Russell said, "Wherever I go, no matter who I talk with, libertarian philosophy wins the day. It's a message that transcends the color of my skin."

He recalled that when asked to go after the nomination, he agreed because he would not have to compromise his principles or betray his heritage by running as a Libertarian, since there is nothing in the Platform that is not "Indian."

If nominated, who would he reach out to? "The 63% of the electorate that refused to vote — that's where I plan to campaign. We can excite them with a choice — a choice for freedom."

Ron Paul, former Republican congressman from Texas, described the situation in the world as "devastating." "This is a crucial year. We must become a viable party in 1988 — not 1992." His view of libertarianism: "It's based on humility. We don't want to run other people's lives, the country, or the rest of the world. We put our trust in the ability of people to make their own decisions."

He pointed out that the Libertarian candidate, whoever is chosen, will have an easier time than either Ed Clark or David Bergland, because he will not be running against Ronald Reagan and "there are no Ronald Reagans on the horizon. . . Our task is to convince the American people that it's in their best interest to go with us."

Andre Marrou, former Alaska legislator and candidate for vice-presidential nomination, is running strictly for that office. "I would rather be first choice for an office I want than second choice for one I don't." As vice-presidential candidate he'd travel to smaller towns and outlying regions — the presidential nominee must concentrate on the big cities. And, he points out, in the smaller communities it's easier to get on television to reach a whole segment of the voters.

Newman Withdraws from Race

Carol Newman, LPC candidate for Attorney General in 1986 and an announced candidate for the LP presidential nomination, withdrew from the campaign early in July. Citing time constraints and work pressures, Carol explained to Region 65 chair Lee Connelly, the reasons for her decision. "My workload has been increasing, and the fact that I wouldn't even be able to attend the Caucus on the 11th made me realize I wouldn't have the time to spare for an all-out presidential campaign if nominated at the National Convention in Seattle. My apologies go out to all who have supported my bid for the nomination."

LPC Pickets Reiner's Home

Libertarians spent several hours Sat., July 18, carrying signs outside DA Ira Reiner's home to protest his relentless harrassment of Norma Jean Almodovar, LPC candidate for lieutenant governor in 1986. Norma Jean was convicted on charges of pandering, her real crime being that of writing an expose of the L.A. Police Department. So far she has lost in both the superior and appellate courts, and when she appealed to the California Supreme Court to review the case, that august body refused to hear it, even though it involves First Amendment issues.

Libertarians from the L.A. area, Ventura and Orange Counties came to show their support for the LPC candidate and to express their opinion of Ira Reiner. Norma Jean herself was not able to be present, since she was in New York doing a special filming for the Phil Donahue Show. News coverage was unfortunately slight, although Channel 7 did do a segment for the six o'clock news, interviewing coordinator Larry Leathers; and a UPI reporter sent out a nation-wide story. Reiner himself, although he was known to be basking by his swimming pool, refused to be interviewed.

Norma Jean is scheduled for sentencing July 28, and is asking libertarians and other supporters to send letters and telegrams to the governor urging him to grant a pardon. His address is: The Honorable George Deukmejian, Governor of California; State Capitol; Sacramento, 95814. The salutation is Dear Governor.

Delegate Status

PLACER COUNTY: Bruce Daniels has resigned his position as chair of the Central Committee of Placer County LP, and is turning his job as LP contact over to Dennis Schlumpf, former Northern California vice-chair. LOS ANGELES COUNTY: John Vernon, chair of Region 61 (San Fernando Valley), has agreed to be chair of the Los Angeles County Central Committee, the liason between the LPC and the L.A. County Registrar of Voters. Although for our purposes Los Angeles County has seven regions, as far as the Registrar of Voters is concerned, there is just one. The task of serving as L.A. County Chair has been handled by Laurel Fest, but she recently decided to resign. John was named to the position by the L.A. County chairs at the Delegates' Caucus in Buena Park.

SANTA CLARA COUNTY: The LPC had a literature booth at the American Indian Festival in San Jose, July 25-26. At least 1,000 pieces of literature were handed out, and nine people decided to register Libertarian. Booth coordinator Donna Peart reports that a lot of people have signed an inquiry list for additional information.

Russell Means spoke Sunday to a crowd of about 500, explaining why he had become a Libertarian. Channel 11 (ABC) that covered the event, showed the booth and interviewed Russell for the six o'clock news.

We're in the Running

No sooner had the dust settled on the June elections, than Libertarians began thinking about entering the political arena once more. As of presstime here are the announced candidates.

Dennis Thompson announced his candidacy for the 44th Congressional race at the July 4 party in San Diego. Dennis ran for this seat in 1986. He'll square off against incumbent Jim Bates (D) in 1988. County chair Pat Wright says that Dennis' campaign will probably be the major one that San Diegoans will become involved with.

Lee Connelly, chair of Orange County and Region 65 and recently a candidate for the 33rd State Senate District, is still ready and willing. He's announced for the Buena Park city council race to be held this November. Says Lee, "Libertarians should think about running for local offices in order to make voters more aware of our philosophy. Local elections are the best chance for us to become elected."

And in Rancho Palos Verdes Alan Carlan is running for city council. Alan has a number of community contacts from whom to seek support, and is looking forward to running a strong campaign. He will focus on showing how libertarianism can make a better community.

"Our goal is to change the media's opinion of the LP from 'Who are they?' to 'They're Everywhere!'" says Kim Goldsworthy, newly appointed Media Relations Coordinator.

Let's Talk About It

Here are three modest (well, not too modest) proposals for your consideration:

1. Formation of an organization: California Freedom Initiatives Co-Operative, Inc. — to circulate and place on the ballot a number of initiatives; encourage the formation of similar organizations in other states; co-ordinate multi-state initiative campaigns through a National Freedom Initiatives Co-Operative, Inc.

2. Formation of Libertarian Information Co-operative, organized as a consumer co-cooperative. The co-ops would sell books, magazines, pamphlets, audio tapes, etc. In addition to bookstores, there would be lending libraries with computer links to sister co-ops across the country. The information co-ops could then serve as the basis for other organizations, for example, credit unions. Group health plans, mutual casualty (especially auto) insurance companies, housing co-ops., etc.

3. Form mutual casualty (especially auto) insurance companies open only to dues-paying members of existing libertarian organizations. Raise dues accordingly (in anticipation of insurance savings, dues now \$15.00 might be raised to, say, \$50.00.

Eye on Sacramento

LPC and Friends Fight SB 442

On July 1, LPC chair Mark Hinkle and San Jose activist Mike Iddings flew to Sacramento to testify before the Local Government Committee of the Assembly against the infamous SB 442. That's the one that would give your nice neighbors and that friendly developer permission to set up private redevelopment agencies complete with eminent domain powers so they can "readjust" your property boundaries. *CLNews* has been reporting on the progress of this bill over the last few months.

The hearing, chaired by Assemblyman Dominic Cortese, began at 2:00 p.m. with supporters being allowed to sound off first. As Mike describes it, "It was hurry up and wait — for two hours — till a little after 4:00 p.m. when the good guys got a chance to speak." By then the panel committee members were tired. Moreover, this was not the only piece of legislation being heard, so they wanted things speeded up.

Sherry Passmore spoke as official representative for many homeowner associations, and between her group and the Libertarians a number of objections were raised. Mark testified primarily on the injustice of eminent domain, while Mike discussed how "redevelopment" in general causes more harm than good.

The committee listened and suggested changes. SB 442 became heavily amended, mostly by the piling on of bureaucratic requirements. Sen. Marion Bergeson, the author of this little gem of legislative pornography was there and agreed to any and all amendments but one — that eminent domain powers be deleted.

Amendments came in so thick and fast that the committee finally decided it was impossible to consider anything then and postponed the vote till July 15.

The hope was that it would be defeated or perhaps passed to another committee. It really doesn't belong in the Local Government Committee, but should be heard by Housing and Urban Development or the Judiciary Committee. Lobbying was intense, and during the two weeks grace period opponents managed to convince the Republican Caucus of the Assembly to take a formal stand against it — which was a real coup, especially considering that Bergeson is, herself, a Republican. Assemblyman Elder of Long Beach (D) was particularly active in rallying opposition. Un-

fortunately, it was not quite enough, and the bill squeaked through the committee on July 15.

Next stop, Ways and Means, to be heard after August 15. Please get your letters, petition forms, etc. to the committee before that date. Ways and Means is chaired by John Vasconcellos. Now, there's the very real possibility that that Ways and Means will simply put it on the consent calendar and send it straight to the floor of the Assembly. If this happens, how will your assembly person vote? And does your assembly person know about SB 422? Be sure to send a copy of your remarks to the governor. This bill is on a fast track and may just fly through in a matter of days with hardly anyone being aware of it. In your correspondence urge not only defeat, but demand that SB 442 receive a full hearing by Ways and Means.

What you can do — particularly if you are in an organization or profession related to contracting, planning, or development. Try and get your organization to take a formal stand and let the committee know that your this stand has been taken. That's what Dennis Schlumpf has done. He's on the Tahoe City Advisory Committee, an eight-member group set up by the Placer County Board of Supervisors. Dennis got the necessary information about the bill to his colleagues, and after some study, they took a unanimous stand of opposition.
