In this edition, you'll find proposed Constitution and Bylaws changes that were submitted to the Party Secretary in writing as required at least thirty days prior to the convention.

These proposed changes are being provided in accordance with the wishes of our members who have previously asked to see such proposals in advance of our annual convention. Since the deadline has passed, these are the only Constitution and Bylaws changes that will be considered this year. Changes to the Convention Rules however, can still be considered during the convention.

While we are on the subject of the con-

vention, I would like to encourage everyone to run for a board position. If you are interested in running for secretary, treasurer, vice chair or chair, then please do. Competition for these positions is healthy. Without competition our party stagnates and none of us want that. So, please feel free to run. Whether you win or lose, we will always appreciate the efforts of those pursuing a position of responsibility.

Moving on to other points of interest, I must say this has been a challenging month. As our party continues to grow, so do our needs. This month, I have been looking for legal advice, software, and a web programmer that can donate a little

server side scripting. I know we have members that can lend help in these areas, but I have no way of locating you unless you let us know you are out there.

Our legal committee is currently a committee of one. One person can't do it all. There are numerous laws that apply to us as a political party. It would be helpful if we had several folks working to assure we are in compliance with them. We have developed a program that can make our membership database available on line to party officers and state and county committees. Making this information available on line in real time will facilitate party growth and help streamline our organization.

Now, all we need is the software to generate what they call run time versions of the program. It is unfortunate, but this project is stalled until we can raise the money to cover the cost of the software that will generate the runtime versions that are needed.

Speaking of money, we are taking steps to facilitate fundraising. Several web forms have been developed that we would like to make available on our website. Some of these forms are functioning, but they could be a whole lot better with a little server side scripting behind them. Please let me know if you are a web developer and can spare a little time to donate some server scripting.

By the time you receive this, we should have at least one form on our web site that will allow you to make monthly, quarterly or annual pledges to our party. We will be expressing our appreciation for donors in various ways including a before dinner reception at the convention. Our state Board of Directors has always been frugal and I'm confident they will put any money that is raised to good use. The starting level for pledges is ten dollars per month. I'm hoping each of you will consider making

The next few weeks will surely be hectic as we prepare for this year's state convention. Our organizers are working hard. This promises to be a good year. There is still time to sign up if you haven't already. I'll be looking forward to seeing all of you there.

Proposed Amendments for 2005

The LPPa Constitution and Bylaws require proposed amendments to be submitted in writing to the Party Secretary at least thirty days prior to the convention. The following proposed changes to our bylaws and convention rules were submitted to the Party Secretary accordingly. These are the only changes to our Bylaws that will be considered. In accordance with the wishes of our membership, these proposed changes are being offered for your consideration in advance of the convention.

Phrases struck out are ~~lined through~~.

Phrases added are ***bold, italic and underlined***.

Proposed Bylaws Amendments Submitted by Tim Crowley, Western Vice Chair LPPa, 12-06-2004

1. Regional Committees (Bylaws amendment)

ARTICLE III. COUNTY AND REGIONAL COMMITTEES

Section 1 - Definition of County and Regional Committees

Any group of ***two or more*** members in good standing residing in the same county, shall, upon their request to the Party be recognized by the Board of Directors as a "County Committee". ***The county committee must select an executive board consisting of two or more people, and they must choose as their Parliamentary Source any version of Robert's Rules.***

Recognized county committees from adjoining counties without sufficient members to qualify for individual voting LPPa representatives may elect one joint voting LPPa representative, provided that the total number of members in good standing among the adjacent counties exceeds the minimum of twelve prescribed in the bylaws for single county representation. These multi-county entities shall be called "Regional Committees".

A county ***or regional*** committee which fails to hold a regular meeting in any four month period shall cease to be in good standing. County ***and regional*** committees shall be responsible for the nomination and campaign of Libertarian Party candidates for county and local offices.

County and regional committees are required to elect their local board and their LPPa representative yearly, and they must provide a rank ordered list of alternate representatives to the board.

Section 2 - Purpose and Scope of County ***and Regional*** Committees

County ***and regional*** committees shall conduct activities consistent with the Constitution, Bylaws, and Rules of the Party.

Section 3 - County ***and Regional*** Committee Representation on the Board of Directors

Any member of a county committee who presents a petition to the Board of Directors from the majority of the members of his

or her county committee who are members in good standing of the Party (provided that the majority is at least twelve members) shall become the County Committee Representative.

Any member of a regional committee who presents a petition to the Board of Directors from the majority of the members of his or her regional committee who are members in good standing of the Party (provided that the majority is at least twelve members) shall become the Regional Committee Representative.

If at any time such county ***or regional*** committee shall have fewer than twelve members in good standing of the Party, or upon a challenge from at least three members in good standing of both the Party and such county ***or regional*** committee, such person shall cease to be the Committee Representative.

Absent such challenge, any duly elected successor board representative of such county ***or regional*** committee shall automatically be seated as a member of the Board of Directors.

Proposed Bylaws and Convention Rules Amendments Submitted by Chuck Moulton, Election Committee Chair LPPa, 3-31-2005

1. Executive Director (Bylaws amendment)

ARTICLE VI. EXECUTIVE DIRECTOR

The Board of Directors shall have the power to hire an Executive Director to assist the Chair in administering the operation of the Party. The Executive Director shall be subject to the same qualifications as a member of the Board of Directors.

Salary for the Executive Director shall be exclusively from special project fundraising earmarked for that purpose or commissions from the profits of fundraising and membership prospecting conducted by the Executive Director. Money from the general fund shall never be used to pay the Executive Director's salary.

2. Candidate Nominations (Bylaws amendment)

ARTICLE IX. NOMINATIONS OF CANDIDATES FOR OFFICE

Only the Libertarian Party of Pennsylvania shall have the power to nominate candidates for Pennsylvania state offices under the "Libertarian Party" label. Candidates for county and local office shall be nominated by recognized county committees in good standing. **Congressional and state legislative candidates shall be selected by a regional caucus of the recognized county committees in the district.** In the absence of a recognized county committee, the Board of Directors shall have the power to nominate candidates for **congressional, state legislative,** county, and local office with the advice of members in that county. **In the absence of a Convention resolution not to run any candidate for an office, the Board of Directors shall have the power to nominate candidates for offices not filled in Convention.** The Board of Directors shall have the power to nominate candidates for special elections, ~~and~~ nominate substitute candidates as provided in the state election code-, **and select individuals whose names are to appear on statewide nominating petitions as proxies for candidates nominated in Convention. The Board of Directors shall have the power to unendorse candidates for cause.**

3. Caucus Nominations à la carte (Bylaws amendment)

ARTICLE IX. NOMINATIONS OF CANDIDATES FOR OFFICE

Only the Libertarian Party of Pennsylvania shall have the power to nominate candidates for Pennsylvania state offices under the "Libertarian Party" label. Candidates for county and local office shall be nominated by recognized county committees in good standing. **Congressional and state legislative candidates shall be selected by a regional caucus of the recognized county committees in the district.** In the absence of a recognized county committee, the Board of Directors shall have the power to nominate candidates for **congressional, state legislative,** county, and local office with the advice of members in that county. The Board of Directors shall have the power to nominate candidates for special elections and nominate substitute candidates as provided in the state election code.

4. Post-Convention Nominations à la carte (Bylaws amendment)

ARTICLE IX. NOMINATIONS OF CANDIDATES FOR OFFICE

Only the Libertarian Party of Pennsylvania shall have the power to nominate candidates for Pennsylvania state offices under the "Libertarian Party" label. Candidates for county and local office shall be nominated by recognized county committees in good standing. In the absence of a recognized county committee, the Board of Directors shall have the power to nominate candidates for county and local office with the advice of members in that county. **In the absence of a Convention resolution not to run any candidate for**

an office, the Board of Directors shall have the power to nominate candidates for offices not filled in Convention. The Board of Directors shall have the power to nominate candidates for special elections and nominate substitute candidates as provided in the state election code.

5. Proxy Nominations à la carte (Bylaws amendment)

ARTICLE IX. NOMINATIONS OF CANDIDATES FOR OFFICE

Only the Libertarian Party of Pennsylvania shall have the power to nominate candidates for Pennsylvania state offices under the "Libertarian Party" label. Candidates for county and local office shall be nominated by recognized county committees in good standing. In the absence of a recognized county committee, the Board of Directors shall have the power to nominate candidates for county and local office with the advice of members in that county. The Board of Directors shall have the power to nominate candidates for special elections, ~~and~~ nominate substitute candidates as provided in the state election code-, **and select individuals whose names are to appear on statewide nominating petitions as proxies for candidates nominated in Convention.**

6. Unendorsements à la carte (Bylaws amendment)

ARTICLE IX. NOMINATIONS OF CANDIDATES FOR OFFICE

Only the Libertarian Party of Pennsylvania shall have the power to nominate candidates for Pennsylvania state offices under the "Libertarian Party" label. Candidates for county and local office shall be nominated by recognized county committees in good standing. In the absence of a recognized county committee, the Board of Directors shall have the power to nominate candidates for county and local office with the advice of members in that county. The Board of Directors shall have the power to nominate candidates for special elections and nominate substitute candidates as provided in the state election code. **The Board of Directors shall have the power to unendorse candidates for cause.**

7. None Of The Above (Convention Rules amendment)

ARTICLE X. ELECTIONS

Section 3 - Votes cast for "None of the Above" shall be considered valid in any nomination or election. Should a majority of the votes be cast for "None of the Above", none of the losing candidates for that position may be selected to fill the vacancy for that term of office, or be nominated for that office in that particular election. In elections or nominations having more than one possible winner, the number of votes received by NOTA shall be divided by the number of winning positions for which there are candidates.

Wednesday, April 13th, join Harrisburg's WHP 580's Bob Durgin and CALP (Capitol Area Libertarian Party) on the West steps of the State Capitol in Harrisburg from 3-6PM for CATTS (Citizens Against Tyrannical Taxation).
