The Libertarian Party of Pennsylvania will be holding its annual convention the weekend of March 19, 20, 21 at the Harrisburg Hilton, a few blocks from the state capitol building.

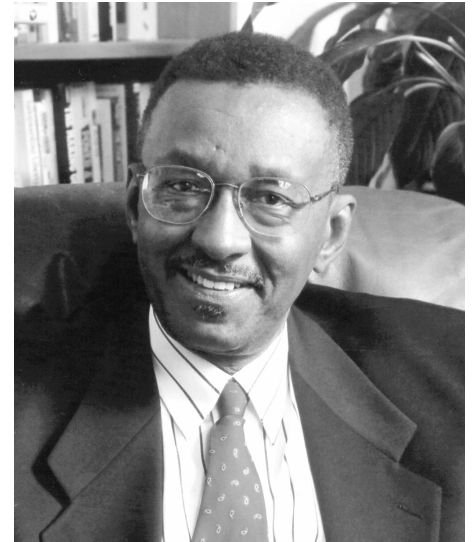
Dr. Walter E. Williams will be the banquet speaker Saturday evening. Dr. Williams is a professor at George Mason University, an occasional guest host on the Rush Limbaugh Show, and an excellent libertarian speaker.

Friday night features a reception for the 2003 and 2004 Libertarian candidates and elected officeholders, with entertainment provided by Jump The Gun. One of the contenders for the LP Presidential nomination, Gary Nolan, will be visiting the convention

Friday night.

Other speakers include Matthew Brouillette, President of the Commonwealth Foundation, Spear Lancaster of the Free State Project, and talk show host Michael Graham. The Libertarian Toastmasters will again be presenting a demonstration meeting at the close of the convention, and of course there will be the legendary Montgomery County Hospitality Suite.

In addition, the LPP will be choosing candidates for US Senate, Pennsylvania Attorney General, Auditor General, and State Treasurer, as well as electing the LP state party leadership and conducting other party business.

Pennsylvania Libertarians Score Seven Victories in 2003!

The Libertarian Party won seven elections in Pennsylvania in the 2003 general election – five of them re-elections – raising the total number of public offices held by Libertarians in Pennsylvania from 71 to 72. In all, 21 candidates appeared on the November ballot under the Libertarian banner, with innumerable local write-in campaigns.

Topping the local races was Mark Wicks in Berks County who was re-

elected Upper Tulpehocken Township Supervisor with 98% of the vote. Mark ran unopposed for re-election, presumably a Libertarian Party first for any Pennsylvania town council, and reportedly a national first as well.

Clarion County boasted the most victories in 2003, winning five races out of seven. The Etzel family provided three of those wins, with Vernon being elected Elk Township Auditor, and his father Berlie winning

Ashland Township Constable with 83% of the vote, and replacing his wife Rochelle as Ashland's Auditor with 79%. By law, Berlie can only serve in one office, and his choice was Auditor. Elsewhere in Clarion County, Ronald Krause was re-elected Supervisor of Brady Township, and Mik Robertson, the incumbent Supervisor of Licking Township, was re-elected with 69.9% of the vote.

Join the Gang of 70!

Another presidential election year is upon us, and that means another petition drive is gearing up.

What's a petition drive? Rather than participating in the government-funded primaries, Libertarians "petition" instead, meaning we collect a certain number of signatures from registered voters to get our candidates on the ballot. That number varies from a handful for precinct-level elections up to tens of thousands for statewide elections. To get our presidential candidate on the ballot for 2004, we're going to need a minimum of 25,697 signatures plus a sizable cushion to dissuade challenges. Call it 35,000 in round numbers.

Even though that seems a daunting goal, all of our past statewide petition drives over the past two decades have been successful (although some drives have been more difficult than others!), and there's no reason to think that this year will be any less a success. The key to a successful petition drive is in its strategy.

Experience has taught us that one of the best strategies for getting our presidential and statewide candidates on the ballot is for us to have lots of local candidates. That's because Pennsylvania's election law permits us to "stack" candidates on a single petition, so a signature collected for a local candidate also counts for our presidential candidate.

The most-local election this year in Pennsylvania is state representative. To get on the ballot, a state rep needs a minimum of around 300 signatures, plus a cushion. Call it 500 in round numbers. If you crunch the numbers, you'll find that if we collect

sufficient signatures for 70 state rep candidates, we will have simultaneously collected the 35,000 signatures we need to get our presidential candidate on the ballot, and with no extra effort.

While this strategy has been proposed before, it has never been followed. The trick has been in finding 70 Libertarians who wish to run for state rep. Although several Libertarians have already announced their intent to run for state rep this year, they total nowhere near 70. That's because many activists prefer not to run for office. Many of us are "behind the scenes" types who have a lot of talent and energy, but shun the public spotlight. Some of us may have professional or personal reasons not to run.

But whatever your reason, there is now a way that you can help get our presidential candidate on the ballot without running for office yourself.

How? By joining the Gang of 70.

A member of the Gang of 70 is someone who volunteers to place their name on the petition for state rep, then organizes a few local volunteers to collect the 500 signatures needed to get a state rep on the ballot. Some members of the Gang of 70 will follow through and run an active campaign for state rep, while others will opt to withdraw from the race entirely as soon as the petitions are filed in late July. The choice is left to you, the member. But regardless of whether or not you choose to remain on the ballot, as a member of the Gang of 70 you'll be doing your part toward getting our presidential candidate on the ballot.

Collecting 500 signatures is not at all difficult. One person can collect well over 100 signatures in one day by standing outside the busiest polling place in their district on Primary Day (April 27th) and asking voters for signatures as they come out of the polls. Four or five people working that one day can easily collect well over 500 signatures. All it takes is someone willing to place their name on the petition for state rep (but not necessarily run for the office) and organize three or four volunteers to assist.

Almost a dozen Libertarians have already volunteered for the Gang of 70 thus far, representing a collective pledge of about 5,000 signatures toward our goal. Since professional petitioners typically charge up to 2 dollars per signature, these volunteers are saving the state party \$10,000 in petitioning costs, and every new member of the Gang of 70 represents another \$1,000 saved.

Are you willing to help us get our presidential candidate on the ballot? Can you spare one day to collect your share of signatures? Then contact the state party ASAP at info@LpPa.org or 1-800-R-Rights. Become a member of the Gang of 70. Otherwise the voters of Pennsylvania might not have a Libertarian alternative on the ballot in 2004.

Proposed Bylaws and Constitution Changes

Bylaws and Constitution Changes submitted by Ken Krawchuk

The following changes to the LPP Constitution and Bylaws have been submitted for consideration at the upcoming convention.

1. Bylaws change:

Under Article 10, Amendments, append the following sentence:

Any proposed amendment may be amended twice at the convention with the consent of a majority of the delegates.

2. Bylaws change, new section:

Article 5, Section 5 – Transaction of business over the Internet

Any business of the Board of Directors can be conducted over the Internet in the same manner as via mail or telephone, except that multiple motions may be on the floor simultaneously provided they do not overlap or conflict with one another. If any members of the Board of Directors do not wish to transact Board business over the Internet, when a vote is required the Secretary will forward to them via mail or phone sufficient information regarding the business at hand to allow them to vote knowledgeably.

3. Convention rules change:

Under Article IX, Agenda, delete the phrase "which shall be conducted in the following order"

4. Bylaws change, new article:

Article 13 – Executive Director

The Chair shall have the power to appoint an Executive Director to assist the Chair in administering the operation of the Party. The Executive Director shall be subject to the same qualifications as a member of the Board of Directors.

5. Bylaws change, new section:

Article III, County Committees, Section 4 - Unrecognized Counties

The Board of Directors shall have the sole power to select a contact person for any unrecognized county. In the absence of a contact person, the cognizant Vice Chair shall be the contact person.

6. Convention rules change, new section:

Article 10, Section 3 - None Of The Above:

Votes cast for "None of the Above" shall be considered valid in any nomination or election. Should a majority of the votes be cast for "None of the Above", none of the losing candidates for that position may be selected to fill the vacancy for that term of office, or be nominated for that office in that particular election.

7. Bylaws change:

Under Article 9, Nomination of Candidates for Office, add the following sentence:

"and select individuals whose names are to appear on statewide nominating petitions as proxies for candidates nominated in Convention."

8. Constitution change:

To Article 4, Organization, Section 4, Judicial Committee, append the following sentence: "In the event of a vacancy on the Judicial Committee, the remaining members of the committee may choose a replacement by majority vote."

9. Convention rules change, addendum to new section (if it exists):

Article 10, Section 3 - None Of The Above: Add the following sentence: "In elections or nominations having more than one possible winner, the number

of votes received by NOTA shall be divided by the number of winning positions for which there are candidates."

Bylaws changes submitted by Tim Crowley Phrases added are bold and italic. (Phrases struck-out are in parentheses).

1. Constitution change:

Article 1. Purpose and Scope, Section 1 - Purpose

The purpose of the Party is to conduct the following activities consistent with the Statement of Principles of the National Libertarian Party: Disseminating Libertarian political (~~philosophy~~) **ideas** by entering into political information activities.

2. Bylaws change:

Article 2. County **and Regional** Committees

Section 1 - Definition of County and Regional Committees

Any group of **three or more** members in good standing residing in the same county, shall, upon their request to the Party be recognized by the Board of Directors as a "County Committee". **The county committee must select an executive board consisting of three or more people, and they must choose as their Parliamentary Source any version of Robert's Rules.**

Recognized County Committees from adjoining counties without sufficient members to qualify for individual voting LPP representatives may elect one joint voting LPP representative, provided that the total number of members in good standing among the adjacent counties

exceeds the minimum of twelve prescribed in the bylaws for single county representation. These multi county entities shall be called "regional committees".

A county **or regional** committee which fails to hold a regular meeting in any four month period shall cease to be in good standing. County **and regional** committees shall be responsible for the nomination and campaign of Libertarian Party candidates for county and local offices.

County and regional committees are required to elect their local board and their LPP representative yearly, and they must provide a rank ordered list of alternate representatives to the board.

In Lancaster County, Karl Spangler was re-elected Auditor in Dover. He had been appointed to the job two years earlier, and now he'll return as an elected Libertarian.

Even in those races where we Libertarians didn't win the election, there was still much good news to be found. Wes "Nemo" Niemoczynski did excellently for Monroe County District Attorney with 18% of the vote. Since it's more than 5% in a countywide race, that 18% means we have major party status in that county and can now hold a Libertarian primary there.

State party Secretary Dave Jahn also did well for Glenolden Borough Council in Delaware County, coming

Section 2 - Purpose and Scope of County **and Regional** Committees

County **and regional** committees shall conduct activities consistent with the Constitution, Bylaws, and Rules of the Party.

Section 3 - County and Regional Committee Representation on the Board of Directors

Any member of a county committee who presents a petition to the Board of Directors from the majority of the members of his or her county committee who are members in good standing of the Party (provided that the majority is at least twelve members) shall become the County Committee Representative.

Any member of a regional committee who presents a petition to the Board of Directors from the majority of the members of his or her regional committee

in fifth (top four win). The winners all had approximately twice the number of votes that Dave received, but Dave's total was almost double what he received in 2001, and that was double his 1999 total. Sighting along that trend, Dave's already gearing up for a win in 2005.

In Chichester, Delaware County, the Libertarian Party fielded four candidates for school board. Best was Mark Garzia coming in second out of three candidates with 265 votes (31%) to the winner's 369 (46%) and third place's distant 172 (21%). The Chichester races were unique in that it was the community who came to the Libertarians to ask us to run candidates against the entrenched incumbents. Kudos go to Dave Jahn and the Delco Libs for their outreach efforts to the community!

In Montgomery County, we had an

If at any time such county **or regional** committee shall have fewer than twelve members in good standing of the Party, or upon a challenge from at least three members in good standing of both the Party and such county or regional committee, such person shall cease to be the Committee Representative.

Absent such challenge, any duly elected successor board representative of such county **or regional** committee shall automatically be seated as a member of the Board of Directors.

unusual sort of victory. The county party pulled out all the stops to vehemently oppose a wasteful open space bond measure that appeared on the ballot. The story was quickly picked up by all the local media, with two notable results: First, the liberal Philadelphia Inquirer actually hired me (yes, "hired") to write a column in opposition to the measure. Second, news of the Montco Lib's opposition made it all the way to the Wall Street Journal, page two! The final paragraph of the article was all about the Libertarian position, with Montco LP Chair Jim Babb quoted by name in the final sentence.

2003 turned out to be another great year for the Libertarian Party of Pennsylvania, with a boost in the number of elected Libertarians in the state. Congratulations to the winners, and our thanks to all our candidates.
