"So what are we gonna do in August after we file our 30,584+ signatures?"

As announced briefly in last month's newsletter, the LPP will be fielding its first Congressional candidate this year-investment counselor Bob Graham, who will be running from the 8th Congressional district (Bucks The Graham campaign organization is shaping up already, and it looks like a bunch of sharp, enthusiastic people who are willing to launch an all-out cam-Neither the Republican nor Democrat running against him is an incumbent, another advantage. Graham is already known in his area as an outspoken opponent of big government who should generate support from the business and professional communities. Besides getting ballot status for Bob and laying groundwork for his Congressional campaign, the Graham forces will be helping to get the MacBride-Bergland ticket on the ballot statewide. - It will make petitioning for next year's local elections a lot easier.
- 4. Perhaps most important of all: Due to dreary weather, voter apathy, and the nature of last year's general election, we only need 30, 584 signatures this time around. Four years from now the figure is apt to be substancially higher. If we are on the ballot this year, and we get 2% of the vote, we'll be saving ourselves one hell of a hassle in 1980!

So please, for all of the above reasons (plus any you can think up on your own,) give petitioning serious consideration.
