# "Wussiocracy" on the Hill

Once again those stumbling morons in the Republican Party have blundered into a manhole, and this time

they're going to pull the rest of the country in with them. What they solemnly promised us all last year, in their much-vaunted "Contract with America", was a balanced budget amendment to the United States Constitution that would necessitate drastic reductions in federal spending — and at the same time steer well clear of increases in what each of us is forced at metaphorical as well as literal bayonet-point to send the government for the dubious service of curtailing our lives, liberty, and property more and more each year. While the audience for community access cable television is miniscule compared to the commercial channels, it is nevertheless a market we have never before attempted to reach, and one with great potential.

One of the big problems for the Libertarian Party is that we get absolutely no exposure in the commercial media. When they do mention us (infrequently), it is to make us out to be a bunch of kooks, nuts and weirdos. This would be a way to show a lot of people that we really do have some good alternatives to the conventional parties. If Libertarian ideas were followed, the country and the people would be a lot better off than they are now. We have an opportunity to tell this to the public at very little cost except our own time. It also would be fun to do.

In order to put on the show, we have to do **all** of the work. The cable company only supplies the studio. We would need producers, directors, camera operators, talent, musicians, writers, graphics artists, etc. You don't even have to be a Libertarian to join with the team. Friends, spouses and children are welcome. The cable company will train us in the mechanics of putting on the program, but after that, it is our show.

coin show—by a pair of I.R.S. agents—that his charmingly quaint views about the Constitution were obsolete, and that, in today's America, the tax code takes precedence over the Bill of Rights.

Now contemplate a time, in the not-too-distant future, when Congress is up against it at the end of the year. Americans are hard-pressed, already forking over half of what they earn to federal, state, and local governments, and they're starting to get sullen about it.

"Balance the budget" the Constitution commands, "or you're breaking the law". Not that any Congressman has ever cared about the Constitution before this, or worried much about breaking the law. Despite my better judgement last November, I voted for two Republicans, and now I'm sorry I didn't just "cast a blank," since there were no Libertarians running for those offices. I'll certainly never vote for a Republican again. Their "revolution"— just like their courage and dedication to principle—is counterfeit.

### Reform Local Telecomm? It's Easier Than You Think!

To the telecommunications companies arm-wrestling over the "deregulation" bill going through Congress, the exact procedure for ending local telephone monopolies is of life-and-death importance. But, as should be clear to all, neither their efforts nor those of the politicians can be expected to result in the best of all possible deregulation bills. After all, the phone companies aren't interested in establishing a real free market in telecommunications, and the politicians don't know the meaning of the words "free market."

I have some ideas for ending the telephone monopoly that run in somewhat different directions. You should understand my starting points, however. I tend to prefer solutions that are as simple as possible, as quick to implement as possible, and as radical (in the sense of getting us to our goal by the most direct route) as possible. I prefer to deal with the inevitable problems as they arise, rather than engage in elaborate speculation about future market failures.

The main problem I have with the proposal that the Baby Bells be regulated during the transition to a free market is that it's necessarily complicated, which is what gives everybody such ample opportunity to bury weird things in 800-page "deregulation" laws.

Here's one simple reform: End laws that make it illegal to offer telecommunications service. Assert that regulatory agencies cannot regulate any new entrants, period. Keep everything else the same.

Result: If competition arises, then presumably we're better off. Otherwise nothing happens and we can continue arguing over complex deregulation bills. Note that I envision this reform as taking place immediately, with a one-page law.

Some will argue about the dangers of cream-skimming. It's a difficult argument to maintain: it must be based on the premise that some customers who could be serviced cheaply should be obliged to subsidize those who are more expensive to service. This is an odd argument in that it does not exist in most other markets, so it must be argued that this obligation is unique to certain kinds of services, usually ones already monopolized, like local phone and postal service.

Further, it is usually based on arguments analo-

gous to class warfare: rich businesses versus us poor residents, for example. What makes such arguments especially harmful is the fact that poor inner city residents usually share the same beneficial characteristics for such services as inner city businesses do, namely density. In effect, you want the people of inner Oakland to subsidize your service in, say, Pleasanton. This doesn't sound right, does it? Then there's the sweeping assumption that all businesses are rich and can be gouged for generic subsidies pretty much without impact on themselves, their workers, their products, their customers, or the economy, let alone the underlying principles of a free people.

I'd prefer letting services such as postal delivery and telephones be opened to the market and those in expensive service areas be offered telecommunications welfare vouchers. It would be amusing to see the people in Blackhawk lining up at the welfare office for their phone stamps. But I digress.

Here's another radical instant reform proposal: All existing communications infrastructure is treated as common carrier — PacBell has to sell first come/first serve access to its telephone delivery lines. Likewise cable TV franchises. Both could, of course, charge gouging rates, but they offer parallel delivery systems in most communities and thus would instantly be engaged in competition. If this were combined with open entry to telecommunications markets, the competition would be strengthened because the cable companies would love to offer telephone service too.

This reduces the perceived need to spend billions creating parallel infrastructures. Throw in wireless and satellite and there are some real opportunities. (It would also help if you required local governments to license all comers in the cable TV local markets, ending the cable franchise monopoly.)

Will this work? Who knows? By definition, in a free market people are free to follow their dreams and ambitions. If we knew what those were, we wouldn't need a free market—the free market is, in essence, the means we use to find out what works—the best means. So arguments that we don't know what will happen aren't arguments against a market solution, they are arguments in favor of it.

Pre-patching the holes that we fear may arise is awkward, time consuming, and dangerously empowering of bureaucrats.

## Waco Jury Foreman at Anniversary Memorial

In follow-up to Doug Ohmen's remarks on the Waco tragedy in last month's newsletter, it seems appropriate to continue the dialogue. The following is an edited transcript of a speech given by Sarah Bain at the Mount Carmel memorial service for the Branch Davidians on April 19, 1995, the Second Anniversary of the final assault. Ms. Bain served as the Jury Foreman at the trial of the Branch Davidian survivors in Federal District Court in San Antonio, Texas.

Ladies and Gentlemen I am among one of the most frustrated individuals that probably is walking these grounds today. Frustrated, first of all because we are even here. Why did all of this have to happen, and we even have to be here?

In my opinion there ought to be 120 or 150 Branch Davidians carrying on their daily routines, worshipping, whatever their life entailed still ought to be happening out here.

From the jury standpoint, I have found out so much information that we were not presented with during the trial. That makes me not pleased with what has happened to me personally. The sign over here is one of the very things I think must be answered for. [At this point, Ms. Bain pointed to a large sign near the podium reading, "The Black Booted, Black Suited, Black Helmeted, Machine Gun Totin' ATF Gestapo Are Guilty Of Killing Women, Children, and American Citizens."]

When we finally were in our deliberation stages several of us were voicing frustration over the very fact that there were eleven defendants on trial. One of the things that we found some peace, though it now seems to be a false peace, was in saying, "This was just the first step, there will be more to come, the ATF hierarchy surely will be called to answer for what actually took place."

If it had not been for those in control who ordered the raid we wouldn't be here today, there would be no reason to be here, it would be status quo. There were so many things that should never have happened. I've been... If we sat for seven weeks seeing, hearing wittinesses, seeing evidence, having things... we were bombarded with information, and during that time we would look out across the courtroom and saw the people, supposedly these were the Branch Davidians who had committed these heinous crimes.

And yet at the same time we didn't know these people. We saw one woman, ten men and that's exactly, really, what they were to us, they were not individuals.

It was not until I had the unfortunate opportunity of going back to the courthouse in June for the sentencing phase, that I finally had an opportunity to meet some of the attorneys, some of the survivors, some of the still existing Branch Davidians, that I came to realize more about who the Branch Davidians are, what they represent. And there is nothing, absolutely nothing, I have learned about the Branch Davidians that could ever lead me to believe that they were involved in any kind of conspiracy against our government. Which makes me even more pleased that we came out with a verdict that said they were not guilty of a conspiracy to murder anyone.

All I can see are loving, caring, religious folks who asked for nothing more than to be allowed to carry on with their lives.

When all of this first hit the news media, you're probably very much in remembrance of the fact that some of the things that were being said were that, "Gee, it's a good thing that we stopped this now, because when we got in there, we found these plans that they had, plans of buildings in Waco, and surely they had plans to bomb buildings, or set them on fire, or do horrible things..."

Impossible to believe! When I was going to school over these hills, at Baylor University, I had no idea that there was even a group that was called the Branch Davidians. How such a group could have lived in Waco, and in this area for 35 years, peacefully, and then suddenly turned into a renegade group makes no sense. Anyone with any logic could say that they had no reason to have this thrust upon them.

I am here hoping that, even though I wish we didn't have to be here, something must be done to keep this before the American public, to see that it doesn't happen again, to see that no more children die, and that no more crepe-myrtles have to be planted row on row. Thankyou. □

## Candidates Struggle for Ballot Positions

Many of you who don't receive the *Libertarian Lifeline* on a regular basis may have been surprised by telephone calls last month from candidates requesting your signature on their nomination petitions.

The Libertarian Party is attempting to persuade the Secretary of State to allow us to nominate our candidates by caucus instead of by the primaries that the Democrat and Republican parties stage at taxpayer expense. Since most of our candidates run unopposed, it strikes us as wasteful that we are forced to participate in the primary elections. The Secretary's own accounts indicate that it costs taxpayers more than a million dollars each election to print up ballots for Libertarian Party candidates, all of whom run unopposed (the LP of California has had only one contested nomination in the past decade).

The Caucus system would allow us to nominate our candidates at our own expense, saving the taxpayers millions of dollars in the long run. This past October, the LPC held caucuses to select our candidates, but since it is expected that the Secretary of State would contest the legality of our decisions, candidates were advised to file their nomination petitions in accordance with the old rules. This requires candidates to collect signatures from registered Libertarian voters to guarantee their position on the ballot.

Collecting these signatures is a daunting task, even when the number is quite small. The list of registered Libertarian voters which we obtain from the Registrar's office is very poorly maintained, many of the names and addresses are incorrect, and most of them do not include phone numbers. The Registrar's office cannot be bothered to perform death clearance matching on their database, so many deceased voters remain on the books. You can see now how easy it is for dead voters to end up casting ballots for Democrats and Republicans!

Candidates are under a very strict timeline to collect these signatures, and if they do not collect the required number, they must pay the difference in cash. If you signed a petition for Greg Lyon, Terry Savage, Bob Gough, George Steffner, Wayne Nygren or Terry Floyd, you have our eternal gratitude. Your signature

was worth between \$9 and \$13 to these candidates. The effort necessary to obtain these signatures tests the commitment of our activists, particularly since the timing of the March primary required most of the signatures to be collected during the Christmas holidays when many people were out of town.

Thank you for registering to vote as a Libertarian. We are attempting to raise our number of registered voters by persuading more people to register with the LP. Currently, we have less than 0.5% of the total registered voters in California declaring themselves to be libertarian. We believe the actual number of people who believe in libertarian philosophy to be much higher than that figure indicates.

If you registered to vote as a Libertarian simply because you are disgusted with the antics of the Demo-Publicans, you are probably a libertarian-leaning person anyway. As the ideological lines continue to blur between the two major parties, it has come to seem as if the Libertarian Party is the more mainstream, despite some of our radical ideas. We believe our party represents the true intent of the founding fathers of our country. To quote Thomas Jefferson, "That government is best which governs least." Libertarians believe we are already quite over-governed by politicians who have overstepped their constitutional power. Libertarians believe free people should be allowed to govern themselves. David Bergland, the LP's candidate for President in 1988 has written, "Where today's politicians are power brokers handing out favors to their cronies at the expense of hard working taxpayers, Libertarians hold that the people in government have one simple job to do: protect the persons, property and rights of the citizens; otherwise, leave them alone."

If you are receiving the *Lifeline* for the first time as a result of signing a candidate's petition, please consider subscribing or becoming more active in the local party. We believe libertarian ideas are practical, sensible, and ultimately necessary if our society is to remain free of the oppression of politicians who believe that *they* are better qualified to run your life than *you* are. If you are alarmed by the actions taken by politicians at City Hall, in Sacramento, or in Washington, DC, you would probably welcome the Libertarian alternative. We would certain by welcome you

The Secretary-Treasurer maintains the party's finances, pays the bills that are due, and receives disbursements from the State Party Treasurer. The Executive Committee Representative must attend quarterly meetings that alternate between southern California and Northern California locations. In addition, the Exec Com Rep should have access to a computer and e-mail in order to participate in the on-line discussions that precede these meetings and receive immediate alerts when the ExeCom takes action outside of its regular meetings. Delegates and alternates should make plans to attend the state Convention to represent our region during the Bylaws and Platform debates.

The LP needs more volunteers to help spread the work around to be a more effective organization. If more hands are available, less work will need to be done by each individual, more will be accomplished and more of our goals will be achieved. We have a voter registration drive in progress and need all the help we can get. Please do your part to make the LP a success!
