Good evening, all,

I am the Chair of the Judicial Committee of the Libertarian Party of Idaho, and we currently have a petition before us requesting the expulsion of two party officers from the state party: Robert and Jennifer Imhoff-Dousharm. The named individuals have complained of potential prejudice of some members of the Judicial Committee, but the JC members, myself included, do not agree with their claims of prejudice, and have not recused ourselves.

However, because of this disagreement, the JC thinks that it is possible that the Imhoffs will refuse to participate in any hearing that we hold, and will similarly refuse to abide by any ruling we make. Therefore, we're hoping that there might be some way we could have the LNC or the National JC hear and decide the petition, instead of the LPID JC, in order to offer an option that brings a resolution, without involving the dispute over prejudice.

Does that sound like something that is (a) procedurally possible, and (b) something the LNC may be willing to consider? It would be a great help to us in resolving our internal conflicts without risking escalation to court battles.

I don't know the National bylaws well, so I'll need to defer to rockstars like Ms. Harlos on that front, but the LPID bylaws can be read at https://www.lpid.org/bylaws. The JC also adopted rules in April which are binding and cannot be changed while we have a matter before us; I'm attaching those to this email. I also checked through Idaho statute, and the concept of a Judicial Committee for a political party is not contemplated anywhere I've found, so that shouldn't be relevant.

I have one definite opinion and one strong. The definite one is that the LNC JC is very limited and cannot be involved at this point. The strong one is that neither can the LNC without setting up a terrible precedent. It is often the case that removed people if they think it wrongful will not abide by the decision, it is a matter of what power they have not to abide.

For instance, I did not abide by the LNC or JC decision, but I had no power, so it was mere words. If the Imhoffs hold power AFTER they refuse to abide and claim to still hold the chairmanship THEN the LNC can get involved. If they have no power, you just carry on. No one can be compelled to participate in a proceeding but ID needs to hold its proceeding without involvement from the national party, and then if the chairmanship is disputed after that point, then the national party can get involved.

A word of personal caution - expulsion and removal are very serious. Hire a parliamentarian. Do everything right with full due process. Do your best to avoid national involvement - although I have the utmost faith in this LNC to review issues fairly and justly, the minute you turn things over to outsiders, your fate is in someone else's hands, and it best not to be in that position.

Okay I cannot comment as I am a bit lost here and would not want to opine outside of a meeting, but if it is the LPID's position that all internal procedures have been exhausted and there is some need for an LNC decision, then it would be ripe for Mr. Smith to proceed. But IMHO (and Mr. Smith obviously can disagree), it would be best be heard at an online meeting where there can be full participation, not an in-person meeting on the east coast where the affected people are not likely to be present.

But here is a question to ask internally, and if the answer is yes, do you really need LNC involvement?

Can we continue to function and proceed as the LPID?

There will always be unhappy people in any affiliate that don't agree with decisions, but if they are not impeding the ability of the Party to exist, it is not an LNC matter. Please remember there is a very very narrow scope in which we can intervene. I trust Mr. Smith's judgment as to whether there is a likelihood of a circumstance in which we can which would then be necessary to have a meeting.
