End Public School Monopoly SUPPORT "CQE" INITIATIVE

There can't be anyone these days that's really happy with the public schools. A nationwide study has declared America "a nation at risk" because of increasing illiteracy, and more recently there's concern about "cultural deprivation." Students are simply not being taught needed information; there's no real content either in textbooks or in classroom instruction. All this despite the fact that education consumes 55 percent of all money spent by government in California.

Now there's a great opportunity for Libertarians to take the moral high ground. Rather than pointing fingers and saying "What do you expect? We told you so," we can say, "yes, the situation is serious — here's what can be done about it."

Richard Arnold, a professional petition-drive organizer, has put together the "Tax Credit for Quality Education Act" Initiative, which has been carefully drafted by attorney David Bergland, the LP presidential candidate in 1988. This initiative would enable all taxpayers (including businesses) to receive an educational tax credit to be deducted from income taxes paid to the state of California. This would be for qualifying educational expenses incurred or paid by the taxpayer on behalf of eligible students, whether they attend public or private (including home) schools.

Arnold has formed an organization, Californians for Quality Education (CQE), to field the initiative, and he's lining up a broad coalition of support: private schools, Christian schools, education reform groups, etc.

The initiative is important for two reasons. First, the disaster known as public education must be rectified, and this cannot be accomplished simply by thowing ever increasing amounts of tax money at the schools. As Arnold points out, "we have allowed the State to monopolize education, removing from it the benefits of competition. . .we have made curriculum the subject of unending political lobbying and strife in our courts. . .we have trapped the poor in the worst schools." The public school monopoly must be broken, and education opened to the benefits of competition.

Second, the initiative can be of enormous benefit to Libertarian candidates and the party during the coming campaign. David Bergland writes: "the LP's presidential campaign could cause quite a stir. If we mounted some other equally impressive effort at the same time, the effect could be not merely

doubled, but multiplied. A major initiative could help buoy the LP onto a rising tide in 1988."

On page 3 is an ad by CQE calling for signature gatherers, contacts with private schools and other groups, Libertarian coordinators, crew managers, etc. Study it carefully, there's sure to be some way you can participate. Signature gathering will begin just after the first of the year (candidates can take forms around while their getting signatures for ballot qualification). The initiative has been formally endorsed by the ExCom of the LPC.

Free Forum Update

Last month *CLNews* reported the Oct. 23 raid by the San Francisco Police Department of Free Forum Books, the libertarian bookstore owned by San Francisco LP chair Jim Peron. The cops came to arrest a part-time employee on "morals charges" and proceded to search the place and confiscate records. No charges were pending against the bookstore, but the officers, described by a district attorney as "two cops on a crusade that I can't control," spent seven hours going through everything. They took Jim's personal address book, membership lists, payroll records, letters from customers, signed petitions for Norma Jean, whatever caught their fancy. None of what was taken had anything to do with the charges against the employee. "An intelligence gathering operation" is how one lawyer sees it.

Jim writes: "At this time the bookstore is engaged in costly efforts to force the police to return the stolen items. Legal costs will easily run over \$2,000. . .The D.A. admitted the police want to try to close the bookstore with phony charges but 'didn't have anything.' With no charges pending and the D.A. not intending to file any, the police officers 'on a crusade' are still managing to put Free Forum Books out of business by forcing the store to spend thousands of dollars on legal fees."

November 3 Results

Ballot Measures: California voters seem bent on getting more debt and higher taxes. Incredible. In Alameda County, Marion McEwen (see last month's *CLNews*) was unsuccessful in her last minute attempt to alert the voters to the evils of Prop. C — an initiative to raise the Gann spending limit. But the appearance of her signs and the fact that there was any opposition at all was sufficient to strike terror into the hearts of Prop. C pushers like county supervisor Don Perata. A good deal of press coverage was generated by this Libertarian action, and although voter approval was apparently overwhelming, the actual number of votes cast was quite small. Only 15% of the eligible voters went to the polls, despite massive efforts by the pro-Prop. C people to drum up interest in the election.

In San Diego, a similar proposition to raise the Gann spending limit was approved by voters (Prop. E), but voters did reject the two bond issues which libertarians had written arguments against. Mayor Maureen O'Connor is working to figure a way to circumvent this obstacle.

Local Races: Lee Connelly, chair of Orange County and Region 65, came in fifth in the Buena Park city council race. "I did well, considering my total expenditures of \$10 and my attendance at three candidates forums," said Lee. "I received five percent of the vote total. No signs, no flyers and no precinct walking. Not a bad finish at all."

Alan Carlin finished fourth (16.2%) in the Rancho Palos Verdes city council race — three vacancies, three incumbants, five candidates. He ran a hard campaign and finished only a few hundred votes short of third place.

Hartune Neffian in Visalia and came in fourth in a four-way race for two seats on the city council, just a few votes behind the third-place candidate. In his literature Neffian described himself as "a strong advocate for individual rights," and in public speeches told audiences that "government is set up not to speak for the majority, but to protect the rights of the individual." He stressed the right to property, individual liberties and opposition to zoning, subsidies to developers, regulation of businesses, etc.

Dennis Schlumpf, former northern vice-chair, was defeated 45% to 55% by the incumbant for a seat on the Tahoe PUD.



High Court Rejects Appeal

The U.S. Supreme Court on Nov. 9 refused without comment to hear Norma Jean's appeal, thus letting stand a lower court decision that she be incarcerated at least three years in state prison on a charge of pandering. Earlier this year the California Supreme Court refused to review the case. This means all her appeals are exhausted and her only hope is for a new trial.

Meanwhile, she's been moved to a different facility and has a new address: W27022, Dorm 112, Bed 55; P.O. Box 1800 CRC: Norco, CA 91760.

Cracked Pots in Orange County

Orange County Libertarians have begun bestowing a special. award — The Cracked Pot Award — on politicians, bureaucrats and other authority figures for decisions/actions that infringe upon the personal and economic rights of individuals.


The first award, in Sept., went to Mayor Larry Agran of Irvine for his pushing for a 100 percent ban on smoking in Irvine restaurants. Agran met with chair Lee Connelly and received his award, a cracked flower pot. Lee reports, "We agreed that we disagree on the amount of allowable governmental intervention in the lives of human beings, but I'm glad an open channel has been established. . ." They sure do disagree. To the local paper, *The Daily Pilot*, Agran said that without laws "we'd be urinating on the street and drooling in our spaghetti." Good choice. Give that mayor the Cracked Pot (and perhaps a copy of Bastiat's *The Law*).

The Oct. award went to 32 people — the Orange County Deputy D.A., 19 police officers and 12 jurors that entrapped and later convicted one woman, Pamela Weston of (gasp) prostitution.

Talk about a sting operation. To entrap Ms. Weston, 19 officers from Santa Ana, Irvine and Newport Beach staged a bachelor party, paid for by the taxpayers of Orange County. According to the report, 17 of the cops left with satisfied smiles on their faces — they had to get proof after all. Lee Connelly observes, ". . .crimes like rape, robbery and murder were undoubtedly being committed while this difficult operation was 'going down' — pardon the pun."

Media response has been good, and the recipients of the awards have wanted theirs — you know, 32 flower pots is an awful lot of pots. In fact the response has been so good that a similar award project is planned for Region 65, the Mid-Cities region. Also under consideration is a Liberty Bell Award to be given to friends of liberty. Perhaps *CLNews* is being overly cynical in supposing that candidates for that honor will be a lot harder to find.

Common Sense is Big Hit

The following is from *Alabama Liberty*, the newsletter of the Alabama LP. *CLNews* recommends that every regional chair and local group send for a sample copy (please include a couple of dollars to cover their costs). — Editor.

Here's something that has worked in Birmingham to spread libertarianism and that could be tried elsewhere. It's *Common Sense*, a four-page newsletter for residents of Jefferson County. Depending on the issues covered and the amount of money available, 5,000 to 20,000 copies are printed and distributed each month.

Common Sense discusses local issues exclusively. Libertarianism is woven into the stories without suffocating readers in ideological jargon. Take the lead story in one recent issue. It discussed how a group of doctors in Birmingham has asked the city to use eminent domain to force a number of businesses to sell their property to make way for a clinic. In simple graphic language, the story showed how this was the same as the doctors waving guns in the owners' faces to force them to surrender their property. It further pointed out that the real culprits are the city officials who are willing to take property by force. . .



The most popular feature is "Horrible Mentions." This consists of brief items on recent stupid, arrogant or scandalous actions on the part of public officials. The items are supplemented by deliberately sarcastic editorial comments. Humorous graphics drive home the point. Readers are invited to vote for the "Horror of the Month" — and they do!

Reaction to Common Sense has been gratifying. The editors receive letters after every issue, most of them favorable. Some readers send \$5.00 to get a year's subscription by first-class mail. Callers to local radio talk shows are somtimes heard quoting Common Sense, and sources say copies are circulated through City Hall and the County Courthouse.

Common Sense is an easy publication to do. Its news comes straight from the local media, so little original research is required. A helpful local printer and the party's bulk mail permit keep expenses fairly low.

Restaurant and store owners are starting to help out by keeping stacks of *Common Sense* available for their customers. They can see that Libertarians are people who care about what's happening in the community and who are willing to stick up for the rights of the little guy against the power-mongering local tyrants.

Property Rights Initiative

The heading on the petition form makes it absolutely clear what the Sonoma County Property Owners Bill of Rights is all about: "The purpose of this initiative is to regain property rights lost over the last 40 years."

Specifically, this initiative would require the county to compensate property owners for any property acquired by the county for public use; prohibit "down zoning" unless compensation is made for lost value; abolish the Design Review Board; and require notification to property owners subject to specific zoning changes or general plan amendments.

Initiative authors George and Richard Crane and Harry Wagner have called in outside help—libertarian John Robertson, a veteran of petition and/or registration drives in many statesto get the LP and its candidates on the ballot. Now he's with People for Property Rights and must collect 15,000 signatures by Dec. 20. That's a real challenge. Sonoma Libertarians could help by signing and returning the petitions sent them by chair Jim Oglesby not long ago. Jim mailed about 600 petitions, but only a few have been sent back. Come on, folks. Even if you just sign your own name and don't collect any others, every signature counts.

This attempt to limit the powers of the planners and zoners comes not a minute too soon. As an example of the kind of things Sonoma County residents are up against take the case of Allen Shainsky, who bought an old 29-acre chicken ranch in Windsor, a small town seven miles north of Santa Rosa on Route 101. His plan was to develop a state of the art modern poultry operation handling 90,000 fryers. Unfortunately, this doesn't fit the intentions of the Windsor Chamber of Commerce that wants the area developed into subdivisions, modern business parks and new retail centers for 30,000 residents. Perish forbid that there be a chicken ranch in such an area. Despite the unanimous approval of the Planning Commission, Shainsky's proposal was shot down by the County Supervisors on Nov. 3.

ExCom Resolutions

The LPC ExCom met in Visalia the first weekend in the last meeting before the Convention next February. Three resolutions were approved: a resolution opposing U.S. intervention in the Persian Gulf, one endorsing the Humane Death Act initiative, and a third condemning the San Francisco Police Department for their raid on Free Forum Books.

The second resolution requires some explanation. It endorses an initiative to pass "A Uniform (Model) Humane and Dignified Death Act" which would permit terminally ill persons to seek physician assisted "aid in dying." Bylaws Changes

Lyn Sapowsky was chosen Bylaws Comittee chair at the recent state ExCom meeting. Political Party Rights

On Nov. 2, the U.S. Court of Appeals, 9th Circuit, denied California's request for a rehearing in San Francisco Co. Democratic Central Committee v Eu. On Nov. 17, the same court denied the state's request for a stay of the decision. Unless the U.S. Supreme Court intervenes, political parties in the nine states in the 9th Circuit will be free to structure themselves as they wish and to endorse candidates in their own

California's request for a rehearing had been presented to all 26 full-time judges of the 9th Circuit. Not one of them, including Judge Anthony Kennedy, Reagan's present appointee to the U.S. Supreme Court, voted to grant a rehearing. Nevertheless, the California Secretary of State and Attorney General indicate they are almost certainly going to ask the U.S. Supreme Court to accept the case.
