THE EDWARDS DISGRACE

It is with some regret and no reservations that I inform Nevada Libertarians that the State and Clark County Executive Committees voted unanimously to repudiate the candidacy of Bob Edwards for Clark County Sheriff.

Libertarianism involves a recognition of the universality of individual rights and requires responsibility in conduct. These can be promoted only in an atmosphere of objectivity.

No one is perfect; we each have our quirks. Generally, if we are hurting no one else, they are no one else's business. But it is a different matter when a Libertarian candidate visibly demonstrates prejudices, which he would probably take into office if elected, thereby misrepresenting all of us, as Edwards has done. That Michael Emerling, our State Chair, and I have to answer to media people and to unhappy Libertarians for Edwards's offensive and hysterical conduct and language is our business.

Michael and I have been confronted with other unpleasantries resulting from Edwards's behavior. Media people whom we respect, and whose reciprocal respect we have worked hard to cultivate, have told us that Edwards has lied to them. They don't like that, and they felt that we should know about it. When asked about Edwards, I have personally resorted to saying only, "He's not mine."

I have tried to be tolerant of Edwards up to now. I accepted assurances from those who attempted to handle him that he was coming along and responding to efforts to educate him.

I called Edwards sometime ago to discuss some questionable things he had said (Continued on page 4)

#### LIBERTARIAN CONVENTIONS HELD

On May 15, 1982, the Nevada Libertarian Party held its sixth annual convention. Among the luminaries attending were Jim Burns, Founder of the Nevada LP and Income Tax foe, Florence Fields, 1978 candidate for Lt. Governor, and Tyler Olson, Chair of the Arizona Libertarian Party.

The Conventioneers saluted the tireless recruiting and registering of Libertarians by <u>Donald T. Darling</u>. Almost singlehandedly, Darling took Libertarian registration in Nevada from 300 to over 600!

Election strategies were discussed. The concensus was that the Libertarian Party should focus on three key goals: first, get 5% of the state vote to maintain its ballot status; second, double the number of registered to vote Libertarians in Nevada by May 1983; third, concentrate efforts on one or two winnable races. Allen Hacker's bid for State Senate and George Pataki's run for Clark County Assessor were singled out for special help.

New Nevada State Libertarian officers were elected unanimously. Michael Emerling became State Chair, Dan Becan, Vice-Chair, Donald Darling, Secretary, and John Ketchum, Treasurer.

The Convention appointed Emerling to head up a State Candidates Convention to generate enthusiasm and public awareness of the Libertarian Party. The Convention was set for Saturday, July 31st.

On Saturday, July 31, almost 50 Libertarians attended a well-publicized Candidates Convention at the Union Plaza Hotel in Las Vegas. Among the dignitaries to speak were Ed Clark, 1980 Libertarian Presidential candidate who received almost a million votes, Paul Fisher, manu(Continued on page 4)

#### JOINT EXECUTIVE COMMITTEE MEETS

Officers and activists of the Libertarian Party of Nevada and of Clark County met at the Las Vegas home of Allen Hacker, Clark County Chair, at 8P.M. on September 16, to discuss ways to build the Libertarian Party state and county-wide.

Two parties were planned, to be held the nights of October 21 and November 2, in order to attract inactive Libertarians and sympathizers and get them involved.

Committee members decided to begin publishing a regular monthly newsletter. John Ketchum agreed to handle editing chores, and several others offered suggestions and help.

The committee discussed ways to generate publicity for Dan Becan's gubernatorial campaign. In Las Vegas, Don Darling will arrange news conferences, and William Head will coordinate the campaign. Volunteers are sought to distribute campaign literature.

Allen Hacker gave a progress report on his campaign for State Senate District 6, telling the assemblage that he and George Pataki, Libertarian candidate for Clark County Assessor, spoke at a public meeting for residents of Mt. Charleston. Allen discussed private land use controls, and George condemned high real property taxes in the area. Both candidates were well received. Additional outreach efforts are urged.

Don Darling, Libertarian recruiter par excellence, told the committee that many Southern Nevada members of the nearly defunct American Independent Party (A.I.P.) are planning to re-register as Libertarians. There is reason for concern that, though they are basically libertarian on economic issues, A.I.P. members often take a non-libertarian approach to civil liberties. Michael Emerling, State Chair, agreed to submit an article to the A.I.P. newsletter, The Patriot, explaining basic libertarian principles and their application to today's economic and political problems. Those who agree will be asked to join the Libertarian Party.

Several attendees expressed dissatisfaction with Bob Edwards, Libertarian candidate for Clark County Sheriff. Objections raised were that Edwards is not really a libertarian, that he has taken an anti-libertarian stance on several issues, and that he has behaved in a manner thought likely to damage our credibility. After some discussion, it was generally agreed to withdraw Party endorsement of the Edwards candidacy. Allen Hacker agreed to release news of this decision to the media.

Other agenda items included internal education for Libertarians and generating support for tax relief measures, especially Ballot Question 6.

The next business meeting is scheduled for 8P.M., October 14 at 1212 Smoketree in Las Vegas.

#### HACKER RUNS FOR STATE SENATE DISTRICT 6

Allen Hacker, Libertarian Committee Chairman of Clark County, has filed for the Senate Seat in District Six. This is a brand new district due to the recent "Gerrymandering" to come out of the last legislative session in Carson City.

Hacker will face Andy Mangeris (R) and Bob Robinson (D) in the general. Mangeris is not expected to kick up much dust at this time. It is our feeling that the fight will be between Hacker and the Democrat, Robinson. If Robinson conducts his campaign strictly on the issues, it's going to be a classic. Robinson is a bona fide regulator, and we all know what Hacker will do with that. Feathers are going to fly!

"I'm going to win this one," Hacker said, "I am going to insist that Robinson stand on his record. He's due for a big surprise."

Allen has what appears to be the strongest chance of winning as a Libertarian in the State of Nevada when you carefully examine the facts in District Six. In the last election, 12% of the voters went for Libertarians. There is also a great chance to capture the Republican vote and the split of Democrats who didn't support Robinson.

Hacker and his staff are depending on heavy media coverage due to the interest he created in the senate debates with Paul Laxalt, and Mary Gojack in 1980.

Libertarian candidate for Governor of Arizona. Electricity filled the air at the Convention. Ed Clark showed how Ronald Reagan's administration proved that Conservatives aren't serious about slashing back government. This, Clark argued, gives Libertarians a unique opportunity. Because many Americans want less government, lower taxes, and more liberty, Libertarians must clearly establish that we are the only political party that is absolutely committed to these goals. This will lay the foundations for the re-birth of liberty.

Paul Fisher's speech had one crucial theme: liberty is not a luxury; it is a necessity for the survival of the human race. Without the virtues of a free market, unpolluted with regulations and taxes, the human race is embarked on a slow slide to extinction.

Sam Steiger drew on his decade in the House of Representatives to explain how Republicans and Democrats get suckered into preserving and expanding government, rather than cutting it back. Listeners commented on Steiger's acute insight into the dynamics of social systems, especially the way government really works.

Finally, the Convention endorsed the Libertarian Candidates for state and local office. Some individuals volunteered time or money to campaigns. And almost one thousand dollars was raised for the State Party.

The Convention adjourned late Saturday evening. And Libertarians began committing freedom on an individual basis.

#### BECAN TAKES ON LIST AND BRYANT

Dan Becan, a pit boss at the Reno Hilton, is running for Nevada Governor. A long-time activist, Dan is the former chair and present Vice Chair of the Libertarian Party of Nevada. He has previously run for Mayor of Reno, the State Senate and Assembly, and the U.S. Senate.

Becan is making personal and media appearances throughout the state, and, with volunteer help, is distributing loads of campaign materials including donation requests sent to Libertarians nationwide. His major campaign issue is taxation.

How does he expect to fare against his two major party rivals? "I think the time is right, and people are fed up with both political parties," Dan replies. What about Robert List, the incumbent? "I sincerely believe that with the present state of government on all levels, the present state of our economy, which is caused by government, and the present state of our individual liberties, which are endangered by government, anybody would be stupid to vote for an incumbent." Becan criticizes List's support of the 5 3/4% sales tax.

Another well-known incumbent, who had promised to get government off our backs, comes in for criticism. Ronald Reagan "will go down in history as the tax collector." Becan cites Reagan's hiring of extra I.R.S. personnel and his new tax bill, which "has a provision to tax waitresses, waiters, bartenders, cab drivers, and other tip earners 10% of the total business they do." Dan holds that many tip earners do not receive 10% of gross sales. He estimates that the additional taxation "would result in a minimum of \$80,000,000 leaving our state for Washington, D.C.," which would ruin our already depressed economy. Tip earners are not the only losers. Others, such as merchants and their employees, whose income is largely derived from tip earners, would also be hurt.

The situation is already desperate.
"The I.R.S. claims \$60,000,000 of unpaid taxes are owed by dealers and is now pressuring employees and employers to pay up or suffer the consequences."
Becan points to Las Vegas's disproportionate number of I.R.S. agents, whom he likens to the Soviet K.G.B. He says

that the I.R.S. promise to casino dealers of non-prosecution for undeclared tips in past years, if the dealers will submit to I.R.S. demands, "is one not even the President can make and is pure and simple fraud."

Dan claims that tips are gifts, and, as such, are not subject to taxation. As Governor, Becan will instruct the Nevada Attorney General to fight I.R.S. efforts to force people to declare tips as taxable income. If necessary, he would take the issue to the Supreme Court.

Becan would put further heat on Washington to reduce federal meddling in Nevada. He would have the Attorney General's office examine federal involvement in our state for possible legal violations. Becan indicates as areas of investigation alleged F.B.I. bribery attempts, nuclear testing, and nuclear waste dumping in the State.

Dan would also work to cut back taxation on state and local levels. This would involve government cuts to match tax cuts. Becan advocates use of "sunset" laws to abolish useless agencies, such as the real estate division, the dairy commission, and the Nevada Industrial Commission. Locally, money could be saved by privatization; that is, by turning, for example, police and fire protection over to more efficient private firms. Costs could be further reduced, and freedome further expanded, by decreasing the number of laws to be enforced, such as laws dealing with prostitution, the possession of guns or marijuana, and other victimless crimes.

The goal is to cut back government to the function of protecting people's lives, liberty, and property from acts of agression by others. Dan Becan's position can be summarized in the phrase "less taxation, less government, more freedom."

Dan estimates that at least 60,000
Nevadans have voted for at least one
Libertarian. A like number could vote
for one candidate. "Less than 50% of
those eligible to vote voted in the last
election, so a maximum of 25% of the
voters did the electing. If I am not the
next Governor of Nevada, it means you or
your neighbor did not think your vote
counted or forgot to register or vote.
Remember, bureaucrats have a vested interest in voting!" (Continued on page 4)

But we Nevadans have consistently donated to outside Libertarian campaigns — even to the detriment of our own state party — to the extent that Nevada has remained in the top ten of contributors to Libertarian campaigns outside Nevada.

While National and other Libertarian groups have financed Libertarian candidates and objectives outside our state with substantial contributions — including funds obtained from Nevada — we in the Nevada party have never asked for equal consideration.

We are asking now. Freedom lovers, now is the time to come to the aid of your party. Give libertarianly.

in a mailing. He received my comments rudely, saying that he was exercising his freedom of speech, that he didn't want any "Party censorship," and that he had a "special relationship" with the press. Some relationship.

The facts are these:

-Edwards changed his registration to Libertarian the same day he filed for Sheriff, having previously failed in a bid for the office as a member of another party.

-He has made statements and taken positions on issues that are anti-libertarian.

-His behavior has put our relationship and credibility with media people at risk.

Even if everything else is unfounded allegation, there is enough here to offend even the most tolerant among us.

I suspect that Edwards joined the Libertarian Party only to gain a free ride to the November elections. That's not the alternative we want our organization to be perceived as being.

When the Charter was written in 1978, we anticipated situations such as this one, and we realized that we could minimize damage resulting from opportunism and misrepresentation by including within our rights as a party the option of disavowing a candidate.

Edwards, and others like him who may happen by in the future, should heed this fact: While anyone who wishes may register Libertarian, and may file for office as such, we are equally free to disown him. We may have to contend with such people occasionally, but we have no obligation to tolerate them.
