

Libertarian wins city council seat

Villa Park activist Bob Patchin credits long-time civic involvement

"I believe in the maximum of personal and property rights, and the minimum of tax and government interference in your life."

This quote is from the campaign flier of winning Villa Park City Council candidate Robert I. (Bob) Patchin, who came in first out of six candidates vying for two open seats.

"It all started a couple of years ago when the city made plans to build a civic center in my neighborhood." Patchin told fellow OCLP

members at their November meeting.

Patchin began attending council meetings regularly and raising such a ruckus that the council invited him to join a "Civic Center Evaluation Committee," apparently in hopes of shutting him up. Instead, as a result of his committee involvement the city wound up canceling the civic center project.

Not one to rest on his laurels. Patchin continued to be involved virtually full-time in civic activities (which as a retiree he was able to do). His involvements included helping produce a summer concert in 1991 and a "Pageant of the Pledge" event in 1992 for the city's school children, working with the local Water Conservation Committee to come up with a less stringent water conservation program, and developing a viable plan for the city's recreational pathways.

"I became known as the guy who cuts through all the confusion to the core issues, the guy who always does his homework," Patchin said. He also developed a reputation as a tough fiscal watchdog determined to minimize government spending.

Patchin recalled an occasion in which the school district announced it would hike fees for the use of its facilities by Little League sports teams. The Little League sought a subsidy from the city to cover the extra cost, but Patchin dug in and fought, successfully, what he decried as a city subsidy of the area school district. He said when some accused him of being insensitive to the needs of the city's children he was able to point to his involvement in the summer concert and "Pageant of the Pledge" as proof that he did care.

In his \$950 campaign for city council, Patchin said probably the single most important thing he did was print and post 200 yard signs around the city. "I hate those things, but you've got to have them or else people don't get the sense that you're for real." He added that after the election he made certain that all the signs that had gone up were taken down.

Major strategy session set for January

National, state and local Libertarian Party officials and activists are expected to converge in Pomona on Sunday, Jan. 17 for a post-election strategy conference and brain-storming session.


The event, titled "Where Do We Go From Here?" is to be held at the Pomona Valley Mining Company, sponsored by the Libertarian Party of Los Angeles County and directed by Gail Lightfoot, with assistance from Jerry Collette.

"This is not an outreach event," Collette explained. "It's mainly for activists and candidates, to take what we've all learned so far and come up with new ideas for the future. We want people to come here with their ideas for what to do next."

The gathering will commence with a brunch buffet beginning at 10 a.m., with the program following at 11:30 a.m. until 4 p.m., Collette said.

Prepaid admission before Jan. 9 will be \$20. Those reserving admission before Jan. 13 will pay \$24, and unreserved admission at the door will be \$28. Those who wish to miss the brunch and just

Paid-up party members are eligible to join Orange County's delegation to the convention. Those interested should call the party office at 540-5053 or attend the December meeting.


