## H. R. 2320

### A BILL

To enforce the guarantees of the first, fourteenth, and fifteenth amendments to the Constitution of the United States by prohibiting certain devices used to deny the right to participate in certain elections.

#### Summary:

An individual's right to be placed on the ballot, along with "party, body, or group affiliation," for a federal election shall not be denied or abridged. The only requirements a state may impose for ballot access will be petition or party vote, limited as follows.

#### PETITION

Number of Signatures: the greater of a) 1000 or b) 1 tenth of 1 percent of the registered voters who voted in the last election for the office.

For us in 1986, that means 1000 signatures! Compare that with 25,000 (read 40,000).

Who Can Sign: "persons residing anywhere in the bounds of the geographic area from which an individual is to be elected to such office.

They don't even have to be registered voters!

Time for Petitioning: a minimum of 210 days--beginning not later than 270 days before the election, and ending not earlier than 60 days before the election.

Compare that with 90 days, ending three months before the election.

#### PARTY VOTE

No need to petition if the party got the lesser of: a) 20,000 votes, or b) 1 percent of the votes cast in the most recent election for President or U.S. Senator.

The states have the option of this requirement in lieu of requiring a petition as circumscribed above. You can bet the Illinois General Assembly will choose this option.

If H.R.2320 passes and goes into effect in 1986, the LP will BE ON THE BALLOT! because Steve Givot received 1.249% of the vote in 1984.

#### WINGER UPDATE ON HR 2320

The latest word from LP Ballot Access Consultant Richard Winger is as follows.

"Everyone who supports this bill should write two letters: 1) to your Congressman or Congresswoman, asking that he or she cosponsor the bill; 2) to Congressman AL SWIFT, Chair of the Subcommittee on Elections of the Committee on House Administration, 802 House Office Bldg. Annex 1, Washington, D.C. 20515, asking him to hold hearings on the Bill in the Fall (earlier hearings on it are out of the question).

These recommendations are from Nancy Ross of the New Alliance Party. She is working full time in Washington, D.C., as a lobbyist for the Bill. Her phone number is 202/737-1020 (office); the office address is 1010 Vermont Ave. NW, #315, Washington, D.C. 20005. I have met her and she is a pleasure to work with. It was the New Alliance Party that did all the work of finding a Congressman to introduce such a bill. She eagerly wants our help."

How about it, Illinoisans---is she going to get all the help we can give her?

Even though you probably have already written to your Congressional Representative and Senators Dixon and Simon, as requested in the last issue of the ILLINOIS LIBERTARIAN, write again---this time asking them to cosponsor H. R. 2320, and introduce an identical bill in the Senate. And write to Congressman Al Swift (D, Washington). The way things are going, a Democrat might not need too much encouragement to facilitate ballot access for independent and alternate party candidates.

First, think about the summer of 1986 and of gathering 40,000 signatures to get our candidates on the ballot---and about the fact that the required number of signatures may be even higher in 1986.

Then, write in your Congressional Representative's name (first & last) on the line at the top of the petition enclosed in this issue of the I L and his/her last name on the line in the third paragraph. Make zerox copies of the petition, and go to work.

As when we petition to get on the ballot, tell people that the Republicans and the Democrats get on automatically, but independent candidates have to get 40,000 signatures---in 89 days! Tell them that this bill, if it becomes law, will prohibit the R's and D's in the state legislatures from imposing these and other restrictive requirements they might think up to keep out competition in Federal elections (for President, Senator, and Representative in Congress).

If you are wavering a little bit---wondering whether you are willing to petition in a "non-election year," think about how you'd like the dollars you are able to contribute next year to be spent.---Do you want a substantial portion of them to go again to paying people to help us get enough petition signatures just to get on the ballot? Or would you rather they be spent on media time to get our message out to the voters?

Now that you've decided to gather signatures, send your petitions to me (address below). I will zerox them and send one copy to your Representative, one copy to Congressman Swift, and one copy to each of our U.S. Senators. PLEASE send them to me BEFORE August 1.

from the NATIONAL CHAIR

Randy Ver Hagen of Wisconsin was elected by the National Committee of the Libertarian Party at its meeting in Seattle in April to serve as Chair for the remainder of Paul Grant's term. Paul had resigned earlier in the month and the Chair for the 1985-87 term will be elected at the National Convention in August.

The purpose of this writing is to formally announce my candidacy for the position of Chair of the Libertarian Party.

In the time that I have been Chair, I have gained a significant insight into the problems that our party faces today. Though we have faced worse crises and have weathered them in the past, that does not diminish the fact that we are in a considerably less than desirable condition at this time. Nor is the fact diminished that we have not adequately learned our lesson.

The single greatest lesson that we should have learned by now is that "black ink is a necessary operating condition." I am committed to black ink, and we are going to take the necessary steps to regain that status.

I am not naive as to the difficulty involved in the above statement. However, I am assembling the necessary systems to right our convoluted course. I am developing a "nuts & bolts" program to get us moving again, in a direction that truly can be adequately supported.

We must spell out specific goals, such as: electing at least one Libertarian to public office in every state, maybe even in the Spring of '86; developing three separate campaign manuals that deal with specific issues in the three different campaign arenas, Federal, State, and Local; and monthly production of LP NEWS---to name just a few.

In other words, we must have a vision of what our party can be, and work accordingly. If the manifestation of that vision requires change, then we must change, regardless of the tenure of person or program. We must put the days of grandiose axiom behind us, and get set for the days of practical application ahead of us.

We elected more people to office in 1984 than in any other year. We raised over one million dollars last year. But we must see this for what it is, the past. It is time now to show our resiliency.

There are 38,000 more federal employees now than there were during the Carter administration. To my way of thinking, that is proof enough of the need to drive on. If government were getting smaller, perhaps we could relax a little. Since that is not the case, we must grow and get much stronger, and set a course that will make that possible.

It is my sincerest hope that our membership

and their delegates to the National Convention will possess the necessary vision to profit our party. The benefits of such vision will be measured in future successes. We can be successful, so we must be successful.

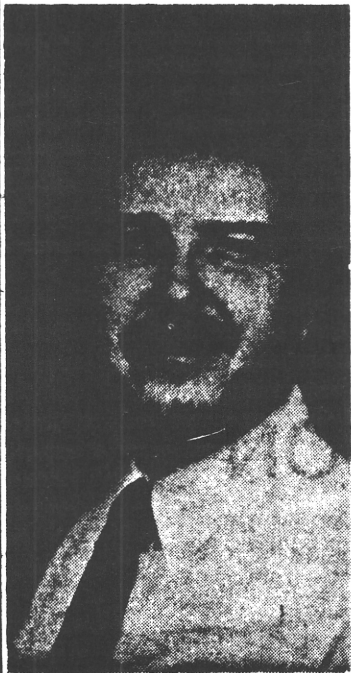

# Another Look

## Philly fascism

The smoke from the fire had not cleared before smoke started to pour from Philadelphia Mayor Wilson Goode, obscuring the facts in his handling of his operation to remove members of MOVE from their home.

Police were attempting to evict MOVE residents from their row house for alleged health code violations at first.

Tear gas did not force the residents to leave their home. Water from a high-pressure water cannon collapsed a portion of one wall of the home; yet none of the residents came out.

The situation had taken on aspects of a standoff, the police were prepared for a siege.

Wilson Goode, lacking at least the virtue of patience, agreed to allow an explosive device to be dropped into the home. Goode claims he had evidence proving MOVE members had enough explosives to destroy an entire block.

Wilson Goode went one block further.

Goode claims explosives were in the house; then Goode claims he would not have allowed the use of explosives if he thought they might start a fire.

Investigators sifting through the rubble have not found the explosives or automatic weapons Goode claims were in the home.

None of the 11 who died in the holocaust, including the children, were killed by police bullets. All died in flames.

Goode says he and police commissioner Gregore Sambor accept "full responsibility" for the blaze which killed 11, destroyed 61 homes and left 270 people homeless.

In a word, that claim is crap.

Goode's "acceptance" is for the city, not for himself.

But the "city" did not come to Goode and say, "Burn this neighborhood." Not one of the individuals who lost a home urged Goode to "Destroy my home, burn my family's memories, my clothes, all my belongings to help me get rid of a few offensive neighbors."

The "city" did not allow 61 homes to burn, 11 people to be killed, 270 people to be left homeless. Wilson Goode and Gregore Sambor did.

Goode's claim that the city was at "war" is ludicrous, without legal or moral justification. Goode cannot hold some abstract institution responsible for the acts of individuals. Only individuals can act; individuals must be held liable for their actions.

Goode's idea of acting "for the public good" is one of mindless brutality, wanton destruction and callous disregard for the individual's right to life and property. He shows no remorse; he insists he would do it again.

Goode and Sambor must be held personally liable for both actual and compensatory damages; they ought to be held liable

as criminals for violating the ultimate civil right — the right to life — of the 11 people burned to death.

What's most appalling is the lack of outcry or outrage by virtually every political figure in America against Goode's blatant use of Nazi terror tactics violating fundamental human rights.

Officials so quick to denounce human rights violations in other parts of the globe should have been equally quick to demand respect for those rights here in America.

Instead, the sounds of the silence are deafening.

None of the voices arrested in front of the South African embassy in Washington, DC, has been heard in protest of Goode's actions. None of the elected officials on Capitol Hill so eager to give or withhold foreign aid based on human rights considerations has been heard in protest of Goode's actions.

Their willingness to tolerate at home the very behavior they condemn abroad is a silent testimony to the world of the hypocrisy of our political leaders' self-serving "dedication and commitment" to individual human rights.

Wilson Goode says he was at war.

Wilson Goode's personal war killed 11 people.

Americans have a place for people who conduct such wars, who destroy property, who ignore fundamental human rights, who kill people.

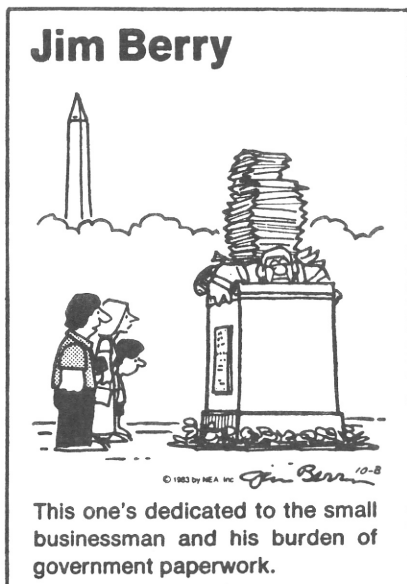

GOOD NEWS...the CHICAGO SUNDAY TRIBUNE ran a front page article on private, for-profit prisons.

Governor Thompson's 2.3 gigabuck (billion dollar) pork barrel reelection scheme (also known as "Build Illinois") was sent to the General Assembly. The Representatives there saw fit to add their wish list items to Thompson's wish list. The total is now 4.4 gigabucks. Children over the age of ten know that Santa Clause sends a bill. Do the voters/taxpayers of Illinois know that?

Arthur D. Little Co. has reported to the Illinois General Assembly that the 1992 Chicago World's Fair could lose up to \$350,000,000. Usually this would be that business's problem; but there are bills pending to fund the Fair with Illinois taxpayers' money. The 1984 Olympics did very well financially, but that may be because there was no taxpayer bailout. The last three World's Fairs, all publicly subsidized, have lost money.

THE NEWS IN BRIEF, 1997...Senator Paul Jacob introduced a bill to allow the sale of the Washington, Jefferson, and Lincoln monuments. The Washington Historical Society, a subsidiary of the Sierra Club, has expressed an interest in buying the properties...In the Ukraine, the rebels have control of Georgia. The negotiations between the Soviet government and the Ukrainians continue...The Supreme Court today awarded a 5000 square mile tract of land to the Zuni Indians. The Court declared that the U.S. Government was in breach of contract, reverting title to the land to its previous owners...And, finally, Congresswoman Xaviera Hollander has announced that she will not seek a second term. The former "Happy Hooker" declared that she was willing to try anything once, but she prefers her previous profession to screwing the public as a member of the legislature, mainly because she dealt with a more respectable type of person.

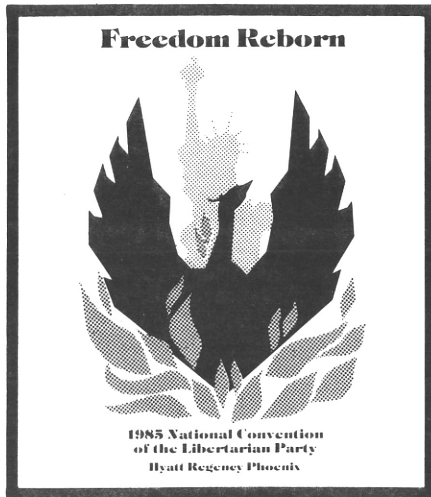

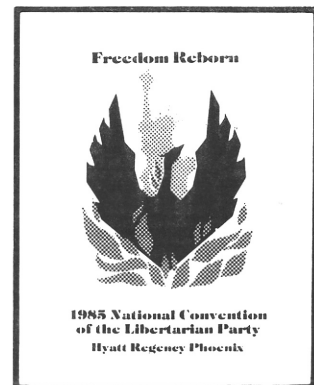
