Newcomer wages quiet campaign for Congress

Excerpted from story by Carol Baker, staff writer, The Daily Breeze (Redondo Beach), that appeared in Monday, Sept. 5, 1994 edition.

"Who is Guy Wilson? And what's he doing running for Congress?"

SOUTH BAY voters may never know the answers to those questions, mostly because Wilson is in no position to finance the kind of campaign needed to introduce a political unknown - himself - to the public at large.

So, for the record, Wilson is the Libertarian candidate running in the 37th Congressional District that takes in Carson, Gardena, Harbor City and San Pedro.

He also is the only challenger to U.S. Rep. Walter Tucker III, the freshman Congressman and Compton's perennial favorite son recently indicted for allegedly accepting \$30,000 in bribes during his tenure as Compton's mayor. There is no Republican in the race. Thus, the lineup in the November election pits Tucker against Wilson, a little-known merchant seaman from San Pedro whose biggest attraction to voters may be that he doesn't face criminal charges.

Last month, Tucker, 37, pleaded innocent to 10 counts of extortion and income tax evasion, branding the charges a racist result of widespread law enforcement efforts to target prominent African-Americans.

In recent weeks, the Congressman has focused on trying to raise money for his legal defense in the federal case scheduled for trial in February, and sees no apparent need for campaigning.

That suits Wilson just fine. In general, he tries to ignore Tucker, the same as the congressman does him.

Taking to the streets

Like many political neophytes, Wilson, 34, generally prefers to talk about his philosophies, the issues and his optimism about a campaign he has taken to the streets, commuter trains and buses.

"Just because I'm new on the scene doesn't mean I don't have a chance" of winning, he said in a recent interview.

Pressed several times for details about how he thinks

the charges against Tucker might affect the race, Wilson said curtly: "Are we only going to talk about him?"

But he said he was pleased with the timing of the indictment, which he learned about in a telephone conversation with his wife, Tina, after his ship pulled into port in Washington during his latest stint at sea.

"I just went, 'Yes!" Wilson said, clasping his fist in a victory sign. Wilson blasted Tucker's contention that the federal case was racially motivated.

RICHARD B. BODDIE, Libertarian candidate for U. S. Senate followed Ross Perot onto the podium at a Perot Rally in Orange County in September. Boddie reported that the Boddie for Senate booth set up by Orange County members was kept busy answering questions about the Libertarian Party and the Boddie Senate campaign

Boddie went on to say, "When I came to the door (the entry for exhibitors and speakers only) and was asked who I was, another person there said, 'Oh, that's Dick Boddie. He can come in.' I was in my element, having a great time." After Perot finished his longer speech in the main arena, he spoke briefly at a podium in the exhibit area along with 2 other individuals. It was then that Boddie was given the podium. "Republican or Democrat - take your pick. It makes no difference." Boddie told a crowd of some 100 people gathered around the exhibit area podium. His less-than-three minute explanation was well received by the attentive crowd.

"I can tell you, when I get to talk to people, they like what I have to say." Boddie said. "We were able to hand out not only my position papers as the Senate candidate byt Libertarian Party literature and copies of *California Liberty* as well."

POLLING: The Mirror As Others See Us

THE ORACLE at Delphi once said. "It is a gift to see ourselves as others see us!" George Gallup might have replied, "For those without that gift, take a poll!"

What is a poll? The dictionary says it is a "canvassing of a select or random group of people to collect information or uncover popular opinion." It can be done by phone, by mail, or in-person. It can be scientific, or quick-and-dirty.

Even if you read this column after election day, I still

maintain that there is still lots of polling left to do. Surprised? Let me explain.

Polling is not just for candidates. Of course, I hope all candidates have asked many, many voters their opinions on many things, and then turned around and applied that knowledge to make themselves, and future candidates, look and sound better than

Polling is not just for Big Tuesday in November. Of course, there is lots of polling to do to find out where our candidates stand in relation to the competition.

After election day, after the campaigns, the polling

Here's a poll I did that I recommend to you: Just a

couple of years ago, I ran for State Assembly. A few weeks after election day, I received the statistical breakdown of my race, precinct by precinct. I was curious about why precincts varied in percentages from 1 percent to 8 percent in my vote totals. Instead of guessing why and setting aside the report, I decided to ask the voters themselves. I picked one precinct where I had my highest percentage. I walked that precinct on a Saturday and Sunday with a copy of the sign-in sheet of that precinct's polling place, so I could ask true voters (not the home-bodies who are registered but never vote) explicitly for whom they voted in my race, and why.

May I suggest that in late November, you walk a precinct and say this script: "Hello, is Jane Doe home? Hello, Jane. My name is Kim Goldsworthy. I ran for Assembly this year, so you may remember my name from your ballot. Do you remember? Well, I'm thinking of running for office again next year, so I'd like to ask you, as an average voter, what influenced your decision in the voting booth — Do you have five minutes to help me learn how I may increase my vote totals next time?'


What I learned from listening to each person who took time to help me, that's another column — things I have never read in any campaign book — Precious, and

(Just to tease you, here are three things voters shared with me: How the winning candidate established name I.D. in this particular voter's mind; The importance the sex

of the candidate can play; The short memory of vot-

Try a variation or two. Poll a precinct to ask about whether the average voter knows the difference between the Libertarian Party and the other parties. Do a live 'Operation: Politically Homeless' quiz as part of a "city wide sur-

Still on my wish list, I have been waiting for the national Libertarian Party to do a nation-wide poll to ask Americans the questions: (1.) "What do you know about the Libertarian Party?" and (2.) "Overall, is it a positive, a negative, or a neutral feeling you have toward their can-

didates and their platform, as you understand them?"

Another example: Did you read the Libertarian Party 200-word statement in the Voter Pamphlet? A poll helped formulate the final version. The final published essay was a carefully designed creation of the most positive, powerful sentences/phrases from a half-dozen very-different drafts. Credit must be given to Lawrence Goldberg of Burbank, an experienced sales professional, whose words and phrases comprise more than 50 percent of the final 200-word essay. His phraseology consistently scored high, according to the impartial reviewers who read each draft, circling words and phrases that were positive, and striking words and phrases that were turn-offs.

In closing, for me to keep doing my job well, I need to poll you regularly. I depend on each county, each region, to tell me, and the Executive Committee, how goes the battle. Each quarter, I read the Northern and Southern Libertarian Party of California

Liberty Scorecard

THE BASEBALL strike ruined August for me; and with it entering week four as I write this, September and October do not look very promising. so I decided to keep score on our progress against the state. On balance, at least in the short term, the news on that front isn't good either.

First, the Good News:

- Aug. 1. The state Supremes unanimously held that a state law prohibiting age discrimination in employment exempts businesses with fewer than five workers.
- Aug. 5. The Defense Department has made it clear that it does not intend to implement Barbara Boxer's plan to use National Guard troops to hinder illegal immigration.
- Aug. 9. Thanks to Willie Brown's efforts, on a tie vote, the Assembly Ways and Means committee rejected a bill that would have authorized paddling as punishment for youthful vandals.
- Aug. 22. The Assembly defeated a proposed two-cents-a-pack cigarette tax hike to raise money for prostrate cancer research.
- Aug. 23. The L.A. City Council (10-1) called on Mayor Riordan to declare an AIDS state of emergency, a move that would encourage the LAPD not to enforce laws against distribution of clean needles to drug users.

Bad News:

- Aug. 5. Reminding us once again that U.S. imperialism survived the end of the Cold War in good health, NATO jets attacked positions in Bosnia.
- Aug. 5. Back on our side of the world, the Senate (63-31) defeated a bill that would have barred Clinton from ordering an invasion of Haiti without congressional approval.
- Aug. 11. Providing more evidence that federal criminal statutes threaten protections against double jeopardy, a teenager acquitted of murder in New York state court was charged in federal court with violating the victim's civil rights.
- Aug. 12. The Fourth Circuit (1-2) stayed a lower court ruling which would have required The Citadel, a state-supported, all-male military academy in South Carolina, to admit Shannon Faulkner as its first female cadet.
- Aug. 18. The Clinton Administration forced the resignation of Jean Hanson, the Treasury Department's general counsel, whose testimony contradicted Roger Altman's accounts of contacts between the White House and Treasury officials concerning the Whitewater affair and who also indicated that Treasury Secretary Bentsen kwew more about the case than he claimed.
- Aug. 19. In a ruling which restricts trial court judges' sentencing discretion, the Ninth Circuit (3-0) ordered longer sentences for Stacy Koon and Laurence Powell, two of the

- cops who beat Rodney King. More troubling, although it received virtually no media attention, the court also ruled that their second trial on federal charges did not subject them to double jeopardy.
- Aug. 20. U.S. imperialists again acted closer to home as Clinton announced a ban on cash remittances to Cuba and new restrictions on flights from the U.S. to Havana.
- Aug. 23. Facism-in-the-Schools Dept. Wilson signed legislation allowing school districts to require that students wear uniforms.
- Aug. 23. Back East, school officials in Georgia suspended a high school teacher for disobeying a state law designed to circumvent the constitutional ban on state-sponsored prayer in public schools by mandating a daily minute of silence.
- Aug. 25. The Senate passed the Crime Bill. The fight in Congress focused on spending (although Republicans objected to only a portion of the \$30 billion total) and the assault rifle ban. But it's pathetic that there was so little opposition to the death penalty for fifty more federal crimes, massive spending for prison construction (\$9.85 billion) in a country which already imprisons a higher percentage of its population than any other in the world, and the increasing federalization of crime.
- Aug. 25. A Los Angeles County Superior Court Judge issued an injunction against 22 gang members which, among other things, sets a 10 p.m. curfew for members under 18 and a midnight curfew for adults. The injunction enables the authorities to charge gang members with violating the injunction even if they lack the proof needed for a criminal conviction. Violators face up to six months in jail and a \$1,000 fine.
- Aug. 30. The California Supremes let stand a San Francisco Superior Court ruling that the state cannot cut welfare benefits under the Aid to Families with dependent Children program without federal approval.
- Aug. 31. Although the Ninth Circuit upheld a District Court order requiring the Navy reinstate a gay sailor, it reversed the lower court's decision that the military's policies on gays are unconstitutional. The Appellate Court ruled that the military cannot discharge someone simply for being gay or lesbian, but can prohibit homosexual conduct.

Green reports that as of September 14, two months away from the election, he had attracted over two dozen volunteers and an active campaign staff. According to Green, "Their generous contibution of the only truly unrenewable resource — their limited time — has freed me up to carry out tasks I would not have been able to consider without their help. I am very grateful for their support. It also tells me that my message of fiscal responsibility is being well received. People are responding to my campaign literature, where I suggest that we should watch how people spend money that they themselves did not earn."

Savage Secures Second PAC Endorsement

"CALIFORNIANS Against New Taxes" has endorsed Libertarian candidate for the 20th Assembly District. Given Savage's clear anti-tax position the endorsement would be obivious if he were a Democrat or Republican. For Libertarians, however, support from PAC's is a major breakthrough. This follows and earlier endorsement by spacePAC, an organization that has supported increased private enterprise efforts in space development.

Libertarian Tops Republican Fundraising

IN A MAJOR financial milestone for the Savage for Assembly campaign, the team raised more money than the Republican candidate did during the entire 1992 campaign. As of September 23, 1994, the Savage Breakthrough Team had rasied over \$30,000 compared to the total of slightly over \$17,000 raised by the Republican running for the seat in 1992.

"The days when Libertarians couldn't afford to run an effective race have passed", Savage said. "We're already ahead of the Republican in the last election in this district, and we're closing in financially on this year's candidate. we'll clearly have enough money to implement our strategy for getting our message out to the voters in the last few weeks of the election."

Savage acknowledges that they are unlikely to reach the fundraising level of his Democratic opponent, who has the backing of the Democratic party machine and liberal special interests. "We'll just have to spend smarter to win", says Savage.

Continued from page 1-"As a black man, I know what kind of bill we've been getting since we've been here," said Wilson, who grew up in South-Central Los Angeles. "But instead of crying about the problem, we should be doing something to alleviate it." Tucker only has himself to blame, Wilson said. "He got caught with his hand in the cookie jar, (His) history speaks for itself."

In 1986, Tucker was fired from the District Attorney's Office after he admitted falsifying evidence. Felony charges against him were reduced to a misdemeanor.

Returning Tucker to Congress could prove more trouble than it's worth, Wilson said. "If the voters elect this other gentleman and he gets convicted, they're creating another headache because they'll have to start all over again.

A step forward

"If they elect me, we can move forward and forget about him." Despite the criminal charges, Tucker would be hard for a Republican to beat, mostly because the district is 76 percent Democratic, experts say. You've got a (political) machine in there," said John Peschong, acting executive director of the California Republican Party. "But if (Tucker's) forced out of office, I think we will probably have the best chance ever of winning the seat.

For now, Wilson relishes his one-on-one race against Tucker.

"I look at it as an opportunity for people to really begin to look at another political party with fresh ideas and say, 'Maybe we don't have to vote for the same political party out of habit."

A fiercely independent man, Wilson finds it frustrating when voters turn down his campaign pitch just because he's not a Democrat. Playing the political game isn't easy for him. Sometimes, he said, it's a challenge holding back the tough sailor side of himself. "I have to be more polite now, which is hard because I'm used to saying what I feel."

At home on trail

But he's comfortable on the campaign trail, especially in urban neighborhoods like the one he grew up in. "I let people know there is someone out there who is one of them."

Wilson attended high school at Westside Academy, a now-defunct private school in South-Central Los Angeles. At 19, he followed in his father's footsteps and became a merchant seaman, delivering cargo to local ports. He moved to San Pedro, away from his neighborhood buddies, "who are still in the same place where I left them."

Wilson was a Democrat until he became a Libertarian in 1992, after watching the party's presidential convention on C-SPAN. 'For the first time in my life, I saw that here's people speaking my language," said Wilson, who found the Libertarian focus on individual freedoms appealing.

"After the (convention) was over I went straight to the post office and registered Libertarian," he said.

He soon got involved in local party activities. With the congressional race, he spotted an opportunity to act on his new-found political persuasions. "This is a big step I'm taking, one of the biggest I've made."

Two-Year Plan to End Welfare

AS USUAL, the bureaucrats come up with an expensive complicated "reform". I've got a better idea on stopping the theft of taxpayer dollars for welfare:

- 1. Effective immediately, no new welfare recipients;
- 2. In three months, with plently of warning, all able-bodied adults without children are eliminated from the welfare rolls;

Question: Why is the LPC not on the "endorsement list" of the "No on 187 (or "Taxpayers Against 187")? Answer: The LPC ExCom voted "not to endorse" Prop 187 in April 1994 after being asked to do so by the proponents of the measure who came to us even before the actual ballot wording was finalized. Since then no further "official" action has been taken except to notify the pro-187 team of the vote's outcome and advise our members and the general public of the LPC's opposition to this measure.

In consultation with Jon Petersen, who is both LPC Treasurer and campaign manager of the "Terry Savage for State Assembly", he pointed out that Mr. Savage supports Prop 187 (as do at least a couple of libertarians who wrote me on this very topic), but for a different reason, namely, as a long term strategy to help undermine the public mind -set that people should live off other people. (My words, not Mr. Savage's words).

Thus, although the ExCom opposed Prop 187 for the draconian enforcement provisiom, there are party members who say 187 is a half way measure toward denying taxpayer money to LEGAL immigrants, and by extension, the citizens themselves, ultimately, by the same arguement. (And never mind the enforcement part, which is either never going to happen at all or happen with all the vigor and efficiency os the post office, or the federal agency of your choice).

And thus, it would be to our candidates' advantage to keep our name off the official endorsement list of the organized opposition. Prop 187 is not libertarian; the idea of it (people living off other people), however, sends a message that some libertarians may latch on to, and flaunt in terms of outreach.

Ed's note: At least two LPC Regions, San Francisco and Los Angeles have placed their names on the "No on 187" endorsement list. As for me, I would be "concerned" that the BATF would be chosen as the enforcment agency.

Editor's Comments

Deadlines

THE TEAM effort that brings you LPC News and California Liberty requires a lotof hard work by many individuals. It is both challenging and rewarding.

One of our problems is communicating time constraints and deadlines to those submitting articles and material. I see a deadline as a final date for articles or material that you cannot submit before that date because the event has not yet taken place. And, even then, it helps a lot if I know about the event and your intention to submit a story.

I have to plan the general content of the paper well in advance.
