Browne on Ballot

Libertarian presidential candidate Harry Browne will be on the ballot this November in New York State. On August 20, the Libertarian Party mailed 23,594 signatures to the New York State Board of Elections. Only 15,000 were required to get Browne on the ballot. No one challenged the petitions.

The LPNY volunteer effort collected 4,000 signatures for the Browne campaign. This is 4,000 signatures that National now "owes" to LPNY's 1998 petition drive.

In addition to Browne, four other independent candidates filed petitions to be on the New York ballot in November. They were Ralph Nader of the Green

Yes, There Are Candidates

Six Libertarians are running for public office in New York State this year, though none is running on the Libertarian line. Each chose to run as a candidate of one of the parties that already has ballot access. Four candidates are running for State Senate, one for State Assembly and one for City Court Judge.

Andre Soleil, the chairman of the Brooklyn LP, is running for State Senate in the 18th district. The district covers the area from Redhook to Brownsville in Brooklyn. This is his first run for public office.

Soleil is running as the candidate of the Republican, Independence, Liberal and Freedom Parties. Soleil also ran against the incumbent in the Democratic primary. The incumbent, Velmanette Montgomery has been in office for 12 years.

Soleil is emphasizing taxes and burdensome government as the primary issues of his campaign. "Big government is stymieing minorities in their growth from poverty; it is aiding the poor in staying poor," he said. "The libertarian philosophy is really a formula for the poor."

David Harnett is running for State Senate in district 41. The district includes all of Columbia and most of Ulster counties. He needed only 9 signatures to qualify for a spot on the Freedom Party line and managed to survive a challenge from the Republican incumbent.

Harnett is emphasizing three issues: (1) stop the drug war, (2) separate school and state, and (3) level the economic playing field. "I shamelessly stole the Harry Browne theme 'government doesn't work," Harnett admitted.

Harnett got a favorable frontpage story in the *Register-Star*, one of three newspapers that covers the district.

Robert Flanzer is running for State Senate in the 25th district. The district covers lower Manhattan and Brooklyn. He is running on the Republican, Conservative and Freedom lines.

His theme for the campaign is "Turn off the heat!" The reference is to frogs being boiled alive as the heat is slowly turned up.

In upcoming campaign appearances, Flanzer will be addressing the Long Island Nurses' Society and will appear on the TV show, "Issues USA". The show was formerly known as

David Greene is running for Sate Senate in the 25th district. The district covers part of Brooklyn. Greene is running on the Republican line.

Thomas Hamilton is running for State Assembly in the 60th district. The district covers the middle of Staten Island. He needed only 8 signatures to get on the ballot on the Independence line. He will face candidates from the Democrat, Republican and Right-to-Life Parties.

Hamilton's wife (who is not a member of the LP) is running for Congress as the candidate of the Independence Party. The incumbent she is running against is Susan Molinari.

Dan Duncan is running for Binghamton City Judge on the Liberal line. He almost won the Conservative primary and also finished third in the Democratic primary.

His Republican opponent is a former district attorney; the Democrat is currently a Family Court attorney. Duncan is the only one with judicial experience. He served as a Family Court Judge for several years.

Party, John Hagelin of the Natural Law Party, James Harris of the Socialist Workers' Party and Monica Moorehead of the Workers' World Party. Howard Phillips of the U.S. Taxpayers Party will also be on the ballot in New York in November, however he will be listed as the candidate of the Right-to-Life Party.

Browne will join Bill Clinton, Bob Dole and Ross Perot as the only candidates to make it on the ballot in all 50 states. This is the second presidential election in a row that the LP has been on the ballot in every state. No other third party has achieved complete ballot status two presidential elections in a row.

In all there are 18 candidates running for president nationwide. Most of them are on the ballot in only a few states. Hagelin will be on the ballot in only 43 states, Phillips in 40, Nader in 22, Moorehead in 13 and Harris in 11.

Remember October 11

Many New York Libertarians are discouraged from running for public office by the large number of signatures required to get on the ballot. To run as a Libertarian for Assembly requires 1500 signatures. State Senate requires 3000.

It is much easier to get on the ballot by getting the nomination of one of the minor parties that already has ballot access. In the Independence Party and the Freedom Party, 10 signatures will often be enough to qualify a candidate for the ballot.

But to do this, you must register with the Board of Elections as a member of that political party. To run in next year's election, the deadline for changing your voter registration is October 11, 1996.

So, if you want to change, do it now. Get your friends to change too, so they can sign your petition.
