the Illinois SEVEN

Two years ago, when the last municipal elections were held in Illinois, there were three Libertarian candidates on ballots and one who was a write-in candidate. For the April 2 election in 1985, there are seven Libertarian candidates on ballots. Here are the seven.

GEORGE CLOWES

is running for Trustee of the Mt. Prospect Park District against four other candidates, two of whom are incumbents, for one of three vacancies on the Board. After waging an unsuccessful campaign as a private citizen to block the Park Board's plans to build a wave pool in one of the District's parks, George organized an eleventh hour write-in campaign for a seat on the Board. He brought in almost 16% of the vote in a three-way race against two incumbents.

This time around, with his name on the ballot and time for campaigning, George will be heard by the voters. He will campaign on three planks: setting limits to the scope of what the Park District does, lower taxes, and more openness about what the Board is doing. The District has the biggest exercise program in the state, paid for by all the taxpayers and used by only a few. George promises, if elected, to represent the taxpayers who do not use the parks.

STEVE GIVOT

received almost 60,000 votes as LPI candidate for U.S. Senate. Now he is running in field of seven for three positions on the Village Board of Trustees in Barrington Hills. The population of the Village is 3,700.

RANDY HEIDENFELDER

made a name for herself by spearheading the "water fight" in Palatine Township last year. When the Village of Palatine bought the private water company which had been supplying the residents of unincorporated Palatine Township, it raised the rates for unincorporated Township residents from \$1.57 to \$6.23 per thousand gallons. There were demonstrations, an arrest, and a law suit against the Village. Randy was in the thick of it all.

Now Randy is making a bid for Trustee of Palatine Township. Three of the four incumbent Trustees are Republican precinct captains who were appointed to finish out vacated terms.

They and another Republican are Randy's competition for the four seats.

Her platform has three planks: "Stop the constant increase in taxes caused by government's never-ending appetite for our hard-earned money," a voice for citizens in the local government, and more cost efficiency.

TOM HEIDENFELDER

is seeking one of two six-year terms on the Palatine Library Board. Treasurer of their condominium association, he is known in the community for his involvement in the "water fight" described above and for watch-dogging the Library Board. Tom, another man from his condo, and a Palatine Village resident who is a member of the Friends of the Library filed their petitions early. The League of Women Voters apparently didn't like the idea of even one tax limiter getting elected; within a few hours of the closing of the filing period they filed a petition for a fourth candidate. There is only one candidate for a four-year term, a grade school principal who was appointed in preference to Tom (who also applied for the position) when it was vacated two years ago.

Tom's platform is 1) no tax increase; 2) more reliance on user fees, for example, charging for the use of expensive resource materials and computers, and for borrowing sculpture, paintings, and video tapes and equipment; 3) the creation of a permanent Income Fund, into which donations, user fees, and late fines would go, making it possible to eventually eliminate Library taxes completely---he is working out a timetable for achieving zero Library tax.

MARJI KOHLS

is running for a seat on the Niles Library Board. There are five other candidates competing for two vacancies. One is an incumbent, one a former Board member, and one the wife of the Village Clerk. Marji said, given the job they have, i.e., administering taxpayers' money in the operation of a public library, the present Board actually does a relatively good job.

GERRY WALSH

two years ago was one of the first two Libertarians to be elected to public office in

Illinois. Scott Tillman, Alderman in Marquette Heights was the other. Gerry is now campaigning for President of the Roselle Village Board, commonly referred to as "the Mayor." He says he will have a hard campaign because the Republican incumbent is firmly entrenched and may receive some high-powered support from the Republican Party. In 1983, Gerry coupled his campaign for Trustee with a tax-cut referendum campaign. The referendum was passed against the Mayor's strong opposition. He had previously fought the imposition of a utility tax, which the Board passed with the Mayor's support. Gerry will remind the voters of who stood where on these issues and clarify the most current spending issue, a matter of \$700,000 for a road which the Mayor thinks should be spent.

JIM YOUNG

has been working on his candidacy for Councilman in Normal for a year now. He has attended every Council meeting and researched all the issues. In a town of 36,000 with a student population which has quadrupled in less than a decade (to 21,000), the issue of University-Community relations looms very large. Last year the Council passed a piece of very repressive legislation regulating "mass meetings" aimed specifically at the students. Jim will target that ordinance as the wrong way to resolve the problems residents are experiencing as a result of the student presence and offer rational proposals for improving relations between the townspeople and the students. He will raise the issue of fiscal responsibility and demand that the Council ask and answer some basic questions about their plans for economic development and reconsider whether Normal should continue to maintain a scarcely-used bus system with a budget of a million dollars per year, nine tenths of which comes from the Federal Government. In connection with the latter issues, the expectation of Federal funds drying up will definitely be in Jim's favor for getting his message across.

Jim spoke at a meeting sponsored by all the student organizations on campus along with the four other candidates for the three open seats on the Council, including two incumbents and one who lost the last election by four votes. The students endorsed Jim's candidacy. The League of Women Voters has invited Jim to speak at a candidate's forum.

In view of the closeness of the race between Paul Simon and Charles Percy, it appears that Steve Givot's vote did tip the balance. Although your editor's prediction of the final vote total was a bit more optimistic (perhaps reflecting the wishful thinking of a veteran petitioner), Steve had predicted "between one and two percent." That he achieved the primary goal of his campaign is in no doubt. The Givot for Senate Campaign did get the word out. The voters of Illinois know now in much greater numbers than ever before that there is an alternative, and that it is the Libertarian Party. Steve had more media coverage, and talked to more live audiences than any candidate we've had before. He appeared on half-hour interview programs on ABC, CBS, NBC, and the Mutual network TV stations in Chicago, in addition to the ETV station, which has interviewed our previous candidates.

In the precincts we covered completely with door-to-door distribution of Givot campaign flyers the vote totals for Steve ranged from 3.37% to almost 5%. In partially covered precincts, totals ranged from 2.06% to more than 4% and, in one uncovered (door-to-door) precinct, it was 4%. We were not terribly scientific. For example, many workers distributed the flyer at railroad stations, in shopping centers, parking lots, and car-to-car on the streets around churches on Sunday mornings, where voters in "uncovered" precincts undoubtedly received it. The whole picture of these results is clouded by the fact of Steve's media coverage.

There seems to be a somewhat more clear indication of the effectiveness of door-to-door distribution of the Bergland flyer---at least in one sample in Maine Township. Since Dave

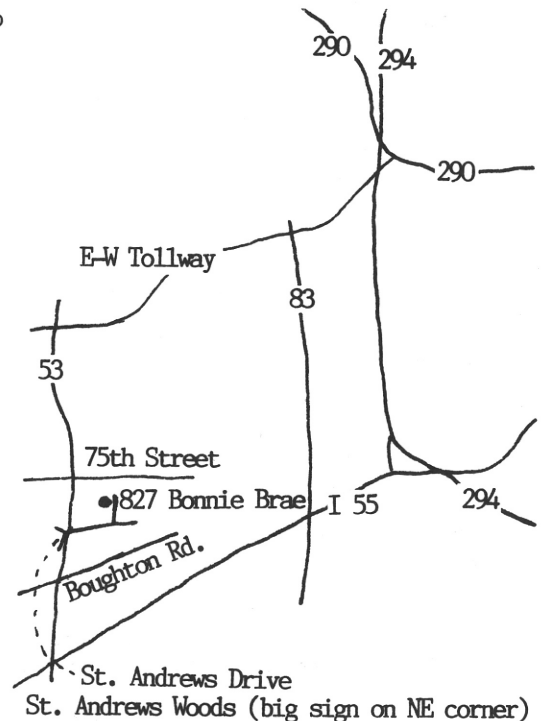

received virtually no media coverage in the area, possibly the figures are more meaningful. In two fully covered precincts, the totals were 1.183% and 1.124%; in two partially covered precincts, .823% and .739%; and in two uncovered precincts, .204% and 0. For the whole Township, it was .222%.

AROUND THE COUNTRY

Alaska once again has a Libertarian in the state legislature in the person of Andre Mareau, and Jean Druke won a seat on the Amphitheater School Board in Tuscon, Arizona. LPI's Helen Heyden sweated out by long dis-

tance a California cliff-hanger, recount by recount. The final tally gave Helen's cousin, Tom Tryon, a seat on the Calaveras County Board of Supervisors.

Some impressive also runs include Toni Nathan with 48% of the vote for Lane County, Oregon, County Commissioner; Jo deForest McIntyre with 25% for Oregon State Representative; and Ed McGuire with 40% in a best 2-out-of-3 race for Vermont State Representative.

A THINK TANK FOR FREEDOM IN ILLINOIS

In April, 1984, Chicago's first think tank devoted to finding free market solutions to local and regional problems was founded. During its first six months it quietly assembled supporters, staff, and research material. During the past three months it mailed five publications and two press releases to every newspaper and major radio and TV station in Illinois. Next month, The Heartland Institute will sponsor a dinner conference on taxicab deregulation featuring Alderman Martin Oberman and FTC Regional Director William MacLeod.

The Heartland Institute could be a boon for the libertarian movement in Illinois. For the first time, Illinois has a full-time organization devoted to personal freedom and minimum government. The Heartland has the people and the resources to command the respect of the mass media and public officials. As a nonpartisan, nonprofit organization, it can work with a wide range of local and national organizations to truly affect the public policy debate in Illinois.

Who are they?

The Heartland Institute emerged from a meeting of the Loop Libertarian League, a group of Chicago businessmen and professionals meeting regularly since 1980. The members of the Heartland's board of directors are Dave Padden, Everett and J. Donald Moffat, Craig Allen, Jim Johnston, Dick Poje, Bob Jackson, Michael McCarthy, and Jim Murphy. Last June they hired Joe Bast, co-editor of *NOMOS* magazine, as executive director; most recently Pat Peterson joined as development director.

The Heartland Institute has assembled a number of prominent scholars and talented researchers into a board of advisors, among them Yale Brozen, Sam Peltzman, and J.W. Henry Watson of the University of Chicago; Charles Breeden of Marquette University; Jeffrey Paul of Bowling Green State University; and local transportation experts George Clowes and Gene Haschak.

In addition to members of the board of advisors, research for the Heartland is being performed by nearly a dozen people, including Scott Tillman, David Jahntz, Joe Maxwell, David Ramsey Steele, and Joseph Schwieterman.
