

## ELIMINATE

### CITY HALL

For years the voters of New York City have been hearing that all the problems of City Hall would be solved if only the right candidates were elected.

After years of increasing taxes, deteriorating public services and rising crime it has become apparent that it does not matter who gets elected. City Hall as it is presently organized can only make things worse.

 THE STRUCTURE AND FUNCTIONS OF CITY HALL MUST BE DECENTRALIZED.

### **TAXES**

The simple fact is that taxes have been increased, not to increase benefits to the tax-payer, but to pay for increases in welfare, increases in the number and salaries of city employees, and increases in the wages and pensions for municipal unions.

City Hall has no reason to continue to waste money for "services" such as sanitation and street repair that would be provided more efficiently by competitive businesses.

The best way to stop the wasteful use of your money on inefficient services and social welfare projects is to stop the money from going into City Hall.

- ELIMINATE THE CITY INCOME TAX.
- CONDUCT A YEARLY REFERENDUM TO DETERMINE THE LEVEL AND ALLOCATION OF OTHER TAXES.

### **TRANSPORTATION**

The municipal transit crisis has been caused by the City and State governments' regulating private mass transit into bankruptcy necessitating City takeover.

Mass transit cannot and certainly will not improve until the City allows the private market to capitalize the building of modern transit systems that are both financially and technologically possible.

Left as it is now, the City and State will continue to give deplorable service at increased prices. Automobiles will continue to clog the streets and pollute the environment with their noise and emissions.

- SELL THE SUBWAYS AND BUS COMPA-NIES TO COMPETITIVE ENTERPRISE.
- ELIMINATE ALL REGULATIONS OF MASS TRANSIT TO CREATE COMPETITION.
- SELL RIGHTS OF WAY ON STREETS AND HIGHWAYS TO BUILD PRIVATE, MODERN MONORAIL SYSTEMS.
- CHARGE AUTOMOBILES THE FULL COST OF STREET MAINTENANCE, PARKING ON PUBLIC PROPERTY AND POLLUTION.

### HOUSING

Thousands of sturdy apartment buildings have been abandoned because City Hall has made it unprofitable to own them.

The quality of housing in New York will not

improve until the present rent control laws are abolished. Owners are discouraged from improving existing buildings or constructing new ones for fear that their investment will be lost.

The poor will continue to be the group most affected by rent control as owners continue to abandon the older unprofitable housing first.

ELIMINATE RENT CONTROL.

### CRIME

The greatest threat to the individual occurs on **public** streets, protected by **public** employees and enforced by **public** courts.

Improvement in individual safety will not occur until City Hall stops trying to enforce unenforceable victimless crime laws concerning drug consumption, censorship, prostitution and gambling. These laws make voluntary transactions illegal and serve only to corrupt the police and direct their efforts away from protecting the individual citizen.

The main reason for violent crime in New York is the prohibition of heroin. Addicts who have heroin do not commit crimes. Addicts without heroin do.

- ELIMINATE OR DO NOT ENFORCE ALL LAWS WHICH HAVE NO VICTIMS.
- GIVE TAX DEDUCTIONS FOR ALL MONEY SPENT ON PRIVATE PROTECTION.
